• Chairperson's Report:


She welcomed the new CB8 Members and invited them to introduce themselves.

April's Community Board 8 Public Hearing/Meeting (recap)

Shubhra Datta - representing Queens Borough President Donovan Richards

This year, the Borough Presidents office had a pool of 916 total applicants who filed to join the Community Boards. Of that total, 361 were appointed. Dr. Stern stated in accordance with the By-laws of Community Board 8, the April meeting is a nominating meeting. The following slate was nominated:

Committee Chair Dr. Stern opened nominations from the floor. Hearing none, nominations were closed. She stated that the elections will be held at May's general meeting.

Guest Speakers:

• Captain Mo Tsang, 107th Precinct Commanding Officer

During the 28-day period, the two major categories that went up were burglaries and grand larceny auto. Grand larceny auto went up about one or two percent. The cars that are being affected are Hondas, Acuras, and Infinitis. Burglaries are up by eighty-five percent. There were nine burglaries in Sector A, nine in Sector B, seven in Sector C, and four in Sector D.


• Flooding 101 - Queens Commissioner Alfonso Lopez, DEP

Commissioner Lopez stated that he can be reached at queensdep@dep.nyc.gov. Here are the main takeaways from the presentation [available by email upon request]:

- The flood season takes place between June and November.
- The three types of flooding are stormwater, coastal flooding, and groundwater.
- The sewers protect us against 98% of rain events and are built to handle 1.5 to 1.75 inches of rain per hour.
- The sewer system can get overwhelmed when the amount of water produced by a rainstorm is greater than the capacity of the pipes.
- To combat flooding the city has the sewers, bluebelts, floodnet sensors, and unified stormwater rule.
- Unified stormwater rule is what new developers have to follow.
- American Water Resources (AWR) is an insurance that covers the service line to the home.

Health Minutes with Dr. Penny Stern

The week of April 21st is National Volunteer Week. Volunteering is a very healthy activity. Major medical institutions, from the Mayo Clinic to Harvard have been publicizing the health benefits of volunteering for years. It is associated with improved mental health, reduced levels of anxiety and depression. The direct physical benefits of volunteering include lowering your risk for heart disease by improving your circulatory system, improving cholesterol levels, and blood glucose (sugar) levels. It helps the brain shift its focus from pain as you are deeply involved in activities that have meaning and purpose for you. Social connectivity helps prevent feelings of isolation and we know that isolation is associated with poorer health outcomes.



If you do not pay your property taxes, water and sewer charges, or other property-related charges, you may be at risk of being included in a lien sale. The next lien sale will be held on May 20, 2025.

When you are included in the lien sale, the City of New York sells your debt to an authorized buyer. This does not mean that your property has been sold, but if you do not resolve your outstanding debt, the lien sale can be a first step toward foreclosure.

> You have several options for avoiding the lien sale. You must take action by May 19, 2025!

OPTION 1: PAY THE CHARGES

You must pay at least the minimum amount shown on the warning notice that you received in the mail. You continue to be obligated to pay the amounts due on your property.

- Property taxes and related charges: www.nyc.gov/citypay
- Water or sewer charges: www.nyc.gov/dep

OPTION 2: ENTER INTO A PAYMENT PLAN

There are three payment plan options for property taxes and charges:

- Standard payment plan: Available to all property owners. No down payment required (unless there
 was a previous default). Pay monthly or quarterly, for a period of 1-10 years. Must also remain
 current with new charges.
- PT AID: Available to 1- to 3-family homes or condominiums that are primary residences. Annual household income must be no greater than \$107,300. Deferral or income-based repayment.
- PT AID Circuit Breaker: Available to owners eligible for PT AID whose property tax bill is more than 10% of their income. Property's assessed value must be \$250,000 or less. Can defer the amount above 10%; minimum annual payment of \$1,500.

Not-for-profit organizations may be eligible for an exemption that will keep their property out of the lien sale. Active duty military personnel may request an exclusion from the lien sale by completing an affidavit. More information is available at www.nyc.gov/liensale.

OPTION 4: SUBMIT A LIEN SALE EASY EXIT PROGRAM APPLICATION

You can be removed from the lien sale if you are approved for the Lien Sale Easy Exit Program application. To be eligible:

- The property must be a one-, two-, or three-family home or condominium unit.
- The property must be your primary residence.
- You cannot own any other New York City properties.
- The combined annual income of all owners and residing spouses must be less than \$107,300.

You can be removed via the Easy Exit Program up to three times in a 36-month period.

OPTION 5: SUBMIT AN EMERGENCY REPAIR CERTIFICATION

If you only owe HPD Emergency Repair charges, you can be removed from the lien sale if you have a one- to three-family home that is your primary residence and you do not own other properties. Visit www.nyc.gov/liensale.
