# September Community Board Public Hearing/Meeting (recap) 183-02 Union Turnpike Fresh Meadows

- The Minutes of November 9, 2022, Board Meeting were unanimously approved by 34 members.
- <u>Chairperson's Report</u> Chairperson Martha Taylor congratulated Board Member Seymour Schwartz who received an award from the Queens Civic Association Congress.

She announced that applications for board membership will be available on-line, at the Borough President's website, beginning January 4, 2023, and closing February 15, 2023.

The Exodus contract is being terminated at the end of the year [2022] for transitional services at the Wyndham Hotel in Fresh Meadows. Housing Works will be the contractor for the next six months. The Board was copied on a letter to Mayor Eric Adams from our elected representatives requesting information about plans for the facility moving forward.

# **Guest Speakers:**

# Honorable James Gennaro, City Councilmember:

Council Member Gennaro spoke about a bill banning criminal background checks for potential renters circulating the City Council. He suspects it will not pass.

The City Council passed a bill to help homeowners with financing backflow prevention devices and it awaits the Mayor's signature. He recommended that homeowners install these devices, to reduce water damage.

The Mayor's office has a stockpile of free COVID at-home tests. If you need these tests, you can contact Council Member Gennaro's office and arrange to get them.

He announced that he is working to bring Shomrim, a program that works with volunteers from the community to form neighborhood watch groups. This is to help reduce street crime. He plans to start this program in Kew Gardens Hills. He added that these volunteers <u>will not</u> be armed.

## Deputy Inspector Kevin Chan, 107th Precinct

Deputy Inspector Chan spoke about a case where a resident tried to sell an expensive bag to a stranger from an online app. When she went to meet the individual she was robbed. He recommended that when using social media for selling or purchasing goods, residents should arrange to meet at the precinct.

# Stevie Feig, NYC Department of Transportation – Carshare Program

Carshare, a new program that provides on-demand, short-term access to a shared fleet of vehicles is being unveiled. Vehicle renters will access vehicles typically through a membership, with an hourly or annual fee. This program is designed to reduce greenhouse emissions. Three locations have been proposed for Community Board 8.

# Committee Report - Executive Committee

- The members discussed support of Council Member James Gennaro's letter to Governor Kathy Hochul requesting the addition of a "dangerousness standard" when it comes to bail reform. This would allow judges the authority to remand the most violent repeat offenders until trial.
- The Board discussed sending a letter to the Board of Standards and Appeals requesting that they halt all consideration of the variance for 80-74 188th Street in Jamaica Estates that was heard by the Board in October. This is pending the final disposition of a criminal case being heard at the United States District Court of the Eastern District of New York. Some of the owners are named in the lawsuit.

Before their visit, applicants must complete a CUNY application and pay an online application fee at: <u>www.cuny.edu/apply</u>. All official transcripts must be sent to QC by mail or via email to transcripts@qc.cuny.edu. Transcripts submitted in person must be in sealed envelopes. Applicants from non-CUNY colleges must bring official transcripts from all institutions they have attended. Veterans and military service members with military credits may submit their transcript to Joint Service Transcript at https://jst.doded.mil/jst/. Applicants should also bring their COVID-19 vaccination card, state ID, driver's license or passport to their appointment. CUNY students should have a Cleared4 pass ready to present at the main gate.

Queens College has a rich tradition of service in the military. It was estimated that 70 percent of the pioneer class of 1941 served our armed forces during World War II. A memorial to them and their service sits at the campus Quad as a constant reminder of their sacrifice. Our students and alumni have continued to serve proudly in the military throughout our 85-year history. # **HOMEOWNERS**

Apply for an exemption and lower your property tax bill.

- STAR: homeowners with an annual income of \$250,000 or less.
- E-Star: seniors age 65 and over with annual incomes of \$93,200 or less.
- SCHE/DHE: seniors age 65 and over, disabled homeowners with annual incomes of \$58,399 or less.
- Veterans: who served in the U.S. military during designated periods of conflict, their unmarried surviving spouse, and Gold Star parents.
- Clergy: for active and retired members of the clergy and their unmarried surviving spouse.
   Must be NYS resident.

# To apply, please bring:

- Picture ID
- 2021/2022 tax returns or income documents for all owners
- DD214 or discharge papers (for veterans)
- Trust documents (if applicable)
- Clergy verification letter on official letterhead (clergy)

# **TENANTS**

Seniors and people with disabilities:

apply for **SCRIE** or **DRIE** and keep your rent from increasing if you:

- Are at least 62 years old or 18 years old with a qualifying disability.
- Have a household income of \$50,000 or less.
- Live in a rent-regulated apartment.
- Spend more than 1/3 of your income on rent.

DSNY will collect clean Christmas trees (and wreaths!) from Friday, January 6, 2023 through Saturday, January 14, 2023 — weather permitting.

Remember, Christmas trees and wreaths are collected separately from your trash and recycling. They are scouted at the curb to make efficient collection routes, so yours may not be picked up immediately.

## Before your Christmas trees and wreaths can be collected, you MUST:

- Remove ALL lights, ornaments, tinsel, and stands. Remove stands from trees and metal frames and wires from wreaths.
- Make sure they are not wrapped in ANY plastic or placed inside a plastic bag.
- Leave them at the curb between the designated dates (January 6 14).

Trees and wreaths are chipped, mixed with leaves, and recycled into rich compost for NYC's parks, institutions, and community gardens.

Bring your tree to a chipping site on Chipping Weekend to take home a tree-mento! We'll chip your tree and give you your very own bag of mulch to use in your backyard or to make a winter bed for a street tree.

# Snow and Ice Removal

Every owner, lessee, tenant, occupant, or other person having charge of any lot or building must clean snow and/ or ice from the sidewalk after the snow has stopped falling. Snow may NOT be thrown into the street.

# If the snow stops falling between:

- 7:00 a.m. and 4:49 p.m., it must be cleared within four hours;
- 5:00 p.m. and 8:59 p.m., it must be cleared within fourteen hours.

Example: If the snow stops falling at 7:00 p.m., the owner, lessee, tenant, occupant, or other person in charge of any lot or building has until 9:00 a.m. the following morning to clear the sidewalk.

• 9:00 p.m. and 6:59 a.m. It must be cleared by 11:00 a.m.

If the snow or ice becomes frozen so hard that it cannot be removed, the sidewalk may be strewn with ashes, sand, sawdust, or similar suitable material within the same time limits. The sidewalk must be thoroughly cleaned as soon as weather permits.

**\$100 - \$150** for 1st Offense **\$150 - \$350** for 2nd Offense
