3. PUBLIC FORUM

Sam Esposito, Ozone Park Resident, stated the following:

- The number of homeless population has increased in Ozone Park over the last six months.
- Thanked the 102nd Pct. for their quick action in catching the individual responsible for assaulting a woman in the laundromat.
- Wants the board to be involved in all events organized by the Ozone Park Residents Block Association.
- Hopes that the Department of Homeless Services will confirm the opening of a Homeless Shelter for 113 mentally ill men by October 22, 2018.
- Encouraged all Board Members to rally with the Bengali Community on Friday, October 12, 2018 in front of proposed Homeless Shelter on 101st Ave & 85th Street.

<u>Joseph Carumma, President, Our Neighbors of Ozone Park Civic Association</u>, stated that he is working together with the newly formed Ozone Park Residents Block Association in resolving issues to make Ozone Park a better community. He invited all to attend their meeting on Thursday, November 1st, 2018 at 7:30 p.m.

1st Vice Chair Rampershad recognized legislative representatives:

Kate Mooney, rep. Council Member Adrienne Adams, reported the following:

- The Participatory Budgeting process has been a great success, the office received 520 requests this
 afternoon.
- Constituents who want to sign up for weekly emails can do so by visiting the councilmember's website.
- Free early detection of breast cancer event will take place at Queens Health Center, 97-04 Sutphin Blvd. on Wednesday, October 10, 2018.
- Council member has allocated \$210,000 for neighborhood cleanup. Her district received high ratings for cleanliness over two months' time.
- Her next project is to remove all abandoned/derelict and illegally parked vehicles from the streets.
- Free legal help is available at the Lefferts Branch Library every Wednesday and Thursday 11 a.m. to 3 p.m.
- The Parent Advisory High School Fair with the Borough President will take place tomorrow at Queens Borough Hall.

Michael Cohen, rep. Council Member Karen Koslowitz, reported the following:

- There were approximately 200 requests submitted for Participatory Budgeting. They will be brought before the various city agencies by January 1, 2019 and actual selection will take place in April of 2019.
- LIRR President Eng called the Council Member stating that the reconstruction of the LIRR Bridge over Lefferts Blvd. is anticipated to be completed by April of 2019.
- Everyone is aware of the Mayor's intention of closing Ryker's and relocating those inmates at Riker's to
 four locations in four boroughs. The area behind Borough Hall is the selected site in Queens. The monthly
 scoping process is going to end. It is a ULURP matter which will come before this board.

5. Monthly Update Report 102 Pct.

Captain Cortney Nilan reported on the following:

- The major crime stats are currently at its historic lows: 25% for the past month and 14% year to date.
- There was a burglary pattern of one individual going through unlocked kitchen windows. The perpetrator
 was arrested and is still in jail because he was found to be committing the same crimes in 106th and 75th
 Precincts.
- A homicide occurred last Saturday where a club promoter was shot and killed in front of the Tavern Lounge, 97-07 Jamaica Ave. The Precinct is working with the SLA in trying to shut this establishment down.
- A pedestrian, who was walking against the light, was killed at the very controversial intersection of Woodhaven Blvd & Jamaica Ave. The driver, who was not intoxicated and did not flee the scene, was not arrested. 102nd Pct. is working with DOT to make that intersection safer.
- At the Vision Zero initiative, the most problematic locations were picked for enforcement and educational purposes.
- The Neighborhood Coordination Officers (NCOs) from all four sectors are present tonight. They've been given more time and opportunity to collaborate with residents in identifying and solving local crime concerns and quality of life conditions.
- New Executive Officer at 102nd Pct. Capt. Cassacelli introduced himself stating that he will be paying close attention to traffic issues and working to find ways to resolve them.

Question and answer period followed.

6. Chairperson's Remarks & Exec. Report - J. Richard Smith

1st Vice Chair Rampershad thanked all for their services stating the following:

"I would like to take a moment and thank every community board member, elected official, their staff, all the civics, the 102nd Pct. and all those residents who have come out to CB9 meetings.

It has truly been an honor and privilege to serve with you all over these past 13, nearly 14 years.

With that said, I just would like to make everyone on the board aware that this may be my last meeting. I was recently nominated by Queens Borough President Melinda Katz to become a city Planning Commissioner, while I still have a hearing date set up next week with the City Council Committee on Rules, Privileges and Elections, in the event that they vote and accept my nomination I would then have to resign from

board due to the City Charter stating that I cannot sit on two City agencies at the same time. I will update everyone after the hearing.

I also wanted to tell everyone not to be afraid to voice your opinions; it matters! There is a reason why we all wanted to join the community board. We all want to contribute to the well-being of our community. There are not many forums in which one can express their thoughts and concerns about matters that affect the community so please look at every meeting as an opportunity.

Although a community board is mostly advisory, it doesn't mean that our elected officials and city agencies don't hear us. Thank you."

1st Chair Rampershad announced that the selected candidate for CB9 District Manager position will be interviewed on Wednesday, October 24th, 2018 from 7 to 10 p.m. at Queens Borough Hall, Room 200. The final vote will be taken at the closed section of November 13th, 2018 general board meeting.

10. Land Use Committee Report - Sylvia Hack & Sherman Kane, Co-Chairs, Sylvia Hack stated the following:

Mayor de Blasio has proposed closing the Rikers Island jail and building four huge jails, one in each borough except Staten Island. The proposed Queens location is Kew Gardens in Community Board 9. This jail would be 1.9M square feet for 1,510 inmates and parking for over 1,000 cars. 82nd avenue would be remapped between 126th St. and 134th to be built on. This is being pushed by the Mayor's office at extraordinarily speed. The community first learned of this project on August 15 and weeks later saw the CEQR report that was followed by a public scoping meeting on September 26 to which replies were mandated by October 15 - later changed to the 29th. A few days earlier, Mayoral staff stated that they expected certification by the beginning of the year, at which point the ULURP process begins. This is one of the biggest projects this or perhaps any board has ever had, and the city is doing one simultaneous ULURP for all four boroughs. Dist. Atty. Richard Brown made an eloquent statement to the Lippman Commission pointing out that Riker's could be re-built (it's on over 400 acres of land) and the choices of spreading problems at Riker's to four local communities is a really bad idea.

11. Parks, Environment & Sanitation Committee Report – Regina Santoro, Chair, stated the following:

- Attended Budget Hearing at the Overlook where the Parks Commissioner announced her retirement.
- Parks Department's request of a crew cab dump truck with plow and salt spreader for the amount of \$60,869 is moved to CB9 Capital Budget Request for FY2020.
- Any tree related requests can be entered through the 311 App.
- The Kew Gardens Playground will be handicap accessible and will have diaper changing facilities.
- **12.** Economic Development Committee Report Matthew Singh, Chair, stated that he had an opportunity to represent the board at the resource fair hosted by City Comptroller Scott Stringer on September 29. Mr. Singh is waiting for an official report to come out so he can share it with the board.

13. Education & Youth Services Committee Report – Seth Welins, Chair, stated the following:

- It is still not known when the Richmond Hill Library closure and renovations will begin. We are trying to arrange a meeting with officials to discuss this and related matters.
- Richmond Hill HS asked that we support their request for air conditioning in the auditorium and cafeteria.
 We will add this request to our next capital budget request form.

14. Old Business

John Carter gave a brief report on the Board's budget status and explained how Good and Welfare fund money is being spent.

15. New Business

Rabbi Pollack stated that:

- Congress member Grace Meng has done many appropriations to help VA get federal funding.
 This month's VA office hours are from 10 a.m. to 4:30 p.m. on Wednesday, October 24th, 2018 at Congress Member Meng's office, 40-13 159th St. Prior appointment is required for any veterans who need assistance.

- Congress member Meng is also trying to get funding for Opioid Drug Overdose Prevention Program.
- The H.R.423 Anti-Spoofing Bill was signed into law.
- Glendale will have its own zip code.
- He asked all to be aware of sending checks by mail as they can be stolen from the mailbox.

Sherman Kane reminded all that the next Land Use & Housing Committee meeting will take place on Tuesday, October 23, 2018 at 8 p.m. at the board office. Guest speaker, James Quinn, Queens Assistant District Attorney, will be talking regarding Kew Gardens Jail proposal.

Richard David announced that he was elected a District Leader, therefore he is resigning from the board. He looks forward to remain engaged and involved.

J. Richard Smith thanked Raj Rampershad for chairing this meeting and wished him luck in his future endeavors.
