6. Monthly Update - NYPD 102<sup>nd</sup> Pct. Report - not present to give a report.

- 7. Health & Social Services Committee Report Marian C. Molina, Chair, reported on the following:
  - ➤ The Breaking Ground site at 100-32 Atlantic Ave will be completed and fully operational by December of 2020. The tentative bed count is 75.
  - Renovation of the Homeless Shelter at 85-15 101<sup>st</sup> Ave has been completed and expected to be fully operational by the end of February. A copy of the detailed contract between the Department of Homeless Services and Lantern Community Services, Inc. was emailed to the full board for review.
  - Committee Chair Molina presented Zakera Ahmed, Partnership Specialist for 2020 Census Employment Opportunities who stated the following:
    - The Decennial Census is the once-a-decade population and housing count and is mandated by the United States Constitution.
    - 2020 Census is around the corner. The community is recommended to apply so they can help in obtaining an accurate count. Self-response forms will be available in twelve languages.
    - For the first time, the data will be collected online. In March of this year census forms will be mailed out to everybody.
    - As written in Title 13 of the U.S. Code, private information is never shared with any other agencies. It is against the law to disclose or publish any private information that identifies any individual or business.
    - \$675B is allocated by the Federal Government for New York State and it is based on the
      Census count. This money will be spent on schools, Medicate, Medicare, SNAP and WIC
      programs, affordable housing, etc. House Representatives are assigned according to census
      count. Everyone is encouraged to participate so that New York City will receive its proper
      funding and representation.

## APPRECIATION for FALLEN, WOUNDED AND ACTIVE LAW ENFORCEMENT OFFICERS

Whereas, law enforcement officers have played an important role in safeguarding the rights and in protecting the lives and property of our citizens;

Whereas, a select few individuals answered the call by our society to protect and serve their fellow citizens as law enforcement officers, despite inherent dangers in performance of their duties, to ensure a lawful and orderly environment for all, serve with valor, dignity and integrity;

Whereas, each year, a number of law enforcement officers lose their lives, become disabled in the performance of duty while keeping their respective communities safe; and through their courageous deeds epitomize selfless acts of bravery;

Whereas, this distinctive heroism and selflessness of our officers' dedication and services make our precious daily lives and safe communities possible with humility and grace, deserve our thanks and endless gratitude;

Whereas, our societies are forever indebted for the gratitude of these brave men and women who donned the law enforcement officers' uniform, discharge their duties with pride and honor;

Whereas, New York State lost 11 law enforcement officers in the line of duty in 2018, 4 of whom were members of the New York City Police Department, which recorded, in 2018, the safest year in New York City PD recorded history:

Whereas, this ultimate sacrifice should not go unrecognized nor unremembered, for in giving their lives in the line of duty these gallant officers are perpetuating the quintessential just and fair societies we strive to preserve;

Whereas, it is fitting that we express our gratitude for the dedicated service and courageous deeds of law enforcement officers and for the contributions they make in our everyday life and the well-being of all our peoples; and

NOW, THEREFORE resolved, on motion of Community Board 9 and fully endorsed by the full board, expressing profound appreciation and gratitude for law enforcement officers' faithful and loyal devotion to their duties, have rendered a dedicated service to our communities and, in discharging such have established for themselves an enduring reputation for preserving freedom and liberty of all citizens;

Be It Further resolved, our thoughts and prayers are with wounded law enforcement officers in the line of duty, whose honor and devotion are forever upheld as beacons of enduring courageous and heroic endeavors.

Sylvia Hack read Committee's Resolution re: BSA Application # 271-09-BZ Planet Fitness, 132-40 Metropolitan Ave:

"Queens Community Board 9 approves the 10-year extension of the previously granted special permit Application filed at the Board of Standards and Appeals that permits the operation of the physical culture establishment, Planet Fitness, at an existing building at the site within R6/C2-3 zoning district. This 10 year special permit would run from the expiration date of January 17, 2019."

Sylvia Hack reported on the steam rolling over the four boroughs to build four megalopolis jails. Without criminal justice/ bail and open file reform issues there is no way to know how many jails are needed and where they would be located.

Closing Rikers Island is a social movement but a movement that can destroy four middle class residential communities.

- 11. Parks, Recreation & Environment Committee Report Regina Santoro, Chair, stated that the committee discussed the replacement of the metal traffic guard with the wooden plank fencing along Freedom Drive in Forest Park and would like to add this to the Expense Budget.
- 12. Economic Development Committee Report Matthew Singh, Chair, not present to give a report.
- 13. Education & Youth Services Committee Report Seth Welins, Chair, stated the following:

According to Queens Library officials:

- RH Library is now fully funded at \$10.2 million for the proposed renovation. No changes will be made to the
  original design plan that was shown to the board.
- Work should commence in approximately two years.
- There is currently no timeline for the closure period.
- The double trailer will be approximately 25'by 60' and will include some terminals and desks for patrons.
- Woodhaven Library will also be closed for renovations around the same time as the Richmond Hill library. It received \$250 K from Erich Ulrich and \$500K from the Borough President for a swing space. It will probably be located in a store front on Jamaica Avenue, but no site has yet been found.

The Education Committee will ask for additional opening time for both libraries, including Sunday hours.

#### 14. Old Business

District Manager McClelland asked the board members to review CB9 Budget Requests that are included in their packages and select three priorities for the Budget Testimonies.

## 15. New Business

Stephen Esposito thanked the board members for supporting the GWDC 2019 Wonderful Woodhaven Street Fair.

Kevin O'Leary thanked Council Member Karen Koslowitz for sponsoring a Bill that requires all food carts to be inspected and graded by the Health Department.

Kamal Bhuiyan encouraged all to vote for Public Advocate on Tuesday, February 26, 2019.
