2. REPORTS FROM LEGISLATIVE OFFICIALS

Assembly Member Jenifer Rajkumar

- Introduced her first bill at the State Assembly that will make 'antibody cocktail' widely available.
- AM Rajkumar is a co-sponsor of the bill that will allow vaccination by getting 4-hours paid time off from work in any job, private or public.
- A bill was passed by the State Assembly that gives small businesses an eviction and foreclosure moratorium until May 1st.
- Introduced a bill to make a Diwali a school holiday.
- The Assembly Member's office staff will answer all questions regarding vaccination sites, etc.
- 13 laptops will be given away to the victims of recent house fire in Richmond Hill. They are donated by Tzar Realty with the help of Sherry Algredo.

Council Member Holden's bill intro 2044 will be passing in the City Council this week. It will extend the moratorium on business awnings and signs for another two years from the date that the bill becomes law. The proposed legislation would also extend the temporary DOB assistance program established by Local Law 28 of 2019 for two years and would increase the 75% waiver of certain permit fees related to accessory sign installation to a 100% waiver of such fees.

4. OPENING OF MEETING & READING OF MINUTES

Chair Wilson asked if there were any corrections/additions to January 12th, 2021 meeting minutes and motions.

Addition submitted by Seth Welins:

Page 6, under New Business, Mr. Seth Welins asked all to take a moment of silence in memory of Brian Sicknick, the police officer who was murdered during the January 6th insurrection at the U.S. Capitol. "Our moment of silence also reflects our deep concern for the injured police officers, the traumatized elected officials, and Capitol employees who experienced this terrible event."

5. MONTHLY UPDATE NYPD 102nd PCT REPORT

Capt. Fidacaro stated that the 102nd Pct. is currently doing better in crime this year compared to last year but still are experiencing a lot of issues related to grand larceny auto. He stressed the importance of not leaving vehicles running and unlocked. There are also numerous car break-ins in the north east area of the Command, especially in Kew Gardens.

The 102nd Pct. is still maintaining its presence at the Umbrella hotel to maintain order.

Question and answer period followed.

6. CHAIRPERSON'S REMARKS & EXEC. REPORT - Kenichi Wilson

- Woodhaven BID and the WRBA are working with DOT on postponing parking meters rate increase that was proposed before COVID.
- There were no snow removal complaints received by the board office despite heavy snow.
- Chair Wilson is working with DM McClelland and HPD on resolving the heat and hot water complaints from the remaining residents of the Umbrella Hotel.
- Have been advocating for restaurant workers to get priority on their vaccination.

7. DISTRICT MANAGER'S REPORT – James S. McClelland

- Wished Happy Birthday to Faiuze Ali, Nick Comaianni, Rabbi Daniel Pollack and Sursattie Singh. Also, wished Happy Wedding Anniversary to Irina and her husband.
- Community Board applications are due Friday February 19th. Emails were sent to Board members who are up for reappointment. If you have a question about whether you need to re-apply, please contact the office.
- Testified at the Queens Budget Hearings last Monday. Emphasized the need for the Elected Officials to fight for restoring funding for critical services.
- The office receives numerous complaints regarding illegal dumping, litter basket pickups, graffiti, road resurfacing, sewer repair and many other quality of life issues.
- Also emphasized the need for the Richmond Hill Library to move forward since it is fully funded.
- Over the next few weeks will meet with each of our council members to discuss our Capital and Expense Budget priorities.
- Despite heavy snow fall we received very few snow removal complaints; however, a few problematic locations have

been identified and we are working with agencies to address these areas.

• The next District Service Cabinet Meeting will be on Thursday, February 25th.

8. EDUCATION & YOUTH SERVICES COMMITTEE REPORT – Sherry Algredo, Chair

"Due to time constraint at general board meeting, we are having our speakers at our monthly education meetings and all board members are welcome to attend.

On January 25th we met with Mr. Denis Rosenberg and other staff members at Birch Family Services which has opened a new location at 92nd Street and 101st Ave. They have acquired a facility that was formerly owned and run by Catholic Charities and have done a complete renovation of the facility. This two-level group home will house young adults that are severe on the autism spectrum. The house manager and the staff will always be present in each facility. These young adults come from the OPWDD - Office for People with Developmental Disabilities.

The DOE has a Parent University Training with 278 courses in 8 different languages and includes a yoga class for parents.

Middle school test results will be released in early May, and High School in early June.

Spoke with Mr. Norment, the Deputy Superintendent of District 27 about the ways masks are being distributed to teachers. They will address this when meeting with principals.

The next Education and Youth Services committee meeting will be held on Monday February 22nd at 6:30pm. Jonathan Hunter with the Community House program at JHS210 will be presenting on youth programs that are available online."

Seth Welins reported on Gifted and Talented Program proposed changes based on a DOE meeting on February 8:

- No changes are planned for Gifted and Talented programs next year. However, teachers will now evaluate students
 and recommend students deemed eligible for the G and T program. The previous formal qualifying test for Pre-K 4year old kids will not be used anymore. A lottery will decide which of these eligible students will be offered a place in
 the program.
- The DOE believes that there are many talented children in every school and each school should have challenging
 programs for these students. The goal is to make these programs more inclusive and more available to students in
 every school.
- Next year, all middle schools will be unscreened since they will not have students' current test scores for evaluation purposes. High schools will be able to consider 2019 test scores and other academic grades from early 2020 as criteria for acceptance. In the future, the DOE aims to have all high schools un-zoned.

9. HEALTH & SOCIAL SERVICES COMMITTEE REPORT - Andrea Crawford, Chair

Ms. Crawford explained the difference between COVID-19 vaccines and stressed the importance of getting vaccinated and continued testing.

10. LAND USE & HOUSING COMMITTEE REPORT - Sylvia Hack & Sherman Kane, Co-Chairs

Mrs. Hack urged every board member to attend a very important special meeting (date TBD) via Zoom regarding Council Speaker's new zoning legislation Intro 2187 that will reduce/exclude participation by community board and civic associations in critical land-use issues regarding zoning and density leading to the demise of one family homes in Queens.

Land Use & Housing Committee co-chairs asked Mr. Paul Graziano, a zoning specialist, to lead the discussion as he has with several other community boards.

The committee will be preparing a resolution to be voted on by the Executive Committee and sent to the City Council and the elected officials.
