REGULAR MEETING AGENDA

1. <u>Opening of Meeting & Reading of Minutes</u>

Chair Gonzalez opened the meeting and thanked Kew Gardens Community Center for hosting. Marie Turley asked for additions/corrections to the minutes.

Corrections submitted by Jim Coccovillo:

Page 5 - The evaluation tool was designed to be used by the CB9 Chair and at least one other elected board official, not the Ad-hoc committee.

2. <u>Chairperson's Remarks & Exec Report- Ralph Gonzalez</u>

Chair Gonzalez reminded all that the election of officers will take place in March. There is a list of CB9 Chairs and Vice Chairs in the board members' envelopes. He stated that board members might consider running for CB9 Chair.

3. <u>Acting District Manager's Report- Lisa Gomes</u>

"I attended the WRBA town Hall meeting on Jan. 17, 2015. Mr. Andrew Newman, Communications Manager NYC Parks Dept. Forestry Division, spoke about The Million Trees NYC Initiative and stated the program has planted 938,000 trees throughout NYC. Trees can be planted via nyc.gov/parks, Constituent Requests or Environmental Need.

Fiorella Trimble, Senior Forester stated the Parks Dept. works with the Community and Individuals do not have the right to refuse to have trees planted in front of their homes. They indicated that some medians along road ways are too narrow for planting as evidenced by the high mortality rate. Medians need to be 8ft. wide for trees to survive.

Greg Mitchel representative from Eric Ulrich's office announced that the Councilman was holding a Participatory Budget session at his Office on 1/22/15. I attended this meeting and some of the budget items discussed were:

- Equity Park Improvement/Renovation- 88th Ave at 90th St. (behind PS60).
- Library Improvements- Richmond Hill Branch (118-14 Hillside Ave) & Ozone Park Branch (92-24 Rockaway Blvd).
- 911 Memorial in Forest Park (by the Bandshell).
- Neighborhood Signs, i.e. "Welcome to Woodhaven".
- Funding for Local Schools PS 97, PS 66, PS90, PS 306, \$75,000 per school for a total of \$300,000.

Assemblyman Mike Miller discussed a bill he introduced to create a Civilian Summons Review Board to hear cases involving summonses issued by the Dept. of Sanitation. Woodhaven residents have been getting an unusual amount of summonses and have asked for the Assemblyman's help.

Of course one of the major issues was that of The Woodhaven Ambulance Corp. Shutting Down!! Both Martin Colbert WRBA President & Ed Wendell, former president & member of WRBA stated they are starting the process. This is due to the delays in construction work on the building. The newest deadline for the roof completion is 2/22/15.

I have been in contact with Anthony Illiano, of the DOB to arrange a meeting with Martin Colbert & Ed Wendell to discuss their frustration with the legal process and its impact on the buildings & Ambulances future and its importance to Woodhaven and its residents.

I attended the 102 PCT Council Meeting 1/20/15- Special Guest Speaker was: Chief Joanne Jaffie. Chief Jaffie was promoted to the City's Community Affairs Bureau 10 months ago. Her experience in working closely with Public Housing residents provided valuable experience in developing trust & bonds with the community at large. She oversees Community Outreach teams throughout the city, and the bureau oversees Community Affairs Units, i.e. Crime Prevention Division and Juvenile Justice Division. Deputy Inspector Saunter reported on following:

9% decrease in Major Crimes for 2014 with significant decreases in Robberies and Felony Assaults.

Six Rookie Police Officers were assigned to the Pct. They will complete a six month on the job training at the Precinct.

Two Officers were honored with "The Cop of the Month Award" for their efforts in thwarting a robbery in progress last month. They were Eric Contreras & Annmarie Tyrie.

The Deputy Inspector and our own Latchman Budhai, 102 PCT Council President, presented the Rookie Officers with Plagues.

A moment of Silence was observed to remember & honor Detectives: Rafael Ramos & Wenjian Liu.

DOT created 40 to 50 angled parking spots on 134 St. btwn Union Tpke & Hoover Ave. Extended metered parking south bound on Queens Blvd, south of 83rd Ave and converted to 6 hour metered parking. Estimates: this will create an additional 20 to 25 spots.

Last but not least, I had the great privilege of attending Borough President Katz Borough Cabinet meeting with the Queens Chamber of Commerce."

2nd Vice Chair Smith recognized NYPD representatives.

4. <u>Monthly Update Report 102 Pct.</u>

P.O. Severino & P.O. Martinez stated the following:

Elisa Velasquez, Rep. Borough President Katz, announced that the new Deputy Borough President is Melva Miller. She stated that the BP's Budget Hearings will take place on Monday, Feb. 23, 2015. Hayden Horsham, Rep. Senator Sanders, Jr. introduced himself and stated that Senator Sanders is working closely with Council Member Wills regarding a juvenile facility in South Ozone Park. Mr. Horsham can be reached at (718) 523-3069.

David Renz, Rep. Assembly Member Miller, nothing to report. The office phone number is (718) 805-0950.

Scott Wolf, Rep. Assembly Member Simanowitz, stated that the Assemblyman voted on a bill that will establish a State Office of the Utility Consumer Advocate. This office will create an independent body that would represent consumers of this state when it comes to utility issues, in addition to the Public Service Commission that represents both consumers and utility companies. Forty states currently have a Utility Consumer Advocate Office. We hope that New York State will be the Forty First.

Anthony Lemma, Rep. Assembly Member Weprin, stated that the Assemblyman is in Albany trying to make sure that our schools get proper funding.

Redmond Haskins, Rep. Council Member Ulrich, spoke about Participatory Budget sessions stating that some of the topics that were submitted include: 911 Memorial in Forest Park, Emergency Call Box Post in Forest Park, Equity Park improvements and renovations, upgrade and renovation of Richmond Hill and Ozone Park branch libraries and auditorium upgrades in P.S. 64. The next Participatory Budget session will take place in March. Mr. Haskins distributed the Winter 2015 Newsletter.

Bruce Eiber, Rep. Council Member Karen Koslowitz, stated that the office will be working late hours Tuesdays and Wednesdays, 5-8pm.

Carl Moore, Rep. Senator Joseph P. Addabbo, stated that Senator Addabbo and Assembly Member Miller's Recycling event will take place April 26, 2015 at the Forest Park from 10 am to 2 pm.

Jahi Rose, Rep. Council Member Rubin Wills, reported on Free Family Legal Law Clinic taking place at the Councilmember's office every Wednesday from 10 am to 4 pm. The constituents will be able to get free one-on-one legal consultations on:

- Child Support
- Child Custody/Visitations
- Orders of Protection in Family & Criminal Court
- Child Protective Services.

This program is sponsored by the Urban Justice Center and is a part of the Domestic Violence Project. The consultations are by appointment only and can be scheduled by calling (718) 206-2068.

Mr. Rose stated that the office provides free tax preparation.

Dev Awasthi, Rep. Comptroller Stringer, distributed 'A Year in Review' newsletter and stated that the Comptroller's office is accepting suggestions for this year's audits.

Alexander Bennett, Rep. Congress Member Grace Meng, reported on the following:

- A press conference was held to warn the public about the scams related to President's Obama Executive Act on Immigration.
- The Congresswoman wrote to Chancellor Farina to reopen a Gifted and Talented Program in middle schools, in the District 25 & 28.
- Will hold an Info Session on Executive Act on Immigration on February 23, 2015, 5 p.m. at the Elmhurst Hospital
- Distributed 2015 US House Representative calendars, a gift from Congress Member Meng.
