Paul Rudolph, Woodhaven Business Owner, urged the board to vote against the Woodhaven/Crossbay Blvd. SBS proposal.

Carina Nieves, Richmond Hill Resident, stated that Q52 and Q53 lines should get articulated buses to alleviate lack of buses. She also stated that every single bus route should be redesigned every ten years.

"On Thursday Jan 7, 2016 J. Richard Smith and I attended a meeting at the Dog Run on 85th St and Park Lane South, Veteran's Memorial and The Skate Board Park in Forest Park to discuss Participatory Budget money from Council Member Eric Ulrich. J.R. Smith will give you an update.

Attended QBP Melinda Katz's Borough Cabinet Meeting-

** DEP Presentation Re: Municipal Separate Storm Sewer System (MS4) ** MS4 are a conveyance or system of conveyances (transports, passages, etc.) They are designed or used to collect or convey storm water (including storm drains, pipes, ditches, etc.) At this time they are not implanting this in CB9Q, but the Jamaica Bay is part of this project and should be done by June 2016.

NYCNYC will develop a Storm Water Management Program to reduce the contamination of storm water runoff while continuing to prohibit and increase awareness of illicit discharges.

This is a comprehensive plan to describe how the City will address controlling storm water discharges through Best Management Practices and other controls.

The MS4 Permit is citywide and DEP will be coordinating with 14 City Agencies, i.e. NYC Dept. City Planning, DOT, NYC Buildings, Sanitation, Police, Fire and Corrections, Parks, NYC DDC, NYC Citywide Administrative Services, NYC Dept. of Education, etc. You can see the full presentation on the DEP website: <u>http://nyc.gov/dep/ms4</u>.
