# 11. Education & Youth Services Committee Report – Seth Welins, Chair

- The School Construction Authority rejected P.S. 90's request for air-conditioned classrooms and an elevator. CB9 supported this request.
- According to a recent IBO report, N.Y.C. Public schools' ELA and Math test scores no longer lag
  the rest of NY State, for the first time since 2006. The city' schools ELA scores are on a par
  with the rest of the state while the math scores are 3 percentage points below the State's
  average scores. When controlling for a number of student characteristics, the city's ELA and
  math test scores are approximately 13% higher than the scores of students in the rest of the
  state.
- P.S. 66, 64, 306 and 54 are overcrowded, according to the 2017 Expense and Capital Priorities report. The Education Committee will reach out to these schools and offer support in their effort to relieve overcrowding.

# 12. Parks, Environment & Sanitation Committee Report – J.R. Smith & Laraine Fletcher, Co-Chairs

J. Richard Smith asked Naidoo Veerapen to give background on the history of the Phagwah Parade. Mr. Veerapen stated that Phagwah, or Holi, is an ancient Hindu Festival that celebrates the triumph of good over evil. It also ushers the arrival of the spring season.

Over the last twenty seven years, the Phagwah Parade has attracted large crowds drawn from the New York Tri State communities, and even beyond. In fact the New York Times described it as "the biggest street festival in Queens".

The Phagwah Parade in NY, which was started by Hindu immigrants from Guyana and the Caribbean, truly reflects the cultural diversity of our country and strongly promotes the concept of unity in the face of adversity. Mr. Veerapen invited all to the 28<sup>th</sup> Annual Phagwah Parade which will take place on Saturday, March 26, 2016 at 10 a.m. The Parade's route is Liberty Avenue and 133rd Street; west on Liberty, north on 125th Street to Smokey Oval Park at 125th Street.
