P.O. Severino stated that the same info can be obtained at 102 Pct. website. He also added that the 102 Pct. is 26% down in crime year to date and has the second lowest crime rate in the city. P.O Severino was happy to announce that in July, 2016 the 102 Pct. is getting twelve more police officers in addition to the fourteen officers that joined 102 Pct. in January, 2016.

#### 6. District Manager's Report – Lisa Gomes

"On Tuesday April 19<sup>th</sup> I attended the QBP Cabinet meeting. A presentation took place by JASA Senior Initiative Project regarding Foreclosure Prevention. Foreclosure scams are targeted towards Homeowners, especially on seniors who are in distress. This can be done via telephone calls, and unsolicited Mailings. JASA has 3 major objectives:

- Protect Seniors who were victims of scams
- Provide financial counseling and help to enable them to manage their household Budget. (Seniors live on fixed incomes in NYC).
- ▶ JASA reaches out to seniors to prevent Scams through their outreach efforts.

- Many organizations try to prevent scams through outreach campaigns at Senior Centers, houses of worship, and community based organizations.
- ▶ Be advised that Housing Counseling Services won't charge upfront fees.
- ▶ Seniors can get Applications for help through The Department of Finance.
- Prosecution of the Companies that scam seniors can be difficult as they don't stay in the neighborhood for very long and change their Company name.

<u>Data2Go.NYC</u> -this is a research tool funded by a grant from the Helmsley Charitable Trust. They connect sectors that are organized by maps and census data, birth rates, statistics, etc.

- ► There are 12 sectors and 360 indicators.
- ► Map shows you what is happening with indicator across the city. Data is available by Community Districts and Census Tracts.
- ▶ 40% of Indicators comes from the Census Bureau
- ► New data will be loaded annually for 4 years."

Ivan Mrakovcic spoke about Neirs Tavern Landmark Support Rally sponsored by Historic Districts Council that took place on Saturday, May 7, 2016. Neirs Tavern, located at 87-48 78 St in Woodhaven, is NYC's oldest continuously operating tavern since 1829.

Ivan Mrakovcic made a motion to support a Landmarking of Neirs Tavern and send a letter to the Landmark Committee. Sherman Kane seconded the motion.

Mr. Wilson stated that this location does not meet the criteria for a speed hump installation. There is an open DOT study with bigger boundaries that will show all necessary improvements.

### SBS update:

- Key street design changes will be implemented
- Key pedestrian and traffic safety treatment will start this fall
- Left turn on Jamaica Ave will be kept intact
- There are three workshops coming up soon: May 17, 2016, 6-8 p.m. at P.S.42, 488 Beach 66<sup>th</sup> St; May 21, 2016, 12-2 p.m. at P.S. 65, 103-22 99<sup>th</sup> St and May 25, 2016, 6-8 p.m. at P.S. 306, 95-16 89<sup>th</sup> Ave.

Alex Blenkinsopp added to SBS update:

- Though DOT plans to restore some of the left turns, they are still planning some key left turn bans. For example, southbound traffic will not be permitted to turn left onto Union Turnpike. Instead, DOT plans to have that traffic do a U-turn at 81st Road.
- DOT still plans to have median bus stops. Interestingly, the median bus stops are planned only for Woodhaven and Ozone Park; the rest of the SBS route will have bus stops on the sidewalks.
- DOT said they need the bus lanes to be in effect 24/7 (as opposed to just rush hour) for the CB9 part of the route because they don't want the SBS buses to pull over into the stops the same way the local buses will - even though the local buses will be using the same bus lanes.

  - 3. Provide Free Zika Protection Kits to Pregnant Women
  - 4. Deploy Rapid Response Teams wherever a case of Zika transmission is confirmed.
  - 5. Issue Emergency Regulations Requiring Local Zika Control Plans.
  - 6. Launch Aggressive Public Awareness Campaign
