Deputy Inspector Urprasad stated the following:

- Crime is down 24.7% year to date on all major categories.
- 102<sup>nd</sup> Pct. is continuing law enforcement of electric motorcycles.
- The operation of towing away commercial vehicles illegally parked in residential area is ongoing.
- There was a shooting at 88<sup>th</sup> St & Atlantic Ave.
- There is more police presence in the parks.

Council Member Elizabeth Crowley addressed the board and spoke regarding the activation of passenger service on the Lower Montauk Branch of the LIRR which runs into CB9 in Richmond Hill. CM Crowley gave a presentation that illustrated some of the aspects of the proposal stating that the City Council has allocated \$500,000 for a study in the city's FY 2017 budget. She stated that it was already brought to the attention of CB2, CB5, & CB6. They passed a resolution supporting a study of the service.

# 6. District Manager's Report - Lisa Gomes

District Manager Gomes reported on the following:

At the Queens Borough President's Borough Cabinet Meeting on May 17, 2016 there was a Presentation on Hurricane Preparedness. They emphasized that individuals should know their evacuation zone. There are 65 evacuation centers throughout the five Boroughs. There are 450 Shelters associated with these evacuation centers.

NYC can feed 70, 000 people for 7 days. There is an email for any requests or inquires, the email is <a href="mailto:intergov@oem.nyc.gov">intergov@oem.nyc.gov</a>. You can also sign up for Notify NYC which is the City of New York's Official source for information about emergency events and important City Services.to get information on weather, storms, etc.

#### Department of Youth & Community Development

Mr. Alexander Betancout stated that they have had the greatest increase in funding of after school programs. The Department has funded 2500 Contracts totaling 600 million dollars. There are 60, 000 Summer Youth Employment jobs. He also gave an update on the departments Comprehensive After School System of New York City.

The Comprehensive After School System of New York City (COMPASS NYC) integrates the best Out-of-School Time (OST) practices with the unprecedented expansion of afterschool programs serving the City's middle school students. Programs are offered at no cost to young people and are located in public and private schools, community centers, religious institutions, public housing, and recreational facilities throughout the City. COMPASS aims to help youth build skills to support their academic achievement, raise their confidence, and cultivate their leadership skills through service learning and other civic engagement opportunities. The COMPASS NYC system is projected to serve 97,000 youth with a budget of \$247.3 million.

I had the honor of attending the Ribbon Cutting of the New Mary Whalen Playground on June 3, 2016 along with Mary Whalen's two daughters, our Chair Raj Rampershad, J.R. Smith Chair of CB9 Parks Committee, Council Woman Crowley who allocated \$1 Million for the project, Assembly Member Mike Miller, Commissioner Mitchell Silver and Commissioner Lewandowsky.

# 11. Education & Youth Services Committee Report – Seth Welins, Chair

Mr. Welins reported on the following:

- Several attempts were made to meet with the Queens Library officials concerning the Richmond Hill Library renovations and proposed closing of the library during the renovations. We expect to meet with these officials within the next few weeks.
- The DOE will be implementing several new programs. One program, Advanced Placement for All, will offer at least five advanced placement courses in every NYC high school by 2021. This program will be gradually phased in over the next 5 years.
- Black and Hispanic students are under-represented in the NYC specialized high schools. The DOE will be offering free intensive test preparation classes for all middle

school students. The major goal of these classes is to help students enhance their test-taking skills. School staff will encourage more minority students to take the admission test and the tests will be offered in all middle schools during the school day instead of weekends.

#### 12. Health & Social Services Committee Report – Marian C. Molina, Chair

Ms. Molina reported on the following:

On June 6, 2016, the Health & Social Services Committee met with Joseph Marzilliano from the Dept. of Health and Mental Hygiene. We discussed the reason for recent media interest in the Zika virus and how the City is taking preventive measures. Recently, scientists have found that there is a link between children born with microcephaly and the Zika virus. The City of NY is monitoring mosquito populations by spraying pesticides or dropping dunks/pellets in public areas where standing water is a problem in order to minimize the risk of mosquito-borne diseases. Mosquito monitoring season runs April 1 through October 31.

The type of mosquito linked to the current outbreak, Aedes Aegypti, can be found in tropical climates such as Central and South America, Mexico, the Caribbean, and parts of Southern United States. Aedes Aegypti has not been found in New York City. A different mosquito that can carry Zika is sometimes found in New York City during the summer: Aedes albopictus. So far, there are no cases of Zika virus reported in NYC.

Standing water complaints should be reported to 311. Homeowners can face violations which carries a fine of \$200. Abandoned construction sites can face violations starting at \$2,000.

Mosquito dunks or pellets can be bought at Home Depot and are recommended for individuals and homeowners who prefer this method in place of spray pesticides.

When traveling or conducting outdoors activities use a mosquito repellant that contains Deet. It is considered to be safe for children and pregnant women.
