Chair Rampershad recognized legislative representatives.

#### Assembly Member Mike Miller stated that:

- Cameras were finally installed around Forest Park. He will allocate \$1M for more cameras to be installed in his district at the sites suggested by the 102 Pct.
- Electronic Recycling Event, sponsored by Assembly Member Miller and Senator Addabbo, will take place on Sunday, September 25, 2016 at the Band Shell parking lot in Forest Park.
- Proposed Safe Haven/Drop in Center for the Homeless is in preliminary stages and he hopes that everybody has a chance to voice their opinions.

Council Member Rubin Wills spoke regarding the decision for DHS to deny support to homeless service provider Breaking Ground's application to establish a Transitional Shelter Facility at 100-32 Atlantic Ave. The proposed facility would be located less than 250 feet from the High School for Construction Trades, Engineering and Architecture. NYS Penal Law 65.10 prohibits certain sex offenders from knowingly entering into or upon school grounds, and it cannot be assumed that measures would be taken to prevent unlawful sheltering of registered sex offenders. Last year, Skyway Men's Shelter was discovered to be sheltering Level 2 and Level 3 sex offenders. The Council Member stated that the NYV Council continues to support and admire Breaking Ground's street outreach. DHS must however deny a contract to any provider that proposes to install facilities at any location where their relative proximity to a school's grounds is less than 1000 ft.

<u>Harpreet S. Toor, Rep. Assembly Member David Weprin</u>, stated that the decision regarding Safe Haven/Drop in Center for the Homeless should be made in consideration with what is best for the community.

<u>Bruce Eiber, Rep. Council Member Karen Koslowitz</u>, stated that the Council Member is not opposing the Proposed Safe Haven/Drop in Center for the Homeless at this time.

<u>Daniel Blech, Rep. Assembly Member Simanowitz</u>, stated that the Assembly Member is working on the Proposed Safe Haven/Drop in Center for the Homeless but has no further comments.

<u>Sergio Galeano, Rep. NYC Comptroller</u>, spoke about the Bureau of Public Affairs Community Action Center which assists New Yorkers with complaints or inquiries about government services on topics ranging from NYCHA repairs to City pension payments, tenant harassment, or filing a claim against the City.

Mr. Galeano stated that an audit recently released by Comptroller Stringer found that the City's Health Department failed to ensure that daycare centers tested their water for lead. Based on a sample of 119 daycare centers, auditors found that lead tests were conducted at only 49 sites, while another 70 were listed as safe without any proof that a lead test was ever done.

**Cheryl Mackey, Richmond Hill Resident**, spoke on behalf of her neighbors stating that they cannot support the Proposed Safe Haven/Drop in Center for the Homeless due to the lack of comprehensive services for the homeless population.

Maria Estrada, Richmond Hill Resident, spoke in favor of the Proposed Safe Haven/Drop in Center for the Homeless.

Carlos Ariza, Woodhaven Resident, spoke in opposition to the Proposed Safe Haven/Drop in Center for the Homeless stating that once it's opened at that location it will always be there and there is nothing that Community can do about it.

**Dee Nixon, Richmond Hill Resident**, did not take any position at this time but stated if the Proposed Safe Haven/Drop in Center for the Homeless is going to go through, the funding should be increased for extra police presence, neighborhood beautification, afterschool safety programs, etc.

**Toby Shepard Blah, CB 5 Member**, spoke in favor of NYC's Select Bus Service proposal for Woodhaven Blvd. and encouraged all to listen to DOT & MTA SBS presentation tonight.

**Stephanie Veras, Woodhaven Resident**, spoke in favor of NYC's Select Bus Service proposal for Woodhaven Blvd as it is a better solution to improve services for Woodhaven commuters.

**Paul Hines, Richmond Hill Resident**, spoke about the problems that still exist after the DOT finished Safety Improvement Project at the intersection of Metropolitan Ave & Hillside Ave.

Simcha Waisman, Richmond Hill, spoke against the Proposed Safe Haven/Drop in Center for the Homeless.

**Dominick Arhale**, **Woodhaven Resident**, spoke against the Proposed Safe Haven/Drop in Center for the Homeless.

**Paul Capocasale, Woodhaven Resident,** spoke against NYC's Select Bus Service proposal for Woodhaven and Cross Bay boulevards stating that speed and time of bus services should not be more important than peoples' safety. - Stated that he met with many of the Legislators during the summer after receiving a notification from Assembly Member Miller re: the DHS Proposal to open a Safe Haven/Drop in Center for the Homeless at 100-32 Atlantic Ave.

- Issued several memorandums to DOT regarding the speed bumps requests and thanked the DOT for agreeing to provide the info whether those speed bumps were physically installed.

## 6. District Manager's Report - Lisa Gomes

"Welcome Back. I hope everyone had a great summer. The office has been busy this summer. Irina processed 151 complaints from June through August. Victor processed 23 Liquor license applications, including 1 Cabaret and 1 TLC application.

This summer I met with Mr. Raul Santillan who is the Tenant Representative for 83-09 Lefferts Blvd. He complained about the Hangar Bar which is across the street from his building. He stated that there is constant noise and music coming from the bar as they leave the doors open during the summer. On July 26, 2016 I arranged a meeting between Mr. Santillan (Tenant Rep.) and Mr. Alba owner of Hangar Bar. Mr. Alba lowered the outside music. There have not been any complaints from Mr. Santillan (Tenant Rep.) since 7/26/16.

Queens District Managers had Budget Consultations On Friday September 9<sup>th</sup>. We met with Dept. of Sanitation, Dept. of Buildings and Housing Preservation and Development. We have 9 more Budget consultations:

Sept. 15<sup>th</sup> - DEP, DOT, DOHMH and NYPD Sept. 27<sup>th</sup> - HRA, DHS, ACS, DFTA and FDNY

Sherman Kane stated that the Oligarch application for cabaret license Use Group 12, formerly Republican Club location, was withdrawn thanks to CB9 initiative and involvement.

Sylvia Hack stated that the Board has to get involved because what we are seeing in terms of these shelters is really a problem of affordability. The Independent Budget Office of New York has calculated that it costs the city \$1.2 Billion in lost property taxes every year.

# ▶ Update on Speed Hump on 98<sup>th</sup> St. btwn Jamaica Ave and Park Lane South

Alex Blenkinsop stated that DOT finally installed the two speed humps on 98th Street (between Jamaica Avenue and Park Lane South) that CB9 approved over four years ago. Unfortunately, the locations of those speed humps are at the extreme beginning and end of the block, doing nothing to stop speeding on the 1,000-foot stretch that was the original source of concern for the residents. Multiple people from 98th Street have already complained that the locations of the speed humps rendered them ineffective.

DOT has said they could find no alternate locations that fit their guidelines. Yet they set aside those guidelines by placing one of the speed humps fewer than the required 200 feet from a curve in the road.

He had two suggestions for DOT regarding future speed hump installations:

- 1. If curb cuts prevent a speed hump from being installed, DOT should collaborate with other city agencies to ensure those curb cuts are actually legal. DOT conceded at a previous CB9 meeting that they do not currently do this.
- 2. DOT should explain when and why it deviates from its own guidelines when installing some speed humps, and why it does not do so in the cases of other speed humps.

#### 10. Health & Social Services Committee Report – Marian C. Molina, Chair

# ► Update on Breaking Ground Organization – Proposed Safe Haven/Drop in Center for the Homeless at 100-32 Atlantic Ave

"On Tuesday, August 25, 2016, the Health and Social Services Committee met with representative of Breaking Ground and other elected officials representatives regarding a proposal to open a Drop – In Center/Save Haven at 100-32 Atlantic Avenue. We learned that the proposal is in the preliminary stages. The proposal was not available for review.

At the meeting we learned that Breaking Ground will be servicing adults 18 years of age and older. The Drop-In facility will service both genders. As for the Safe Haven, a gender has not been established. This is not a homeless family shelter. This location will service street homeless individuals who refuse to stay at homeless shelters. The purpose is to find them permanent housing. There is no time limit set as to how long a homeless individual may stay at the facility. The Center will offer semi-private beds, approximately 75, shower facilities, meals, laundry facilities and medical services such as psychiatric services. The facility will service homeless individuals with mental illness and other conditions. It is not a substance abuse treatment center. These individuals will be referred and transported to other locations that offer this type of service.

We asked about screening for sex offenders since they will be located near schools. They responded that they do not screen for sex offenders. We asked if other locations in Queens were considered. They said yes but no specifics were given. There will be 24 hour security inside and around the perimeter of the facility. During off hours there will be 3-5 staff members, more during business hours.

A Q&A letter was sent to M. Borden, Assistant Commissioner for the NYC Dept. of Homeless Services. Mr. Borden provided answers to our letter. All Board members were copied."

Question and answer period followed.

## 11. Education & Youth Services Committee Report – Seth Welins, Chair

- Temporary classrooms have been removed from Richmond Hill HS schoolyard. The school now has a very nice track and sport field. The scaffolds have been removed and there appears to be new windows. The school recently unveiled a new media center for the students.
- Raj Rampershad, J. Richard Smith, John Carter and Seth Welins met with officials of Queens Library

on June 23. We expressed our strong concerns about the possible closing of the Richmond Hill Library during upcoming renovations. Queens Library officials were asked to consider other options to a full closing, such as keeping the children's room open during the renovation. We also strongly urged Queens Library to lease an alternative space near the library if the library has to be closed. As of this date, we have not heard from them.
