He stated the following:

- 102nd Pct. is number seven in the city for crime reduction in all aspects: robbery, grand larceny, auto theft, etc.

- A meeting with the Deputy Director of the SLA Michael Jones will take place on Wednesday, November 17th, 2016 at 2 pm at the district office. We will discuss ongoing issues with establishments in the CB9 area and find out what happens to the letters that are sent to the SLA.

6. District Manager's Report – Lisa Gomes

"I attended Press Conference re: Transitional Residence /Drop in Center for homeless adults. NYC Council Member Rubin Wills & Assemblyman Michael Miller and other community leaders called on both the Dept. of Homeless Services (DHS) and provider Breaking Ground to participate in a Town Hall Meeting to discuss the Transitional Residence and Drop-In Facility. The Department of Homeless Services and Breaking Ground have agreed to a Town Hall Meeting that will not conflict with the Jewish observance of Simcha Torah. The Town Hall meeting will be held on November 10, 2016 between 6 p.m. and 9 p.m. at Richi Rich Palace, 110-19 Atlantic Ave.

Breaking Ground Submitted a Proposal to the Dept. of Homeless Services (DHS).

- DHS has received their proposal and it is still under review. Nothing has been finalized as of yet. They are moving forward with community meetings.
- They are in the process of meeting with community stakeholders including those specifically recommended by Rai:
- On Nov. 2, 2016 Breaking Ground (Claire Sheedy, Doug Becht and Cara Ochsenreiter) and DHS (Matt Borden) representatives met with The High School for Construction Trades, Engineering & Architecture Principal Lakeisha Gordon and colleagues including the head of the high school's PTA.
- Breaking Ground is scheduling meetings with the following block associations in the hopes they can get to all before Thursday, November 10.
 - Richmond Hill Block Association
 - Woodhaven Resident's Block Association
 - Richmond Hill East Block Association

Attended Queens Borough President Melinda's Borough Cabinet Meeting (Oct. 19, 2016). The NYC Fire Department gave a presentation on Fire Safety:

- 70% of fires can be stopped with Smoke Detectors.
- Batteries in your Smoke & Carbon Monoxide Detectors should be changed twice a year.
- Stay in your house or Apartment when there is a Fire.

Queens Borough President Melinda Katz wrote a letter regarding Changes to the Street Festival permit process that would seriously affect our communities, undermine the authority of Queens Community Boards and potentially do away with street festivals in our borough.

She reported that after all public testimony was presented to the agency, The Administration has listened and for now has placed the proposal on hold for at least another year and the 2017 process will remain the same.

Irina processed sixty complaints for the month of October.

7. Land Use Committee Report – Sylvia Hack & Sherman Kane, Co-Chairs

Sylvia Hack stated that the state's controversial 421-a program -a tax break for certain newly built residential developments- is getting a new life and could soon unlock \$2 billion in state affordable housing funds.

Chair Rampershad stated that he is trying to set up a meeting with DOB Commissioner Dereck Lee, but he is away on vacation until November 22, 2016.

A meeting with Senator Addabbo will be set up in order to discuss 421-a.

8. Transportation & Traffic Committee Report – Kenny Wilson, Chair

Chair Rampershad gave an update on Jamaica Ave: at our board meeting on October 11, 2016, we voted to oppose SBS on Woodhaven Blvd. Two days later, DOT began construction of safety improvements at Woodhaven Blvd. and Jamaica Ave. The work included realigning the left turn bays and an expanded pedestrian median.

Woodhaven Blvd. & Jamaica Ave is one of the deadliest intersections in the city, tied with Adam Clayton Powell Blvd. in Manhattan.

Mr. David stated that there is no update on the LIRR underpass at Jamaica Ave & Sutphin Blvd.

Chair Rampershad stated that NYC DOITT is looking into Wi-Fi locations in CB9 submitted by Richard David. Originally it was only one location in Kew Gardens.
