Bruce J. Flanz, President and CEO of Jamaica Hospital wished all a happy and healthy holiday season.

Mr. Flanz gave a progress report on Jamaica Hospital for the year. He stated that in March, 2016 Jamaica Hospital had a survey by the American College of Surgeons to determine whether or not the hospital meets their standards to continue to be a Level 1 Trauma Center. Jamaica Hospital scored 100%.

In November, 2016 The Baby Friendly USA Organization conducted a survey to determine whether a Hospital meets the standards of being baby friendly. There are about 2,500 hospitals with maternity programs in the country and only 383 have achieved that recognition. The results of the survey will be known within a month.

Jamaica Hospital had a fundraiser to renovate its Hospice Unit in the beginning of last year. Over \$1M was raised most of which came from one of the hospital trustees Joseph Ferarra. His family has been very generous and this unit will be named in their honor. Tentative project completion date is April, 2017.

## Department of Sanitation Draft Snow Plan

DSNY Inventory of Available Snow Management Equipment:

9 large spreaders, 39 plowable trucks, 61 plow blades (assigned), 3 front end Loaders The Department has new snow equipment including 80 Additional holsters which will limit the use of outside contractors. Sanitation has also purchased 21 new Front-End Loaders, which will replace mid-sized Front end Loaders. The Department prepares months in advance and has adequate equipment, parts and supplies to carry out this Snow Plan.

## Home Stability Support- Andrew Hevesi

There are over 150, 000 homeless Children in NYS. More Than 80, 000 households are on the brink of homelessness in NYS. Shelter allowance is \$264 to \$447 per month. Cost of Housing is \$658.00 to \$1608 per month. 82, 000 households have rents 1.5 times or more than their shelter allowance. Homelessness has gone down nationally but has increased in NY. The City is at maximum capacity of homelessness. Taxpayers fund over \$1 Billion for Shelters.

Current Shelter Allowance for 3 Person Household with children in NYC is \$400.00. 2016 UD Fair Market Rent for 2 Bedroom unit is \$1,571. 54, 013 families in NY struggling to make ends meet, can't pay their rents and are in danger of being homeless. There are over 150,000 homeless children in New York State and another 80,000 families on the brink of homelessness. Every year 19,000 more people become homeless than escape homelessness, according to New York State's report to HUD.

## Presentation on Bioswales/ Rain Gardens, DEP

Rain gardens (aka Bioswales) capture storm water runoff and help nourish hardy, absorbent plantings which both beautify and green the surrounding communities. Rain gardens reduce the amount of water that drains into the City's combined sewer system, which improves local waterways and Jamaica Bay. Each rain garden has the capacity to collect and absorb up to 2,500 gallons of storm water when it rains.

842 rain gardens will capture an estimated 113 million gallons of storm water each year, Subsequently reducing sewer overflows into local waterways, including Paerdegat Basin, Fresh Creek, Hendrix Creek and Betts Creek, and thereby improving the health of the Jamaica Bay watershed. Rain gardens capture storm water runoff and help nourish hardy, absorbent plantings, which both beautify and green the surrounding communities." Additionally, these rain gardens

reduce the amount of water that drains into the City's combined sewer system, which improves local waterways and Jamaica Bay."

## 7. Land Use Committee Report – Sylvia Hack & Sherman Kane, Co-Chairs

Sylvia Hack stated that the meeting with State Senator Addabbo will be re-scheduled for after the holidays. At that meeting CB9 Land Use Committee will discuss the record crisis in homelessness in the city and the 421a tax abatement. According to the New York Times, record number of people is seeking shelter. As per the Independent Budget Office the City of New York is losing \$1.5B to \$2B in revenue every year because of the 421a Tax Exemption. For example, one of the apartments in Park Slope was for sale for \$1.3M and the property tax because of 421a exemption is \$6 per month.

The Land Use Committee would like to get other Community Boards involved in resolving the issue.

Maricela Cano, Rep. Council Member Ulrich, reported on the Participatory Budget Updates:

- Dog Park in Forest Park was budgeted for \$175,000; anticipated completion is spring, 2017.
- Baby Carriage Lane was budgeted for \$400,000; design to begin in April.
- Lt. Clinton Whiting Square was budgeted for \$250,000; anticipated design is in spring, 2017.
- Forest Park repairs and resurface to pathways adjacent to Schaefer Memorial was budgeted for \$150,000; anticipated construction is spring of 2017.

Ms. Cano stated that the Council Member's office is working with Queens College to bring a program that will prepare adults to take TASC test, formerly known as GED. This program is designed to prepare adults to take and pass this test. Council Member Ulrich has designed this program so all students receive textbooks, instructors and a coach. The office is looking to launch this program in March, 2017.

**Muhammad Rahman, Rep. Assembly Member David Weprin**, stated that the Assembly Member is sponsoring an annual Toy Drive at the Assemblyman's office on 111-12 Atlantic Ave, Richmond Hill, NY 11419. All donations must be received by December 16, 2016.

**Kevin Jean Baptiste, Rep. Senator Sanders Jr.,** stated that Senator Sanders Jr. is sponsoring a Housing Conference on Thursday, December 15<sup>th</sup>, 2016. Constituents can get important updates

about affordable housing, learn how to apply for affordable housing in NYC and understand their rights as tenants.

**Brendan Pillar, Department of City Planning**, stated that he was the Queens/CB9 planner for the past six years. He spoke about the successful operation of Richmond Hill and Woodhaven rezoning in 2009 and introduced Breyonne Golding as a new CB9 liaison.

**State Senator Joe Addabbo** thanked all board members for their services and wished all a happy holiday season.

## 12. Education & Youth Services Committee Report - Seth Welins, Chair:

"The Every Student Succeeds Act was enacted by Congress in 2015. It replaces the 2001 No Child Left Behind law. The NCLB Act centralized many educational polices in the Federal Government. The current ESSA law authorizes each state to develop its own academic rules and regulations. In effect, the ESSA ends federal interference in state standards and ends the federal mandates to adopt the Common Core State Standards.

New York State is now responding to parent and teacher concerns about many of the more onerous Common Core Standards, (standards that are not age-appropriate, for example) and the methods currently being used to assess whether students, schools and teachers are meeting these standards. Commissioner Elia formed a task force which will recommend modifications in the current Common Core Standards and in the testing procedures. These changes will allow schools to significantly reduce testing time and preparation. Schools will be allowed greater flexibility for assessing English language learners and students with disabilities."
