#### 2. PUBLIC FORUM

<u>Gary Chin, American Red Cross Disaster Program Manager</u>, stated that his unit deals with disasters, i.e. fires, provides shelter, food and emotional support to victims of disasters. Mr. Chin said that there is a great need for volunteers to provide home, fire safety and other disaster preparedness to the public.

Ken Davis, Woodhaven Resident, raised the following issues:

- Requested a speed hump on 75<sup>th</sup> Street between Jamaica and 88<sup>th</sup> Avenues.
- Stated that people are inconsiderate with their parking by blocking spots for people and leaving gaps in street parking.
- Trash problems on the corner of Jamaica Ave & 75<sup>th</sup> Street.

Chair Rampershad acknowledged Legislators and their representatives.

Carl Moore, Rep. State Senator Joe Addabbo, no report.

**Carmela Isabella, Rep. Assembly Member Miller**, stated that they are having a mammogram van on May 7<sup>th</sup>, 2017.

Bruce Eiber, Rep. Council Member Karen Koslowitz, no report.

Talya Skolnik, Rep. QBP Melinda Katz, reported on the following:

- Thanked everyone who attended the Borough President's third annual State of the Borough Address.
- On January 29<sup>th</sup>, in response to the Trump administration's executive orders, the Borough President went to John F. Kennedy International Airport to meet with attorneys and representatives of the Mayor's Office who were assisting individuals detained there.
- Townsend Harris High School, which is currently led by an interim acting principal, recently experienced substantial unrest regarding the C-30 process, which is the NYC Department of Education's official public review process for hiring a permanent principal for a school. On December 20, 2016, the Borough President sent a letter to Chancellor

- Farina, urging her to review the concerns raised by the school community and to restart the C-30 process at the school.
- Borough President Katz has also appointed Andrew P. Jackson to the Queens Library's Board of Trustees. Mr. Jackson is an East Elmhurst resident with a long history of community service.
- The next Borough Board meeting is tomorrow night at 5:30pm. There will be a hearing and a vote on the Borough Board's budget priorities for FY18.
- Borough President Katz's Celebration of Black History Month will be this Thursday, February 16<sup>th</sup> at 6pm in the Helen Marshall Cultural Center at Borough Hall.
- The Borough President's Celebration of the Lunar New Year will be Monday, February 27<sup>th</sup> at 6pm, also in the Helen Marshall Cultural Center at Borough Hall.

**Daniel Blech, Rep. Assembly Member Simanowitz,** stated that the NYLAG van from the NY Legal Assistance Group will be at their office on February 27, 2017 from 10 am to 3 pm.

**Leslie Patterson, Rep. Council Member Ruben Wills**, stated that there was no ICE task enforcement at Van Wyck Expressway and 109<sup>th</sup> Ave. She also distributed Know Your Rights with ICE flyers.

Adrienne Felton, Rep. Public Advocate Letitia James, stated that she covers the south east Area of Queens and is the ombudsman for the agency. Ms. Felton said that one of the items on their February 2017 Newsletter is about preserving affordable housing and protection of homeowners who are at risk of losing their homes. #### 4. Monthly Update Report 102 Pct.

PO Severino spoke about Check Washing Scheme stating that thieves steal outgoing mail from drop boxes using an acid based mixture to dilute the ink on personal checks and rewrite them to another recipient. This process accounts for more than #815 million in fraud annually. The NYPD recommends bringing all outgoing mail to the post office and to review bank and credit card statements frequently.

PO Severino notified all about a website <u>www.nypdonline.org</u> which has very useful info, i.e. comp stats, traffic stats, collision reports, etc.

PO Martinez announced the next 102<sup>nd</sup> Pct. Community Council meeting will take place on Tuesday, February 21<sup>st</sup>, 2017 7-9 pm at the Richmond Hill Library. #### 6. District Manager's Report – Lisa Gomes:

# Borough President Melinda Katz State of the Borough Address

The Borough President outlined the accomplishments of the past year and the direction the Borough is going.

- Queens is experiencing the highest tourism increase City Wide, while school overcrowding has been reduced.
- The Borough President stated that the Willets Point Area is going to get a face lift with a proposed Soccer & Hockey Stadium.
- Immigrant Support will be a High Priority in 2017. Since the U.S. Citizenship and Immigration Services field office in Long Island City shut its doors, Borough President Katz & Congressman Meeks are proposing to reopen the queens office in the vacant space available at the Federal Citizenship Office space at the Addabbo Federal Building in Jamaica, which is accessible by public transportation. Immigrant Support will be a High Priority in 2017.
- She called for the creation of a special permitting process for all new proposed hotels.

This Process would compel all Hotel projects in the City to go through a mandated public review through the city's Uniform Land Use Review Process (ULURP).

• The process would grantee community Input and allow Government to better monitor Hotel Growth City Wide.

Attended the Chamber of Commerce Breakfast on Feb. 7, 2015 at La Guardia Plaza Hotel which featured Borough President Melinda Katz who spoke about accomplishments of the past year and the direction of the Borough.

I testified at the QBP'S FY2018 Preliminary Budget Hearing Re: CB9Q Capital & Expense Budget Hearing. The Borough President and Council Woman Karen Koslowitz were interested in the Kew Gardens Senior Center's request for computers.

- Irina processed 47 Complaints for the month of January.
- Victor processed 8 Liquor Licenses and 2 Taxi & Limousine Licenses.

The next staff meeting is on Thursday, February 16<sup>th</sup> at 12 pm.

7. Land Use Committee Report – Sylvia Hack & Sherman Kane, Co-Chairs Sylvia stated the following:

"The proposed 421a legislation concerns us because of the lack of money for affordable housing. We would not need shelters if we had more affordable housing. The majority of the 61,000 homeless people in this city are homeless because they cannot afford a home. Lack of affordable housing is impinging on more and more communities. We hope to have some sort of resolution next month depending on what is happening with the proposed legislation in the state, for which the city is now losing \$1.5 to \$2 billion a year in property taxes, most of it to subsidized housing for the very rich and the super-rich."
