2. PUBLIC FORUM

<u>Kevin Burns</u>, <u>Kew Gardens CSA</u>, stated that there are only two weeks left to sign up for CSA program and urged all to take this great opportunity.

<u>Rayad Khan, Richmond Hill Resident</u>, spoke about the issue he is having with planting of a new tree. He also made a request to resurface Metropolitan Ave from Jamaica Ave to 130th Street.

<u>Fabrice Armand, Dept. of Correction,</u> stated that the NYC Dept. of Correction is now hiring correction officers as well as non-uniform individuals. The 2017 exam dates are May 1-May 31 for civil service title 7331 and June1-June 30 for title 7327. The flyers and booklets are available in the back.

Chair Rampershad recognized Legislative representatives.

Bruce Eiber, Rep. CM Koslowitz, stated that he represents Council Member Karen Koslowitz at all CB9 meetings.

Mohamed Hack, Rep. QBP Katz, invited all to Guianese Independence Celebration at the Hellen Marshall Atrium on Monday, May 15th, 2017 sponsored by Borough President Melinda Katz.

<u>Carmela Isabella, Rep. AM Miller,</u> informed all about NYLAG's Mobile Legal Van coming to AM Miller's office at 83-91 Woodhaven Blvd., on July 24th, 2017 from 10 am-3 pm.

<u>Carl Moore, Rep. Senator Addabbo</u>, stated that the Senator is sponsoring numerous free community events listed on the flyer that's available for everyone.

<u>Daniel Blech, Rep. Assembly Member Simanowitz</u>, asked the board members to tell him if there are any concerns that he can give the Assembly Member to be resolved.

3. Opening of Meeting & Reading of Minutes

Treasurer Mrakovcic asked if there were any corrections/additions to April 13th, 2017 minutes. There were none.

4. Monthly Update Report 102 Pct.

Deputy Inspector Urprasad stated that:

- This is his third year in the 102nd Pct. For the past 28 days the precinct is down 31% in crime.
- There are four Police Officers who cover Forest Park seven days a week trying to keep it safe. There were over 350 quality of life summonses issued in the park and over 37 arrests made for

- graffiti, smoking marijuana and reckless driving.
- Two arrests were made for stealing mail from mail boxes. The precinct is in constant contact with the
 mail inspector as it became a citywide problem. He suggested to physically go inside the post office
 and send the mail from there.
- The perpetrator who was involved in six commercial burglaries was arrested and is out on \$500,000 bail.

Deputy Inspector Urprasad answered board members' questions.

6. District Manager's Report – Lisa Gomes:

Attended the Queens Borough Cabinet Meeting on April 4, 2017.

There was a presentation on FDNY EMS Queens Tactical Response Team.

- ► Christine Mazzola, Division Chief Queens discussed EMS:
 - Provides care to residents and Visitors of NYC.
 - Certified First Responder FDNY Engine companies respond to high priority assignments and assist in patient care and patient removal.
 - Basic Life Support ambulances provide basic medical care such as caring for patients who may have non-critical injuries, vehicle accidents or minor medical conditions.
 - Advanced Life Support ambulances provide advanced medical care such as caring for patients who may suffer from cardiac arrest, stroke or heart attack.
 - Neighborhoods and Demographics- Queens
 - Size: 109 Square miles
 - Population: 2.3 Million (July 2016 census)
 - 9 Major Highways
 - 8 hospitals

Queens Tactical Response Group

There are two groups of seven units and one officer that operates during the day and evening. Units overlap hours, operating primarily during the peak call volume. They are deployed within the borough as a team based on call volume and response times. Response times are updated hourly to get the most accurate information.

7. Transportation & Traffic Committee Report - Kenny Wilson, Chair

Mr. Wilson stated even though the board already voted in opposition to the 87th Street conversion, the Traffic & Transportation Committee will continue to look for alternative ways to make this area safe.

8. Land Use & Zoning Committee Report – Sylvia Hack & Sherman Kane, Co-Chairs

Sylvia Hack stated that Breyonne Golding, the Board's liaison from the Dept. of City Planning, will be attending the May 23 Land Use Meeting. She will be discussing both the proposed Zoning Text Amendment which relates to the building of self-storage facilities in manufacturing zones, and the Parking study which she carried out re the Board's request for a special district in Kew Gardens to deal with the construction of multifamily buildings without a requirement for on-site parking.

9. Education & Youth Services Committee Report – Seth Welins, Chair

Motion # 2: To approve a CEC27 resolution asking for the D.O.E. to mandate a mass notification system at every school as part of a mandated safety plan.

Vote # 2: 32 in favor and 1 abstention

- According to Politico New York article, "less than 5% of current undergraduate students at SUNY and CUNY will be eligible for the (Excelsior) scholarship, according to rough estimates presented at a SUNY Board of Trustees meeting. Parents and students should make sure they qualify for scholarships when considering college options.
- According to a Richmond Hill Library employee, construction and closure of the library is still slated to begin in the near future. Our board will ask Queens Library officials to speak at an upcoming CB9 board meeting.

Council Member Elizabeth Crowley addressed the board and gave updates on the following:

- Fun and Fitness for 55+ Seniors Program will start this year in Forest Park.
- Free Trees and Rain Barrels will take place on Saturday, May 13th, 2017, 11 am-3 pm at The Shops at Atlas Park, 80-00 Cooper Ave.
- Together with the Woodhaven Historical & Cultural Society and the American Legion Post 118 the celebration of Co-Naming of Forest Park Memorial Drive will take place on Saturday, May 20th, 2017 at 12 pm at Forest Park Dr.
- Lower Montauk Branch Public Workshop will take place on Tuesday, May16, 2017 at 7 pm at 80-00 Cooper Ave.
- In a pilot program, the first of its kind in NYC, CM Crowley allocated \$2.2 M in capital funding to improve 21 local schools. Each public school in CD30 not only received \$100,000 in capital upgrades but also the chance to vote on how the money was spent.

11. Health & Social Services Committee Report - Marian C. Molina, Chair:

Old Business – Drop – In Center at 110-32 Atlantic Avenue is now open and operating. CB9 is still waiting for an invitation to tour the facilities as promised, and asked for information as to the extent of their services up to date.

New Business – On 4/24/17, CB9 received a letter from the NYS Office of Alcoholism and Substance Abuse Services notifying us that they had received a funding request from Outreach Development Corporation, a provider of substance abuse and alcohol treatment services, for its Women's Residence Project at 117-15 Myrtle Avenue and 117-08 Hillside Avenue. We were given 30 days to address concerns or questions. Kathy Riddle, President and CEO of Outreach met with the Health Committee on 5/3/17. She stated that the residence will start construction soon and be completed within 9 months. State funds are secured for this capital project. The residence will have the capacity to house 25 female patients, and up to 9 children under the age of 5. Outreach has been at this location for 25-30 years. They are an outpatient drug treatment facility. They service CB5 and CB9 primarily at this location. They service women, adolescents and young adults. Patients are carefully screened before being accepted into the program. They accept major insurance plans and are not dependent solely on State funds. Referrals come from churches, unions, schools and other community organizations. The Women's Residence is not a homeless shelter. It is a temporary residence for up to 6 months. Patients are expected to move out and are responsible for finding their own housing. Outreach offers assistance with applications for Section 8 and housing. In some instances, when patients can't afford to pay rent on their own, Outreach tries to pair them up. The women's residence is equipped with Security and cameras. They have strict

rules. There are always 2 people on staff from midnight till 7:00 A.M. Patients are not allowed to leave the building unless they have been given a pass. Beth Covelli, Senior Director of NYC Outpatient at Outreach, will be attending our next general meeting on June 13, 2017.
