6. District Manager's Report – Lisa Gomes: "On May 31, 2017 Council Woman Elizabeth Crowley Hosted Forest Park Memorial Drive Co-Naming Ceremony. Council Member Crowley continues to commemorate the lives of those who fought for our freedom and paid the ultimate sacrifice, by officially co-naming Forest Park Drive to "Forest Park Memorial Drive." The road now has a name that serves as a reminder that it contains several memorials to those who gave their lives in service to our country.

Council Woman Crowley sponsored legislation in the City Council to bring about this co-naming, which was greatly supported by American Legion Post 118, Vietnam Veterans Local Chapter 32, the Queens Historical Society and the Woodhaven Cultural and Historical Society.

Our very own J.R. Smith was recognized for his service to our country."

7. Health & Social Services Committee Report - Marian C. Molina

- *Guest Speaker*, Senior Director of NYC Outpatient for Outreach Corporation, Women's Residence for Alcoholism and Substance Abuse. Community Board members are welcomed to visit the Outreach Center. Please contact Kathy Riddle, President and CEO for an appointment.
- The Health Department announced on June 1st that fentanyl is being increasingly found in cocaine-involved overdose deaths. Fentanyl, an opioid 50 to 100 times more powerful than morphine, is being mixed in illicit drugs often without the buyer's knowledge. The presence of fentanyl in any illicit drug, including cocaine, increases the risk of overdose. We are sharing this important information so that you might alert your clients and patients. Individuals who do not regularly use opioids but encounter fentanyl mixed into cocaine are at particularly high risk for overdose. For more information please contact NYC.gov or call 311.
- New Rules in Effect: Pet dogs are now allowed in some outdoor dining areas with restrictions. Read the <u>Dining with Dogs law</u>. New York State law requires that all dog owners license their dogs, and the New York City Health Code requires that dog owners attach the license tag to their dog's collars while in public. Dog owners may be fined for violation of these laws. A dog license costs \$8.50 per year for spayed or neutered dogs or \$34 per year for non-spayed or neutered dogs. Dog licenses may be purchased or renewed for one to five years. All dog license fees are non-refundable. You can apply for a New York City dog license or renew an existing license <u>online</u>. You can also download the <u>application and instructions</u> or call **311** to request to have a paper copy mailed to you.

8. Land Use & Zoning Committee Report – Sylvia Hack & Sherman Kane, Co-Chairs: Land Use Committee met with Breyonne Golding of DCP. Ms. Golding presented NYC Dept. of City Planning's Self Storage Text Amendment which requires a special permit for new self-storage facilities within NYC's most active industrial areas. There are only two Self-storage facilities in CB9. Ms. Golding also presented the current status of request for a special district in Kew Gardens in order to alleviate parking problems.

Sylvia Hack stated that Kew Gardens is faced with a potential loss of the Lefferts Blvd Bridge over the LIRR-home to the mom and pop stores that serve the shopping needs to its residents and give the town its character. Save Kew Gardens Coalition started a petition and now has over 3,000 signatures.
