DM McClelland wished happy birthday to Kamal Bhuiyan, Dulal Bhattacharjee, John Carter, Daniel Chu, and Lilian Yagual.

He talked about the district's newest problem: smoke shops opening everywhere. The community board has not received one application from twenty locations in CB9. DM McClelland is working with the Sheriff's office and the 102^{nd} Pct. to come up with a solution.

Mr. McClelland wished everyone happy, healthy and joys holidays.

6. MONTHLY UPDATE NYPD 102nd Pct. Report

Capt. Jeremy Kivlin, the 102nd Pct. Commanding Officer, reported on the following:

- Crime stats are down 2% for the last 28 days.
- Commercial robbery cases are still on the rise.
- A shooting incident occurred at the intersection of 133rd Street & Metropolitan Ave which was over a dispute between

Chair Algredo stated that she signed a letter addressed to Governor Hochul that would ask to sign a bill that she personally requested. The bill would allow to prioritize the needs of students with disabilities and bring fair and equitable financial compensation for special needs educators at a private institution. But before this letter had come to a vote, the Governor vetoed the bill.

9. HEALTH & SOCIAL SERVICES COMMITTEE REPORT - Marla Abarca, Chair was not present to give a report

Chair Algredo congratulated Ms. Abarca on the birth of her baby boy.

10. ECONOMIC & COMMUNITY DEVELOPMENT COMMITTEE REPORT - Matthew Singh & Kirpal Billing, Co-Chairs

Chair Algredo stated that Schmidt's Chocolate, a nearly 100-year-old candy shop located at 94-15 Jamaica Avenue in Woodhaven, was recognized as part of the state's Historic Business Preservation Registry.

Ms. Algredo attended the ceremony and presented the Certificate of Recognition from CB9.

Mr. Billing stated that his fellow board member, Mr. Faiuze Ali, has initiated a questionnaire that will help small business owners to identify post-Covid problems. This questionnaire will be circulated withing two weeks.

Mr. Billing asked all to support their local vendors during this holiday season.
