# 3. OPENING OF MEETING & READING OF MINUTES

Chair Algredo asked if there were any corrections/additions to April 12<sup>th</sup>, 2022, meeting minutes and motions. There were none.

#### 4. MONTHLY UPDATE NYPD 102<sup>nd</sup> Pct. Report

Capt. Naor announced that the precinct's commanding officer, Deputy Inspector Antonio Fidacaro, is moving on and that interviews for a successor, as well as community input, will get underway.

She reported on the major crime stats for the last 30 days, stating that there was a spike in felony assaults, 75% of which were attributed to domestic violence incidents. Capt. Naor made everyone aware that a Safe

Horizon domestic violence advocate, Cindy Caldas, is available at the Precinct from 8 AM to 4 PM for those

who seek help.

Naor said that summer plans are in the works including rapid response to 311 complaints. She took

questions about recent crimes including an alleged robbery of a Sikh man in Richmond Hill.

# 5. CHAIRPERSON'S REMARKS & EXEC. REPORT–Sherry Algredo/District Manager's Report-James McClelland

- DM McClelland wished happy birthday to Zoila Bofill, Reaz Khan, Regina Santoro, and Seth Welins.
- On April 14<sup>th</sup> a community rally was held at the intersection of Union Turnpike and Park Lane South. The
  purpose of the rally was to get DOT to reconsider their refusal to extend pedestrian crossing time. Happy
  to announce that DOT incorporated a Leading Pedestrian Interval at the intersection which allows
  pedestrians to cross while all motor vehicles are stopped.
- On April 21<sup>st</sup> the District Manger met with Kirpal Billing to walk the area around his business and observe some quality-of-life issues including trash accumulation in rain gardens, derelict vehicles, and the Atlantic Avenue median repair. DEP sent a crew the next day to clean the rain gardens. He met with NYPD on April

28<sup>th,</sup> and they were able to remove vehicles from the street. Thanked PO Adelman for his assistance. Organizing another road tow operation in the beginning of June. Kirpal also discussed the possibility of placing metered parking in business corridors to help with parking and the possibility of applying APS regulations in some areas.

 Met with Woodhaven BID, local merchants, NYPD, Sanitation and DSS regarding problems with the Eldert Lane Shelter over the Brooklyn Border. No one from the shelter attended the meeting.

Chair Algredo reported on the items that were discussed at the last Borough Board meeting. She thanked all veterans for their service.

# 11. TRANSPORTATION & TRAFFIC COMMITTEE REPORT – Faiuze Ali, Chair

- Mr. Ali spoke about The SLEEP (Stop Loud Excessive Exhaust Pollution) Act which will raise fines from \$150 to \$1,000 for any illegal modifications of mufflers and exhaust systems that allow cars and motorcycles to become noisier. The law applies not only to vehicle owners who seek the modifications, but to the repair shops that make them or sell relevant parts.
- Gave a brief update on Queens Bus Network Redesign project stating that Community Board 9 is slated for its bus redesign workshop on Monday, May 16.

# 12. HEALTH & SOCIAL SERVICES COMMITTEE REPORT – Marla Abarca, Chair

# > LiveOnNY Mission – Raida Hossain, Community & Government Affairs Liaison

The LiveOnNY mission is to save lives, provide comfort, and strengthen legacies through organ, eye, and tissue donation. Ms. Hossain stated the following:

- They work with local hospitals and transplant centers to deliver the gift of life.
- They care for the families of the organ donors who selflessly give the gift of life.
- They educate the community about the power of donation.
- They advocate on behalf of those who are waiting for transplants.
- Ms. Hossain shared with the board the fact that the month of April was National Donate Life Month. The organization reached out to the communities about organ donations and their importance.
- Only 45% of New Yorkers are registered organ donors.
- Low registration rates have led to an organ shortage.
- Due to the shortage, those who need transplants wait longer.
- On average a New Yorker on the transplant waiting list dies each day.

# 13. LAND USE & HOUSING COMMITTEE REPORT – Sylvia Hack & Andrea Crawford, Co-Chairs

DM McClelland stated that on May 4<sup>th</sup> he sent a follow-up email to Sasha Ginzberg, Executive Director of Borough-Based Jail System but this time cc'd all our elected officials which finally elicited the following response:

"I apologize for the delay in my response. I have been working with our data team to understand what information is possible to provide. Our address data is self-reported, so as a result it is unreliable, and we are not able to provide zip code-level analyses. I am working on providing you with answers to the other borough-specific questions for which more reliable data exists and will circle back shortly once the information has been verified. Thank you for your patience."

#### 14. ECONOMIC & COMMUNITY DEVELOPMENT COMMITTEE REPORT – Matthew Singh & Kirpal Billing, Co-Chairs

Mr. Billing thanked DM McClelland for arranging the removal of derelict cars on 94<sup>th</sup> Ave between Lefferts Boulevard. He also thanked him for submitting a request to DOT to install new parking meters on that block. Mr. Billing had pointed out that the Committee made a commitment to help small businesses.

# 15. PARKS, RECREATION & ENVIRONMENT COMMITTEE REPORT – J. Richard Smith, Chair

Stated that there were two items discussed at his committee meeting: permits for a group that has been trying to use the baseball field and park benches around the Overlook. Both items were referred to the office for the District Manager to resolve both situations.

As per committee members' request, the committee meeting time will be changed to a later hour.

#### 16. BY-LAW COMMITTEE REPORT – REAZ KHAN, CHAIR

Mr. Khan stated that the committee will be reviewing and revising current CB9 By-Laws. Any input and suggestions are welcomed and appreciated.

<u>Michael Carlier, Rep. Assembly Member Andrew Hevesi</u>, reported on the events sponsored by the Assembly Member. He also gave an update on the outcome of the rally that was organized by DM McClelland at the intersection of Union Turnpike and Park Lane stating that the DOT will be exploring safety treatment at this location.

<u>Rokeya Akhtar, Rep. Queens District Attorney Melinda Katz</u>, invited all to the Memorial Day observance Ceremony Zoom Event on Thursday, May 26 and other events sponsored by the DA.

Lynette Shelborne-Barfield, Rep. Speaker Adrienne Adams, reported on the events sponsored by the Speaker and shared her contact information. She also stated that masks, test kits, and hand sanitizers are available at the district office.

<u>Viola Isufaj, Rep. Assembly Member Jenifer Rajkumar</u>, reported on the events sponsored by the Assembly Member. Stated that AM Rajkumar is in direct communication with Mayor Adams on trying to resolve the issue of a recent hate crime incident in Richmond Hill.

Anthony Giudice, Rep. Senator Addabbo, reported on the events sponsored by the Senator.

Linda Fogal, Rep. Council Member Joann Ariola, reported on the events sponsored by the Council Member. She also stated that the Council Member will be introducing her bill, requiring that the mayor create an "Office of Marine Debris Disposal and Vessel Surrendering" with its own director and staff dedicated to helping keep the city's 520 miles of shorelines clean.
