Ms. Hack stated that the Committee received a re-zoning request for the property located at 190 83rd Avenue in Kew Gardens. Department of City Planning will ask the applicant to give a presentation to talk more about their proposal.

13. TRANSPORTATION & TRAFFIC COMMITTEE REPORT - Faiuze Ali, Chair, reported on the following:

- Queens Bus Redesign-the finalized plan for Queens County will be released in 2023.
- Governor Hochul's Plans for NYC Subway Safety \$5M were allocated, 200 cameras were already installed. More transit police officers and NYPD officers will be present in the subway.
- New Parking Mobile App will replace the one that expired. The app users will be charged 20 cents per usage.
- 1,500 Miles of Bike Lanes were created throughout all five boroughs. Some are protected with barriers and the rest are not. There were 36 incidents when bicyclists collided with vehicles in 2021. Three of the incidents that took place in the 102nd Pct. area had fatalities. Mayor Adams had allocated additional funds to install 300 more miles of bike lanes throughout the city.
- Speed Cameras are active 24/7. If a car is caught speeding by a speed camera, the motorist will be sent a Notice of Liability (NOL) in approximately 14 days. The fine is \$50.

14. PARKS, RECREATION & ENVIRONMENT COMMITTEE REPORT – J. Richard Smith, Chair

Chair Algredo stated that Senator Sanders has allocated \$750,000 to add exercise equipment to Phil Rizzuto Park.

15. BUDGET & FINANCE COMMITTEE REPORT – John Carter, Chair

Mr. Carter stated that aside from regular monthly expenditures, the board spent about \$3,300 for public outreach events.

E.J. Sydell stated that over \$2,300 have been raised since the beginning of the "Let's Light Up Kew Gardens" campaign and thanked all who donated.
