Chair Algredo gave a brief recap of Borough Board meeting presentations for the month of March.

She also mentioned that she received a call from the owner of Blend Restaurant to which she and the District Manager listened. It was regarding a letter sent from Senator Addabbo to the SLA. Chair Algredo informed the owner that the board is not able to change anything regarding the situation and it is now up the SLA to decide.

6. ELECTIONS OF OFFICERS

Maricela Cano, Director of Queens Community Boards, oversaw the elections.

Andrea Crawford nominated Sherry Algredo for Chairperson; Rabbi Daniel Pollack seconded it. Sherry Algredo ran unopposed. Vote: unanimous. Sherry Algredo is re-elected Chairperson.

Seth Welins nominated John Carter for Treasurer; Sherry Algredo seconded it. John Carter ran unopposed. Vote: Unanimous. John Carter is re-elected Treasurer.

7. PUBLIC FORUM

<u>Adam Dobrzynski, DSNY, Community Affairs</u>, spoke about the waste setout time change, which will be going in effect April 1. Residents who use containers with a secure lid should place it by the curb after 6 PM. Bags should be placed by the curb after 8 PM.

Businesses that place waste at the curb for collection have two options:

- If using a container with a secure lid, waste should be placed at the curb 1 hour before closing, or
- If putting bags directly on the curb, waste should be placed out after 8 PM.

The Queensway is a community-led effort to transform a 3.5 mile stretch of abandoned railway in Central Queens into a family-friendly linear park and cultural greenway.
