Chair Algredo started the meeting by recognizing The National Law Enforcement Appreciation Day and thanking the 102nd Pct. for their community outreach and engagement, and for protecting our community.

1. GREETINGS FROM ELECTED OFFICIALS

Council Member Ariola spoke about two bills that recently passed at the City Council: intro 0586 would require the NYPD to provide quarterly reports detailing information on level one, two, and three investigative encounters between the police and civilians.

The other bill 0549 would ban the use of solitary confinement in city jails. The bill would also provide individuals in custody of the Department of Correction due process protections prior to being placed in restrictive housing or continued use of restraints.

CM Ariola also mentioned that Council Member Lynn Schulman and herself are co-sponsoring Senator Comrie and Assembly Member Rajkumar's resolution in support for local authorities to have more power in closing illegal smoke shops.

Council Member answered Board Members' questions.

2. CHAIRPERSON'S REMARKS & EXEC. REPORT-Sherry Algredo DISTRICT MANAGER'S REPORT-James McClelland

Chair Algredo reported on the items that were discussed at the Borough Board meeting.

DM McClelland wished happy birthday to Juand Batista II, Stephen Esposito, and Cristal Rivera. He stated that Community Board Applications are due by February 16th.

A testimony regarding CB9 Budget requests and district needs will be provided on January 29th to Council members and Borough President's office regarding our Budget requests and district needs which we submitted to OMB in November.

Also, the Chair and the District Manager will be meeting with CB9 elected officials regarding capital projects.

The next district service cabinet meeting for all city agencies is scheduled for January 18th.

3. PUBLIC FORUM

<u>Bill Knight, Executive Director of Phil Rizzuto Park Organization</u>, gave a summary of activities and events their organization successfully coordinated in 2023.

<u>Pablo Rubio, Executive Director of Formativas Barcelona SC, NYC,</u> had asked for a follow up on his request from one month ago to illuminate the darkened Victory Field in Forest Park.

Mr. Saidi, Queens Resident, spoke about the need for better lighting in Forest Park.

4. HEALTH & SOCIAL SERVICES COMMITTEE REPORT – Carmela Isabella, Chair

Committee Chair Isabella stated that the following information was emailed to all board members:

- Common symptoms of a Cold, the Flu, and COVID-19.
- January is Thyroid and Cervical Cancer Prevention Month.
- The Homeless Outreach Population Estimate (HOPE) NYC Survey an annual survey conducted during the last 10 days in January to estimate the number of unsheltered individuals in New York City.

5. PARKS, RECREATION & ENVIRONMENT COMMITTEE REPORT - J. Richard Smith, Chair

Committee Chair Smith stated that at the last committee meeting they had a presentation from the executive director of New Yorkers for Parks regarding pushing for the mayor to commit to funding the city's parks at 1% of the city budget. This organization is also actively trying to stave off the massive budget cuts the mayor has proposed for parks.

6. NYPD 102nd Pct. Briefing

Captain Maldonado addressed the board and thanked Chair Algredo for expressing her condolences to PO Clifford's family. PO Clifford lost his life coming into work.

Capt. Maldonado stated that the 102nd Pct. finished the year strong with a decrease in all major crime categories, except for grand auto larceny, which increased not just at 102nd Pct. but citywide.

She asked for all to remain alert and continue to exercise caution.

Question and answer period followed.
