2. Guest Speaker, Council Member Robert Holden discussed his stance on Rikers Island. Councilman Holden opposes the plan to close Rikers Island and build borough jails such as the one proposed for Kew Gardens.

Holden has introduced legislation in the City Council to create a commission to study the cost of renovating/modernizing Rikers Island. The Lippman Commission failed to study/address the question of how much it would cost to renovate Rikers Island in comparison to the borough based jails. Holden feels that while we have this debate over closing Rikers Island it's very important that the public has all the facts and number. The cost to renovate Rikers Island would be far less than the cost of building borough based jails.

Other objections to the building of a jail in Kew Gardens include traffic and congestion. The area by Borough Hall and the courts on Queens Blvd is already congested with limited parking. If a 30 story jail was also built there, there would be the added traffic and congestion of transport vehicles, police, visitors, and correction officers/employees. Additionally, Rikers Island currently has many levels of security. It's very difficult to get on and off the island. If someone were to try to escape, there's the river surrounding the island. At a facility like Kew Gardens, there wouldn't be as much space for the many levels of fencing/security needed. If someone were to escape, they'd immediately be in a neighborhood.

Assembly Member Michael Miller addressed the board stating the following:

- He is opposed to Community Board Members' term limits.
- A Protest Rally against opening a homeless shelter for 113 mentally ill homeless adult single men at Ozone Park location took place yesterday at 101st Ave.
- Trying to work with Breaking Ground and address the issue of homeless people hanging out on Forest Parkway.
- Will host a Veterans Breakfast Event on Tuesday, September 18, 2018 at 10 a.m. at Oakridge.
- Electronic Recycling Event, co-sponsored by Senator Addabbo, will take place on Sunday, September 23rd, 2018 at Forest Park Bandshell.
- Annual Hispanic Heritage Awards Night will take place at Woodhaven American Legion Post 118, 89-02 91st Street at 6:00 p.m. on October 3, 2018.

3. Public Forum

Mk Moore, Richmond Hill Resident, stated that he is in favor of The NYC Charter Revision Commission's Proposal on term limits for community board members. In his opinion, it will create opportunities for new voices and leaders on all community boards.

<u>Philicia Chandipersaud, Tilt Lounge Corp., Owner/President,</u> spoke about her request to CB9 Public Safety Committee to amend a request of a 1 AM stipulation to stop serving alcohol.

<u>Chris Stratton, Tilt Lounge Corp.</u>, spoke in support of the request to amend a 1 AM stipulation for Tilt Lounge Corp., 131-15 Jamaica Ave.

Ruby Martin, Richmond Hill Resident, spoke in favor of Tilt Lounge being opened and serving alcohol until 4 a.m.

Priya Khan, Richmond Hill Resident, spoke in favor of Tilt Lounge being opened and serving alcohol until 4 a m

Aaron Baksh, SMS Deli, stated that the Tilt Lunge should be opened until 4 a.m. as it will boost his business.

<u>Murray Berger, KGCA</u>, stated that no merchants or residents of Kew Gardens were ever consulted by the City regarding the Mayor's proposal for a jail in Kew Gardens despite contrary allegations by the city in their press releases.

5. Monthly Update Report 102 Pct.

Police Officer Jose Severino stated the following:

- 102nd Pct. NCO Roll Out started in July of this year. All NCOs will attend the October CB9 meeting.
- The crime stats are down 25% year to date.
- There was a burglary pattern of one individual going through rear windows and back doors and checking if they are locked.
- Tauros Bar & Restaurant, located at 108-02 Jamaica Ave, has been one of Precinct's most problematic bars over the last couple of months. The precinct has had successful underage operations there. The location has had robberies, assaults and grand larcenies. The precinct is also working with NYPD Legal Division to nuisance abate them which should happen soon.

6. Chairperson's Remarks & Exec. Report – J. Richard Smith

1st Vice Chair Rampershad thanked Mr. George Russo for hosting the meeting tonight and expressed his condolences to the Russo family for the passing of their son.

He also extended condolences to Ivan Mrakovcic for the passing of his father.

Mr. Rampershad thanked former District Manager Lisa Gomes for her 20 plus years of service, and wished

her a happy retirement.

Chair Smith will be giving an update to the board regarding the next steps that will be taken in the DM search and hiring process.

7. Guest Speaker, Alexander Kipp from the NYC Conflicts Interest Board (COIB)

Mr. Kipp spoke about basic line standards for how the City's public servants, including community board member, should deal with conflicts between their public duties and private interests. He gave a presentation on basic training in the Conflicts of Interest Law.

A copy of the Conflict of Interest booklet was given to each board member.

Senator Joe Addabbo addressed the board stating the following:

- He is against the opening of homeless shelters for mentally ill people in residential sites due to close proximity to several community schools.
- Public safety issues were addressed at the Rally against opening of a homeless shelter in Ozone Park took place yesterday on 101st Ave.
