<p><b>Job Description</b></p> <p>The Department of Records and Information Services is seeking to hire a Procurement Analyst to work in the Administration division.</p> <p>The duties for this position will include but are limited to:</p> <p><b>Purchasing &amp; Payments:</b></p> <ul style="list-style-type: none"><li>Preparing procurement documentation for the agency including purchase requisitions, memos, and personal expense reimbursement.</li><li>Processing payments for all accounts payable.</li><li>Updating of Trust &amp; Agency accounts, processing purchases and royalties for these accounts.</li><li>Utilizing FMS reports to monitor payments and spending.</li></ul> <p><b>Contracts:</b></p> <ul style="list-style-type: none"><li>Preparing bid and/or pre solicitation review documents;</li><li>Obtaining the necessary market and/or vendor data in support of bid preparation;</li><li>Participating in the review, tabulation, and the analysis of bids;</li><li>Participating in on-site inspections as necessary.</li><li>Tracking and reporting the status of all pending contracts to the supervisor on a routine basis.</li><li>Notifying supervisor of potential problems and offering potential solutions.</li><li>Establishing and maintaining contracting cycles and ensuring there is no gap in contracted services.</li><li>Maintaining and augmenting database of Division registered contracts when necessary and appropriate.</li><li>Monitoring and ensuring divisional compliance with the contracting process as directed by ACCO.</li></ul> <p>This position is open to permanent Procurement Analyst or candidates reachable on the current civil service list.</p>	
<p><b>Minimum Qualification Requirements</b></p> <p>1. A baccalaureate degree from an accredited college and six months of satisfactory full-time professional experience in procurement of goods, services, construction, or construction-related services, or professional, technical or administrative experience in contract negotiation/management; or</p> <p>2. An associate degree or completion of 60 semester credits from an accredited college, and 18 months of satisfactory, full-time professional experience as described in 1 above; or</p> <p>3. A four-year high school diploma or its educational equivalent and two and one-half years of satisfactory full time professional experience as described in 1 above; or</p> <p>4. A combination of education and/or experience equivalent to 1, 2, or 3 above. College education may be substituted for professional experience under 2 or 3 above at the rate of 30 semester credits from an accredited college for 6 months of experience. However, all candidates must have at least a four year high school diploma or its educational equivalent and 6 months of the experience described in 1 above.</p> <p>SPECIAL NOTES:</p> <p>To be eligible for placement in Assignment Level II, individuals must have, after meeting the minimum requirements, either one year served at Assignment Level I or one additional year of the experience described in "1" above.</p> <p>To be eligible for placement in Assignment Level III, individuals must have, after meeting the minimum requirements, either one year served at Assignment Level II or two additional years of the experience described in "1" above, at least one year of which must have been supervisory, or spent performing professional procurement duties equivalent to those performed at Assignment Level III.</p>
