1 PROCEEDINGS 2 MS. AHMED: Good morning. Today is 3 September 28, 2023. The time is 11:01 a.m. Welcome to the New York City 4 5 Department of Small Business Services virtual hearing. 6 7 This public hearing is being held in accordance with the New York City 8 9 Administrative Procedure Act, also known as "CAPA". My name is Shormina Ahmed. 10 I am Associate General Counsel at SBS. 11 12 Today's hearing concerns the proposed rule amendment to Chapter of 10 13 of Title 66 of the Rules of the City of 14 New York. The full text of the rule 15 16 proposal, and a statement of the basis 17 and purpose, were published in The City Record on August 24, 2023 and on the New 18 19 York City Rules website. 20 The proposed rule concerns the City's program for the promotion of 21 22 equal employment opportunity in 23 contracts awarded by the City. This was 24 published to ensure that City 25 contractors comply with equal employment

1 opportunity requirements of city, state, and federal law. 2 3 The program requires that contractors doing business with the City 4 5 submit an Employment Report to the Division of Labor Services, the 6 7 "Division", a division of SBS. 8 An Employment Report is a report 9 that outlines a contractor's employment practices and related information so the 10 City can ensure the contractor is 11 12 promoting equal employment 13 opportunities. Contractors are required 14 to submit an Employment Report for each 15 covered contract awarded to them. 16 After review of an Employment 17 Report, and any other required documentation, the Division issues a 18 19 certificate of compliance to contractors 20 found in compliance with equal employment opportunity requirements. 21 2.2 The proposed rule would amend the 23 process by which the City monitors 24 compliance and enforces contractor 25 compliance with equal employment

opportunity requirements set forth in the Appendix to Chapter 10 of Title 66 of the Rules. 5

Specifically, the proposed rule will 4 amend Section 10-03 to extend the time 5 from 12 months to 36 months, that a 6 7 valid certificate of compliance for covered supply and service contract may 8 9 be used to exempt the contractor from the requirement to submit an Employment 10 Report; and then Section 10-05, to give 11 12 the Division discretion in deciding when to hold pre-award conferences for 13 14 contracts for which an Employment Report is requires; and then Section 10-07 to 15 16 allow the Division, when providing 17 notice to a contractor that it has 18 failed to file or complete an Employment 19 Report, or has filed an Employment 20 Report with substantial 21 misrepresentation, that these notices be 22 provided by email; and then various 23 sections of Chapter 10 to update 24 references to EO 50, 50 which is 25 published in the Appendix to Chapter 10,

1 and remove a reference to the Board of 2 Estimates. This summarizes the amendment. 3 At this time, we will allow members 4 5 of the public to testify and provide their comments. 6 7 We have not received any requests to 8 comment today, so if anybody who is 9 present here and would like to testify, can do so by raising (sic) the raise 10 hand feature or un-muting themselves and 11 stating their name and affiliation. 12 13 Is there anyone who wishes to testify today? 14 15 (No response.) 16 MS. I will pause the record at this 10 time. 11 12 (Recess taken.) 13 MS. AHMED: Is there anyone who 14 wishes to testify? 15 (No response.) 16 MS. AHMED: Can everyone hear me? 17 THE COURT REPORTER: Yes. MS. AHMED: Okay. Thank you, Madam 18 19 Reporter for confirming. 20 (Recess taken.) 21 MS.
