Multi-Agency Response to Community Hotspots (M.A.R.C.H.) Operations

Introduction

During the 1990s, Mayor Rudy Giuliani initiated a new enforcement protocol for New York City nightlife establishments—which include bars, restaurants, music and dance clubs—the Multi-Agency Response to Community Hotspots program, commonly known as M.A.R.C.H.

M.A.R.C.H. is a multi-agency operation, led by the New York City Police Department (NYPD) and supported by inspectors from the NYC Fire Department (FDNY), NYC Department of Buildings (DOB), NYC Department of Environmental Protection (DEP), NYC Department of Health and Mental Hygiene (DOHMH), and the NY State Liquor Authority to conduct unannounced inspections at nightlife establishments. M.A.R.C.H. operations are usually requested by a local NYPD precinct to address incidents and complaints pertaining to a nightlife establishment, and inspections are typically conducted on Friday and Saturday evenings during peak business hours. M.A.R.C.H. operations historically visit between three to six nightlife venues for inspections on a given night, inspecting establishments located within the same precinct or a neighboring precinct.

About this report

In 2019, the NYC Council passed Local Law 220 (2019), requiring the Office of Nightlife at the NYC Mayor's Office of Media and Entertainment to publish a semi-annual report of M.A.R.C.H. operations beginning with the first half of 2020. Due to the multi-agency nature of the inspections, there have historically not been comprehensive records on these operations. The Office of Nightlife undertakes this reporting responsibility with great care to provide information about a subject that is of significant interest and importance to so many New Yorkers. We hope this report will inform the conversation about M.A.R.C.H. operations.

Local Law 220 also requires that beginning April 1, 2020, nightlife establishments must receive written notification at least 30 days prior to any M.A.R.C.H. inspection, with an opportunity to rectify the precipitating condition and potentially avoid a M.A.R.C.H, unless such notice would "compromise an active criminal investigation" or would pose a "serious risk...to health and safety."

This report has been compiled by the Office of Nightlife, working with the participating City agencies to create a centralized data reporting system to provide information about their participation in M.A.R.C.H. operations. The report provides detail on the conditions that led to a request for a M.A.R.C.H., and their frequency, locations, and results, which include: the number of inspectors present, the average duration of inspections, and any summonses or closure orders that were made during the inspection. The data from this report will help us understand patterns of nightlife enforcement and identify potential ways to improve and rethink enforcement practices.

This report also includes information about scheduled M.A.R.C.H. operations for which City agencies reported that inspections were scheduled to occur, but which ultimately did not take place on that night or at another point during this reporting period. A M.A.R.C.H. may not take place if the establishment is closed at the time inspectors arrive, if the inspectors run out of time for the night, if the officers need to attend to other issues in the precinct, or other similar reasons. Those establishments are presented to help provide a full picture of the conduct and complaints that lead to a request for M.A.R.C.H. operations, but they do not factor into the overall data calculations, since no inspections occurred.

This report covers the period from January 1 through June 30, 2020. However, due to the Covid-19 pandemic and the continuing restrictions on indoor activity in nightlife establishments, no M.A.R.C.H. operations were conducted in the months of April, May, or June. As a result, the data presented in this report is not representative of normal operations, due to the unusual circumstances of the Covid-19 crisis. This first report is just the beginning, and the Office of Nightlife will continue to compile and release semi-annual reports on M.A.R.C.H. operations so that New Yorkers have an accurate picture of what is happening.

Executive Summary

In the first half of 2020, there were twenty-three (23) M.A.R.C.H. inspections performed by City agencies. Twenty-three (23) establishments were visited, with each establishment receiving one (1) M.A.R.C.H. inspection within the time period. The average duration of each inspection was ninety-eight (98) minutes and the median duration of each inspection was one hundred (100) minutes.

Of the 23 inspections,

- Eight (8) took place in the Bronx,
- Nine (9) took place in Queens,
- Three (3) took place in Manhattan,
- One (1) took place in Brooklyn, and
- Two (2) took place on Staten Island.

During the course of the inspections, the total number of City inspectors present at each inspection averaged 17, with a median of 17. The average number of inspectors present from each City agency was as follows:

- 1.5 inspectors from DEP
- 1.5 inspectors from DOB
- 2.1 inspectors from DOHMH
- 1.0 inspectors from FDNY
- 11.2 inspectors from NYPD


A total of one hundred and twenty (120) summonses were issued to businesses as a result of this period's M.A.R.C.H operations.

Of the 120 summonses,

- Two (2) were issued by DEP,
- Eight (8) were issued by the DOB,
- Seventy-nine (79) were issued by the DOHMH.
- Seven (7) were issued by FDNY, and
- Twenty-four (24) were issued by NYPD.

One (1) establishment was ordered to temporarily shut down their operations due to findings of the operation. The length of that closure was 135 minutes.


Of the 9 operations,

- One (1) took place in the Bronx,
- Three (3) took place in Manhattan,
- Zero (0) took place in Brooklyn,
- Three (3) took place in Queens, and
- Two (2) took place on Staten Island.

Additionally, two (2) M.A.R.C.H. inspections were requested and scheduled to take place but were not conducted.




In March 2020, there were six (6) M.A.R.C.H. operations performed by City agencies at six (6) establishments, with no establishments ordered to close at the time of the visit.
