

Small businesses are at the cornerstone of New York City's recovery — fueling job creation, neighborhood vitality, and our city's dynamic culture. Thanks to their passion, resiliency, and ingenuity, our city set a historic record this year with the most jobs ever: 4.7 million. New York City is back!

At the Department of Small Business Services (SBS), this year also marks the  $10^{\rm th}$  anniversary of the Worker Cooperative Business Development Initiative which supports the development and growth of businesses where workers have a direct role in all business decisions, fostering a model of democratic innovation that has driven our economic comeback.

The following report outlines the impact SBS and our strong network of partners made in Fiscal Year 2023, the ninth year of the program. Notably, many new worker cooperatives are led by women, immigrants, and people of color, including NYC's first-ever worker cooperative African language services provider and our city's first-ever worker cooperative cocktail bar.

## THE WORKER COOPERATIVE

# BUSINESS DEVELOPMENT INITIATIVE (WCBDI)

In partnership with the NYC Council and the Office of the Mayor, New York City agencies are working to build a more vibrant and inclusive city. The NYC Department of Small Business Services (SBS) contributes to this vision by connecting New Yorkers to good jobs, creating stronger businesses, and building thriving neighborhoods across the five boroughs.

**Worker cooperatives** — businesses that are owned and controlled by their workers — are an effective tool to achieve this mission, particularly for people who lack access to traditional business ownership. They give New Yorkers the opportunity to co-own a business, creating sustainable and dignified jobs while developing community wealth, particularly for people who lack access to traditional business ownership. Worker cooperatives are also run on democratic principles, giving New Yorkers the opportunity to practice democracy daily in their workplace.

The Mayor and the NYC Council launched the Worker Cooperative Business Development Initiative (WCBDI) in Fiscal Year 2015 (FY15) to support the positive impact worker cooperatives have on New York City. WCBDI was created to strengthen the existing ecosystem of cooperative developers in NYC, promote the creation of new cooperatives, and grow existing cooperatives. Mayor Eric Adams' administration continues to support this work to "Rebuild, Renew, and Reinvent" NYC's economy.

Fiscal Year 2023 (FY23) marks the ninth year of the initiative. From the beginning, the WCBDI partners have supported the launch and development of worker cooperatives. SBS supported WCBDI throughout the year by collecting and analyzing program metrics, holding quarterly meetings, sharing up-to-date information on city resources, and connecting WCBDI partners to other city agencies. SBS also continued discussions with WCBDI partners to identify barriers and possible solutions to increase public contracting for worker cooperatives.

This is the ninth annual report in the "Working Together" series that highlights the achievements of this initiative. SBS is committed to helping worker cooperatives thrive in New York City and is proud to showcase the work of WCBDI throughout the past fiscal year.

## FY23 ACCOMPLISHMENTS

## **MEASURING OUR SUCCESS**

The cumulative outcomes listed here were reported by 12 WCBDI partners and summarize the activities conducted in the initiative's ninth year. WCBDI partners received a total of \$3.768 million in FY2023.

The WCBDI measures its success using four metrics on worker cooperative development:

WORKER COOPERATIVES IN THE PIPELINE

A worker cooperative is a business owned and managed by its workers. In contrast to traditional companies, profits from worker cooperatives are distributed among "worker-members," who make governance decisions using democratic principles on a one-member, one-vote basis.

WCBDI encourages both the creation of worker cooperatives and the conversion of traditional businesses into cooperatives through specialized trainings and one-on-one services. Since creating a cooperative takes significant time and resources, WCBDI partners often work with worker-members for several years to either incubate or convert their business into a cooperative. During this time, prospective cooperatives receive business planning, market research, financial planning, access to capital, governance support, legal services, and many other forms of assistance to establish the business and organizational viability of each worker cooperative.

In FY23, WCBDI partners helped 18 new worker cooperatives formally launch by helping them acquire a federal tax ID, formation documents, appropriate licenses and permits, and register as a New York State sales tax vendor when applicable.

WCBDI partners also assisted 16 worker cooperatives "in the pipeline" who are in the process of forming or conversion. These worker cooperatives did not fully complete the formal launch steps listed above but are in the process of registering their business and finding an appropriate legal structure. These businesses have tentatively determined their name, industry, and number of worker-members and non-member workers.



98 TOTAL HIRES A worker-member is a person who owns a share of the worker cooperative, is a beneficiary of a trust, or controls the cooperative with other worker-members. A non-member worker is anyone who works for a worker cooperative but is not a worker-member. WCBDI helps worker cooperatives take on new worker-members and/or non-member workers through capacity-building services. Adding new worker-members to an existing business can be a long process but encourages personal investment in the success of the business.

This metric represents the total number of jobs created by WCBDI-supported cooperatives in FY23 and reflects employment of worker-members and non-member workers.

WCBDI partner organizations provide one-on-one, specialized services focused on worker cooperative development to entrepreneurs planning to become worker cooperatives, businesses interested in converting to cooperatives, and existing worker cooperatives. These services cover a range of topics including bookkeeping, business plan development, financial planning, governance, marketing and market research, strategic planning, succession planning, and translation. One-on-one services allow cooperatives to continue growing and providing sustainable jobs for worker-members.

At the same time, WCBDI partners help other community-based organizations in New York City that provide business development services extend those services to worker cooperatives in their communities. These partnerships allow WCBDI to extend its impact and further strengthen New York City's worker cooperative ecosystem.



**2711**EDUCATIONAL SERVICES PROVIDED

WCBDI hosts workshops, intensive academies, and networking events for current and prospective cooperative members. Educational services provided by WCBDI can be standalone workshops for anyone to attend, or a curriculum-based series of trainings that require an application. Events cover a wide range of business and cooperative management topics, such as bookkeeping, legal entity choice, computer skills, democratic decision making, and conflict resolution. Others aim to connect workermembers and cooperative developers with their communities to teach them about the cooperative model.

This metric represents the number of individuals who were involved in a series of curriculumbased workshops, conferences, lectures, and group trainings hosted by WCBDI in FY23.

Canter for Family Life in Sunset Park seeks to promote positive outcomes for children, adults, and families in the low-income immigrant neighborhood of Sunset Park through the provision of neighborhood-based family and social services, including cooperative business development, family counseling, school-based programs, youth employment, adult employment, and other community services.

CUNY School of Law's Community & Economic Development (CED)
Clinic partners with community-led organizations to address structural inequalities in New York City through transactional representation, strategic litigation, community legal education, and policy reform.

# DEMOCRACY AT WORK INSTITUTE (DAWI)

Created by the U.S. Federation of Worker Cooperatives, the Democracy at Work Institute is a national organization that provides technical, financial, business development, and educational assistance to nonprofits that assist in the development of worker cooperatives as well as the worker cooperatives themselves.

# GREEN WORKER COOPERATIVES (GWC)

Green Worker Cooperatives provides technical assistance and training to prospective and current worker cooperatives through a Co-op Academy, an intensive five-month long training and support program that helps teams of aspiring entrepreneurs develop worker-owned green businesses.

## THE ICA GROUP (ICA)

The ICA Group is the oldest national organization dedicated to the development of worker cooperatives in the United States. ICA provides business development, strategic analysis, and industry-focused support for businesses interested in employee ownership.

## NEW YORK CITY NETWORK OF WORKER COOPERATIVES (NYC NOWC)

The NYC Network of Worker Cooperatives (NYC NOWC), the trade association for New York City's worker cooperatives, is dedicated to sharing and cultivating the educational, financial, and technical resources of its members and supporting the growth of worker cooperatives for social and economic justice. NYC NOWC helps existing and new worker cooperatives in all communities within the New York City metropolitan area, with a focus on the development of cooperatives within marginalized communities. They offer programming, a basic training series, technical assistance, and limited financial support, as well as an initial consultation for those who want further support from other partners. NYC NOWC also advocates on behalf of New York City's worker cooperatives and hosts the annual NYC Worker Cooperative Assembly.

## TAKEROOT JUSTICE

TakeRoot Justice provides legal, participatory research, and policy support to strengthen the work of grassroots and community-based groups in New York City to dismantle racial, economic, and social oppression.

## THE WORKING WORLD (TWW)

The Working World provides nonextractive loans, financial education, and technical assistance specifically designed for worker cooperatives, building wealth in low-income communities.

## **URBAN UPBOUND (UU)**

Urban Upbound is dedicated to breaking cycles of poverty in New York City public housing and other low-income neighborhoods. They provide underserved youth and adults with the tools and resources needed to achieve economic prosperity and self-sufficiency through five comprehensive, integrated programs: Employment Services, Financial Counseling, Income Support Services, Community Revitalization, and Financial Inclusion services anchored by the Urban Upbound Federal Credit Union.

# WORKERS JUSTICE PROJECT (WJP)

Workers Justice Project (WJP) is a community-based organization that promotes social, economic, and political conditions of low-wage workers and immigrant families in New York City. WJP runs a worker cooperative development program that provides training and technical assistance to low-wage workers that are venturing in building worker-owned cooperatives.

# **WORKER COOPERATIVES CREATED**

WCBDI creates worker cooperatives through academies, incubation, and conversion. This section of the report highlights some success stories about worker cooperatives that were created in FY23. Worker cooperatives in the pipeline in this fiscal year are expected to formally launch in the following fiscal year (FY24).

AfriLingual LLC launched on August 31, 2023, as the first African language services worker-owned cooperative that provides language support through interpretation, translation, and language instruction to empower African communities in need.

TakeRoot Justice was connected with AfriLingual LLC through African Communities Together, their partner organization that works with other teams at TakeRoot.

They supported a group of 10 interpreters and translators in creating a language services cooperative. TakeRoot supported the co-op through entity options counseling, incorporation, drafting and adopting a governance document, and obtaining an EIN.



## **UNITED COMMUNITY CONSULTING LLC**

**BOROUGH** Brooklyn

United Community Consulting LLC (UCC) is an immigrant worker-owned cooperative business recently incubated by the Center for Family Life (CFL) in Brooklyn. The group specializes in community outreach initiatives that engage community members within the neighborhoods of New York City. They proved to be an essential partner to CFL in the rollout of the Promise NYC initiative launched by the NYC Administration for Children's Services (ACS). Through this initiative, the group engaged more than 300 families with undocumented children who could qualify for the daycare vouchers that the City offered to families throughout Brooklyn. UCC was the key to the success of the initiative, serving as trusted and credible messengers to inform and engage the immigrant community.

Since then, they have provided consultations to other not-forprofit organizations, including hospital systems and human services providers who seek to engage local communities in their programs. UCC has also co-led the Community Study Circles 96

program, with CFL as a project partner. This project, funded by the Prevent Child Abuse America Foundation with support from the Annie E. Casey Foundation, provides groups of neighborhood residents with a guided curriculum to explore community needs and to engage in data driven advocacy with elected officials and City agencies. UCC co-created the curriculum for this initiative and has led the presentations to elected officials, other advocates, and government agencies.

UCC members were honored to receive a citation by NYC Council Member Alexa Aviles in celebration of Women's History Month and in recognition of their extraordinary dedication and service to the community.









# **TOTAL HIRES**

WCBDI helps newly created, converted, and/or existing worker cooperatives get new worker-members and/or non-member workers. WCBDI helped cooperatives hire 98 new workers in FY23. This section of the report highlights a success story about a cooperative that was able to grow in FY23.



**BOROUGH** Brooklyn

Up & Go is an online booking and payment platform for worker-owned cleaning cooperatives. The platform is owned and run by six cooperatives that received technical assistance from Center for Family Life (CFL).

In Spring 2023, four of the cooperatives from Up & Go held a joint open house to recruit new members. They began a candidacy period of initial training from partners including CFL. Following the training period, the cohort of new worker-owners (15 in total) signed their respective cooperatives' operating agreements, and began working and accepting jobs through Up & Go. This was the first time that multiple Up & Go cooperatives collaborated to collectively recruit new members, and proved to be a successful strategy for growth across the cooperatives.

# ONE-ON-ONE SERVICES PROVIDED

WCBDI provides specialized one-on-one services to business entities and community-based organizations to strengthen the city's worker cooperative ecosystem. These one-on-one services focus on worker cooperative development. Technical assistance is critical to the success of new and established cooperatives, helping mitigate risk for cooperative worker-members and the institutions that invest in them. In FY23, WCBDI provided 1684 one-on-one services to 62 unique entities.

This section of the report highlights some success stories for one-on-one services provided by WCBDI partners.



## **BIO-CLASSIC CLEANING**

**ASSISTING WCBDI PARTNER** | Bronx Cooperative Development Initiative (BCDI)

**BOROUGH** | Bronx

Bio-Classic Cleaning is a worker-owned cleaning service, but they faced challenges with administrative tasks and marketing.

Bronx Cooperative Development Initiative (BCDI) helped Bio-Classic Cleaning address these challenges by helping them secure an annual cleaning contract this year worth more than \$100,000. BCDI also went through the administrative and marketing process step by step with them, which allowed them to obtain hands-on experience on what it takes to successfully secure, service, and see through an annual contract that provides financial stability to the cooperative and its members.

## RR

Being a worker-owner in Bio-Classic Cleaning has changed my life because it allows me to determine my work schedule. This, in turn, allows me to take on my family responsibilities, from taking my kids to school to picking them up. If I were an employee at a company, I would have to work 9 a.m. - 5 p.m., which wouldn't allow me to handle my family responsibilities as a mother. This is important because I get to spend time with my kids."

## DONNA COCKTAIL CLUB

ASSISTING WCBDI PARTNER | The Working World (TWW)

**BOROUGH** | Manhattan

Donna Cocktail Club was a bar and neighborhood institution in Williamsburg, Brooklyn. When they lost their lease and were forced to close in 2020 due to the pandemic, owner Lief Huckman contacted The Working World (TWW) with a radical idea — to reopen Donna as a worker-owned cooperative. During FY22, TWW provided technical assistance to Donna's employees as they formed a cooperative, took ownership of the company, and ran several successful pop-ups.

In FY23, TWW continued to support the Donna Cocktail Club with strategic planning services and financial assistance in the form of a non-extractive loan, which allowed the cooperative to secure and remodel a new brick-and-mortar location in the West Village. In May 2023, Donna Cocktail Club relaunched as NYC's first worker cooperative cocktail bar, and has been featured in *Time Out, Thrillist, Eater,* and the New York Times as one of the most anticipated bar openings of the year.











# EDUCATIONAL SERVICES PROVIDED

WCBDI offers workshops and events open to the public, as well as intensive trainings specifically meant for prospective and/or current worker cooperatives. Educational services provided by WCBDI can be standalone workshops for anyone to attend, or a curriculum-based series of trainings that require an application.

AfriLingual is NYC's first African Language Services worker co-op that provides interpretation and translation services in many African languages, including French and Arabic. The co-op faced many challenges due to the lack of funding, but thanks to WCBDI's grant and the NYC Council language access grant, WCBDI partners were able to offer many trainings and workshops to equip the co-op members with skills that helped them successfully run their business.

OSHA Solutions, incubated and subcontracted by Urban Upbound (UU), stands as a remarkable success story within the NYC cooperative movement. Through their joint efforts, which encompass logistics management, hosting in-person classes, and the distribution of OSHA cards, they have successfully made critical health and safety training accessible to newcomers in the city, directly addressing the urgent needs of migrants during the ongoing crisis. The transition to in-person classes acknowledges

the resource limitations faced by New York's migrant workers, simplifying their access to essential training.

The unwavering dedication of UU staff, who generously contribute their weekends to ensure the seamless operation of OSHA Solutions, managing all administrative tasks from collecting and printing to handling sign-in sheets, IDs, and card registration within the NYC Department of Buildings (DOB) system, remains integral to this achievement. While these services may not align neatly with standard metrics such as technical assistance or education, they prove indispensable in providing migrant workers with a foothold in the workforce, epitomizing the cooperative spirit in our commitment to empower under-resourced communities and foster upward mobility.

# **LOOKING FORWARD**

FY24 marks the 10-year anniversary of the WCBDI program. Over the last decade, the WCBDI program has continued to grow the network of worker cooperatives in the city. As a result, New York City has the most worker cooperatives than any other major city in the US. To celebrate the 10-year anniversary of the program, SBS plans to raise awareness of the impact of the program through different workshops and events in collaboration with all the partners in the program. Additionally, the NYC Council awarded \$3.768 million to WCBDI in FY24 to support worker cooperatives and invest in worker ownership. This funding supports 13 partner organizations and provides centralized program management through SBS.
