NOTICE OF FILING

NEW YORK CITY SCHOOL CONSTRUCTION AUTHORITY

Pursuant to §1731 of the New York City School Construction Authority Act, notice has been filed for the proposed site selection of all or portions of Block 10, Lot 1 and any other nearby sites for the construction of a new, approximately 801-seat high school facility with a D75 program in Staten Island.

The proposed site is located at 25 Wall Street on the north side of Wall Street, between Academy Place and Stuyvesant Place in the St. George neighborhood of Staten Island. The site is currently occupied by a paved parking lot. The proposed site to be acquired by the New York City School Construction Authority, on behalf of the New York City Department of Education, is an approximately 46,096 square foot (1.06 acre) lot.

SCA Public Process for Site Selection

SCA is required to present school real estate sites to the local Community Board and Community Education Council before moving forward

A 45-day public comment period on the sites commenced 09/30/25 and ends 11/19/25– formal comments can be shared through mail and email

Seat Need & Proposed Site


The School Construction Authority is proposing to build a new, approximately 801-seat high school

The proposed site is 46,096 square foot (1.06 acre)

Process includes environmental review and engagement with City agencies, such as DOT, DEP, and FDNY before going to the City Council for final approval
