Public Session

Ms. Barbara Sanchez spoke of Savo Brothers challenging the Borough President's names of the streets that he had given.

Ilya Geller spoke of the Peace Action Presidential Primary Town Hall Meeting is holding a Presidential Primaries Forum on Thursday, April 14th - 6:30 pm to 8:30 pm at the Unitarian Church of Staten Island, 312 Fillmore Street (at Clinton Ave, in New Brighton, near Snug Harbor).

Peter Lisa spoke of a free workshop to create a fundraising plan and increase funding streams. This will help organizations become more sustainable. The workshop is on May 4, 2016 - 6-8 Gerald Carter Center 230 Broad Street.

Mr. Jermaine Williams, Human Resources Administration spoke of Mayor Deblasio's revising DHS's open-ended RFP for new shelters to instead seek proposals for new housing models that combine affordable permanent housing with transitional housing and community space. Under this model, shelter residents will receive services including rapid rehousing.

Deploying HRA staff as a "rapid rehousing team" to promote shelter move-outs from family shelters to permanent housing to help decrease reliance on cluster units. The required headcount for this initiative is included in the January Plan. Experience has shown that households with rental assistance vouchers are more successful finding housing if they have support in their search.

A Certificate of Recognition was given to Rev. Dr. Demetrius Carolina of First Central Baptist Church for his outstanding work he does with the True 2 Life – a cure violence program.

Amoy Barnes, Parks Department gave an update on the Stapleton Playground.

A long discussion was held on projects and repairs to parks. There were questions as to why an entire park needs to be rehabilitated if a few things need to be fixed in the park etc.
