#### **Liquor License Applications:**

Project Brunch – New License

The applicant worked with the owner of Nucci's for 19 years. Nucci's is now gone and the present owner is required to get his own license for the premises now known as Project Brunch. The owner is also asking CB#1 to write a letter to the State Liquor Authority for a 30 day waiver and a temporary license before the new license is given.

There was a problem on St. Patrick's Day with unruly behavior on the premises. There is a photograph of the bartender pouring the contents of a liquor bottle down a woman's throat at the bar (probably contrived). There was an objection to giving CB#1's approval for granting a liquor license based on this. It is suggested that this photograph be sent to the State Liquor Authority with the request for approval of this license.

The vote was taken to recommend the approval of CB#1 sending a letter of approval for granting a liquor license for Project Brunch. All votes but one were to send the letter. There was a vote not to send the picture with the letter of approval for the liquor license to the State Liquor Authority. The vote regarding the 30 day waiver was denied.

Project Brunch will have the following conditions: Serve alcohol until 11:00 pm, close at 12 midnight.

Music will be played only indoors within the premises, not outside.

Each ferry has to have its own separate license.

Discussion on whether it's legal to take alcohol purchased on the premises on the rest of the ferry. It is a policy not to do this although it is not illegal.

#### 22 Van Street - New West Brighton

Conversion of a 3-story frame structure in a non-conforming residential M1 Zone to an office building.

Work done will include: A new exterior, new lighting, new electric, interior and exterior. New exit signs, emergency exits, sprinkler system, new stairs.

A one-story warehouse on the premises will not be changed.

22 Van Street: a 3-story frame house, was originally built as a residence in the last century.

Approved 8-0-0.

Motion proposed by Transportation Committee (see Board agenda):

'That CB1 send a letter to the NY State legislature supporting the bill to authorize Design-Build for New York City projects.'

Argument: Design-Build will speed up the enormous time-lags in completing transportation projects in New York City, e.g., bridges, ferries, ferry terminal resiliency, etc., and bring New York City in conformity with the rest of New York State. There will be no adverse effect on the City's Project Labor Agreements.

#### 3. Express and Local Bus improvement

Members of the Transportation Committee attended the MTA NYC Transit Express Bus Open House on Thursday, March 22nd.


The MTA initial proposal has been adapted under public comment since its original presentation in Fall 2017 (e.g., buses will continue to make a loop in the World Financial Center), but the changes still cut Express Bus time wandering Manhattan and Staten Island, to make more / quicker service on the express part.

Actual routes have now been proposed (after public input). No schedules yet. So no estimate yet of savings in traffic time to be ploughed back into more service.

Implementation possible by August 2018.

No announcement on the local bus component of the study. But a hint from the inside that some work has been done already.
