Mr. Nathaniel Dizkey and Beltina Serfot, both from the Department of Mental Health and Hygiene explained that there is a notice of intent Application No. N 140186 PXR. The proposed acquisition of approximately 13,000 square feet of office space at 135 Canal Street is for the consolidation of two Staten Island Offices. The DOHMH plans to relinquish a City-owned building at 51 Stuyvesant Place and vacate space it currently leases at 2971 Hylan Blvd.

There will be approximately 39 full-time DOHMH personnel on site and approximately 50 visitors per day. The office will be open from 9:00 A.M. – 5:00 P.M. Monday through Friday.

There will be six different units operating out of 135 Canal Street; appointments are suggested for most of the services, although drop-ins are usually accommodated.

Bureau of School Health: Health Promotion and Disease Prevention; Pest Control: Environmental Health & Bureau of Veterinary; Office of Health Insurance Services: Health Care Access and Improvement, Primary Care Access and Planning; Bureau of Tobacco Control: Health Promotion and Disease Prevention; Bureau of HIV/ AIDS Prevention and Control: Disease Control and Bureau of Early Intervention.

Chairman Accornero inquired as to why the Health Department was giving up space when there are services such as an ECB Hearing Office that are needed locally on SI.

LAND USE PUBLIC HEARING CLOSED AT 7:55 P.M.

Chairwoman Leticia Remauro called the Full Board Meeting to order at 8:00 P.M. Pledge of Allegiance.

Motion made, seconded and approved to accept November 2013 Full Board Minutes.

PUBLIC SESSION

Robert DeBiase and John Jankowksi, Transportation Alternatives both spoke requesting CB#1 support for a protected bike lane on Richmond Terrace.

Mr. Richard Burbridge spoke of the Trans Pacific Partnership which is a free trade agreement currently being negotiated by nine countries: The United States, Australia, Brunei Darussalam, Chile, Malaysia, New Zealand, Peru, Singapore, and Vietnam. TPP covers a wide range of issues.

Ms. Sherli Allen spoke of an empty lot next to her home on Corson Avenue that is zoned residential with a commercial overlay. Ms. Allen is asking for advice on how to change the zoning to Residential only, eliminating the overlay.

Neela Wickremesinghe, Elm Park Resident mentioned that the Port Authority has been using the 3.5 acres of land next to the Bayonne Bridge on Innis Street for a staging area and for parking the

construction vehicles. After the construction is completed, Ms. Wickremesinghe would like to have the land restored and possibly turned into an official type of field, baseball etc.

Mr. Joe Polimeni of Joe Broadways located at 2178 spoke of his establishment and how he has been working with the local area committee in being a good neighbor. Since he has taken over the establishment about a year ago, there have been no problems. If anyone has any problems they can contact Mr. Polimeni directly 24 hrs. a day 7 days a week at 646-529-6610.

Mr. Andrew Blancero spoke of Mulchfest events Saturday and Sunday, January 11th and 12th. Residents can bring their Christmas trees to be recycled. If you drop your tree off at a chipping site you can receive mulch.
