## 2. Infrastructure repair on four Expressway bridges

The New York State Department of Transportation is to rehabilitate four Expressway bridges - over Mosel Avenue (both directions) and over the SIRT (both directions). Project design has started, with construction to begin this fall, expected to be completed by the end of 2019.

On each bridge, the deck and substructure will be replaced. Steel will be repaired or replaced, and painted, where necessary. steel railings on each bridge will also be replaced with concrete parapets for enhanced safety. Roadway lighting will be replaced within the project limits.

### 3. The Four Borough NYC Ferry

At the end of August the City completed six de luxe ferry routes touching four Boroughs - the NYC Ferry. The Borough not touched: Staten Island.

Now the New York City Economic Development Corporation (NYCEDC) is undertaking a new ferry feasibility study to examine sites for possible future landings.

#### PRESENTATIONS:

NY Public Library shared their Community Presentation on the proposed upgrades/renovations for the Port Richmond Library, a 112-year old NYC Landmark. Overall, the changes pull together the look of the building bringing the historic elements forward while promoting accessibility, creating meeting rooms, landscaping the grounds, and more. A permanent installation of art created by local artists, funded by NYC Cultural Affairs and NYC Economic Development Corp. is also planned. Projected start is Fall 2019; branch should reopen in early 2022. NYPL is exploring ways to continue service to the community during the construction; working with local schools was suggested, however schools are limited in hours, and services should be available to all community members, not just children. A bookmobile was suggested; any other ideas please contact NYPL.

A motion was made for the Local Area Committee to support approval by the NYC Landmarks Preservation Commission; motion unanimously approved without objection. The matter now goes to the full Community Board for review.

Venture House presented their new facility at 1442 Castleton Avenue., offering a clubhouse-model program of supports for people with mental illness. Hours will be Mon., Tues, Thurs. and Fri., 9am – 5pm, Weds. 9am – 8pm, and Sat. 11am – 4pm. Training in life-skills, job-skills, and opportunities for socialization will be offered, along with job placement services. Access to the program requires a diagnosis; the program is funded by the Department of Health and Mental Hygiene (DHMH).

Community comments included concerns about traffic: response was there is parking available; participants will arrive by access-a-ride or public transit. Venture House will ensure vehicles do not block traffic on Castleton Avenue, and that they do not idle during drop-off/pick-up times. When asked about community notification prior to opening, response was DHMH said it was not necessary. Pointing out the benefits of services once offered by the Sky Light Center, the successful history of club-house programs, the stated

willingness to address concerns, and the need for genuine community supports as opposed to institutional congregant housing, Venture House was welcomed to the community.

- \* Report on Community meeting, including representatives from Community Board 1 and Port Richmond Strong with the Developer, Architect, and Franchisor for the proposed "boutique hotel" developments on Port Richmond Avenue. Plans were shared for the proposed operation at Bennett those plans have not been submitted. The developer agreed to file a restrictive declaration with the Richmond County Clerk, to be noted on the Certificate of Occupancy, indicating there will be no use of the facility by the NYC Department of Homeless Services or other Agencies, public or private. Issues raised include lack of parking for guests and staff, restricting double parking and idling when guests are picked up or dropped off, security plans (taking into account local drug and prostitution); local hires for all aspects from construction to operations, develop, and share, a "Plan B" sfor the operation should it prove unprofitable, Active engagement in community activities and support; protect neighboring buildings, including the landmarked SI Reformed Church, during construction, and guarantee compliance with regulations pertaining to ADA compliance, Universal Design principles, fire safety particularly in regards to cellar egress.

However, inasmuch as our area has very few of the protected designations, we will continue to relay the Department of Buildings reports of significant actions.
