Presentation from EDC, Diana Switaj on Pier I

Maintenance Issue: Closed off. People are coming through the fence. There is garbage and debris.

Fixing it requires major capital investment and will cost millions to fix. It is a priority. We are trying to get money to fix it and the elected officials agree.

A suggestion was made to have an RFP issued for someone to fix the pier.

A discussion ensued about how many other properties are pushed through and the problem was known but by EDC but no money allocated.

Donald DeRosa of Comptrollers' Office said there has been a lot of finger-pointing. A lot of public money has been spent.

Maybe removing and replacing pier would be better and cheaper.

Chris Rooney suggested we modify the Budget Requests for Pier I on CB 1's list.

Ms. Switaj from EDC will follow-up with answers to these questions. There will be a meeting November 22nd regarding the Esplanade.

Presentation from Triangle Equities, Evan Petracca on Lighthouse Pointe

Phase I – Residential building with a parking structure underneath will be completed in 2024. Ground was broken in 2015.

Phase II – Not under construction at this present time.

Bay Street and Borough Place will have commercial portion on bottom and high-rise on top. It will be 60,000 square feet including CSI Tech Incubation, Early Childhood Learning Center, Supermarket, Quick Serve Restaurant space. 115 Residential Units. Ground leases from 49 to 99 years.

Chairman Nicholas Siclari said the front of the building needs to be cleaned up, a scaffold violation had been issued. There is a violation of City Charter due to after 2013, you needed to come to the Community Board to let us know about the change of lease. It's been 10 years, and nothing has been done. Wil Fisher knew you couldn't do anything on the fly. The scope of the work changed.

There are some union workers there, but Mr. Petracca didn't have a percentage on how many.

It was asked if Phase II will include a hotel because we don't want it to become a homeless shelter.

Office Anchor Strategy, Lauren Wolf of EDC

We lease space from private landlords. The city is a credit-worthy tenant. Office space and retail.

Our first project is HRA moving from Downtown Brooklyn to East New York. Second project, Queens, third project, Bronx, and hopefully we will bring the project to Staten Island. You can sign up to receive email to get on list to see all Real Estate Procurements.

Discussion regarding there are nonprofit organizations looking for space. Outlets are 60% vacant but Ms. Switaj said we can't be in retail spaces.
