1. 76 Cedarcliff Road, Thomas J. Soviero, AIA, NCARB, Roger Calvanico Group. Chairman Nicholas Siclari asked Boy Scout, Nicholas Ragucci to lead us in the Pledge of Allegiance. All the Veterans for Veteran's Day that just passed were acknowledged and stood up.

Roll Call Attendance, Loretta Cauldwell. Motion to accept the minutes.

## Public Session, Friday Ogbewele

Jermaine Williams – NYPD Ambassador for SI. We have 8 ambassadors in total for the other boroughs. Friday, November 17<sup>th</sup> Outreach Program for 10-14 year olds. One location is at the ferry at the 120<sup>th</sup> Precinct from 12-6 PM. Other location is at the SI Mall. Be mindful when shopping and putting stuff in your car and going back to shop. People are watching. Be careful out there.

Mary Bullock – It's open season on the banners. Think about your ancestors and who you may want to honor. Third annual tree lighting on Tuesday, December 12<sup>th</sup> at 415 Port Richmond Avenue. Hot chocolate from Café Con Pan. They make a sheet cake that I promise you never tasted one better. Hanukkah Lighting on Wednesday, December 13<sup>th</sup> at 7PM at Temple Emanuel, 984 Post Avenue. Lastly, the Staten Island Jazz Festival on Friday, December 15<sup>th</sup> at the St. George Theater. St. George theater is totally refurbished. Happy Holidays.

Perveen Agarwal – Beverage Island, three locations. Construction on Willow Avenue since February 2023. They close the street and have limited access to our business. We employ 23 people. It's getting worse now with the holidays. We are losing business and we may have to lay-off a few employees during the holidays. We need DEP to give us guidance. (This issue was resolved).

Mike Morrell – Westerleigh Civic Group. Landmarks Preservation Commission. 1197 Clove Road, John King Vanderbilt Home. The house is in horrible condition and the owner would like to construct two other houses on the same plot. The board approved of the construction after the owner rebuilt the original landmark home. The other homes would also have to be contextual to the original home. That's the status. I will keep monitoring and report back.

Agatha Vassallo – We serve the LGBTQ+ families with free mental health counseling, HIV testing, youth programming, etc. Located at 66 Willow Avenue. 10305. Willow Avenue is currently a one-way street that has ongoing construction for the past 10 months. Parts of the street and sidewalks have been closed. No projected date of completion. On November 8th we were told that there would be no curbside access or driveway access from November 9-17. Many of our participants have mobility issues. They are told to drive the wrong way on a one-way street to navigate. Funding for non-profits come from funding from participation that we need to report back to the state. This is a poor plan that denies access of our resources for our participants. (Here is what we heard since the meeting: "We are in the roadway trench restoration phase of the project. The underground work (watermain, sanitary & storm sewer) has been completed. The contractor will be providing temporary access to the parking lot of 66 Willow Ave. from Willow Ave. this Friday, November 24, 2023. Access to the parking lot was restricted from the driveway on Willow Ave. only. Vehicles had and continue to have access to the parking lot from Langere St. The end date for the project is December 29, 2023. It is however possible the project will end before then").

Makeda Campbell – Community Liaison for Jessica Scarcella-Spanton's office - Wanted to introduce herself.

David Pena – Councilwoman Kamillah Hank's office – The election was a week ago and we have been elected for another 2-year term. Thank you. This Saturday, our office is doing multiple turkey giveaways. Locations: Mount Sinai, 382 Jersey Street at 10:00 AM, Brighton Heights Reformed Church at 11:30 AM, Fellowship Baptist Church, 1:00 PM. Happy Thanksgiving.

Chairman Siclari thanked the Board Members for showing up to the area and functional committee meetings. I appreciate what you are all doing.

### Officers' Reports

First Vice-Chairman, Anthony Cosentino – Last month, we didn't have a budget to present to you. We sent out an email with the budget to everyone. If there are no questions or comments we will do a reverse roll call. Passes unanimously.

Chairman Siclari said the Budget is a like a wish list. We spent a lot of time with it. Other boards have 2-3 items, we had 40 items. Loretta Cauldwell is a great-grandmother again. Congratulations. We will be trying a new place next month, Wagner College.

Second Vice-Chairman, Timothy Forsyth - No report.

Third Vice-Chairman, Friday Ogbewele - I want to commend the area chairs for their due diligence.

Secretary, Loretta Cauldwell - No report.

Treasurer, Sunny Jain - Report in packet.

**Chairman, Nicholas Siclari** – We will be trying a new place next month, Wagner College. We will keep trying. St. Mary's is in the center of the North Shore for meetings.

**District Manager, Joan Cusack** - The Budget is done. Thank you for all the help. Thank you to the board members for your support. If you feel something isn't being done correctly, please let us know. Have a great Thanksgiving.

Land Use, George Turner - We had two applications this month.

1. 191 Edgewater Street, BSA Cal. No. 2023-36-BZ – Philip L. Rampulla, Principal/Urban Planner presented. A manufacturing-type building, former Wrigley Gum building. Like a Bay Street Landing type of a building. 6-7 stories high. Will be converted into market-rate 2 bedroom condominiums with parking underneath for 33 spots; taking the first floor out for parking. A roof deck and recreation space. Public access through their site to the water. The bumpy street will be repaired. Extra parking across the street, 190 Edgewater Street as a parking garage. Rear of the building, waterside, there will be a Kayak launch. Sprinkler System & fire hydrant. The Land Use Committee voted yes unanimously 9-0-0.

There was a discussion.

Robert Holst said the building is zoned for manufacturing. They are asking for a variance on that zoning so they can put private residences there. Nothing about affordable housing. Market-rate apartments and the developer gets the profit. If you said there is no chance manufacturing is coming back to the U.S. but it is coming back. The federal government and state is putting money behind it. Chips, infrastructure, etc. These are jobs for the middle class. Before we sign off on changing manufacturing to a residence, what do we as a community get in return for that?

Lillian Lagazzo said we are getting something back for that. This is a beautiful waterfront. We have plenty of affordable housing coming into our area. This gives families who are starting out the ability to buy a piece of property. We are accommodating the community of various levels of income. We should be able to own something to pass along to our kids. It will also be enhanced for the community and be positive for the community. John Guzzo said we have tried to have this property developed for many years. This building has been vacant for close to 100 years. We'd like to see something there. I've been saying for years that manufacturing is coming back and I am for it but that part of Rosebank couldn't handle manufacturing anyway. We can't handle when Alice Austen has a party which is 25 cars. I am on the Land Use Committee and voted in favor of this plan. Selina Grey said she thinks what Robert Holst is

proposing is a good idea. Why not have the developer higher some young people from the high school to give them experience. Another speaker asked if we are asking for union workers? Catherine Schiavone said she agrees with Lillian Lagazzo on the home ownership. I'm tired of my friends moving away to New Jersey, Florida, South Carolina, People want to own on Staten Island. Joseph Bird said we should be prodevelopment on this issue, nobody else is interested and we need these sites developed. Peter Lisi said plenty of times we see a community get nothing. We could put our youth to work. If we deny this building it may stop more development. This building is here 100 years since 1919. If you want to approve with the caveat that it facilitates their own union training for youth, etc. Chairman Siclari said when the Empire Outlets was being built we asked for a labor agreement with local hires with training the kids out of high schools. Everything the Community Board does is advisory only. When we start something and it gets done, like Empire Outlets, we did our job. George Turner said buildings go through a life cycle and it's very rare if a building has a second and third life. This building is obsolete for a manufacturing use. It can have a second life as a residential use. The area will be cleaned up, street fixed, with access from the road to the shoreline. John Guzzo said the lot line is on the street and there would be no way they can have truck deliveries as a building for manufacturing. Peter Rampulla from Rampulla Associates Architects. I am a Land Use Specialist. In 2006 this building was seeking a variance for similar. Not sure why it didn't go through but it was approved for residential back then.

Full Board Motion to approve 191 Edgewater Street provided the owner has a Project Labor Agreement with local hiring.

Full Board Vote: 29-1-0

2. 180 Campus Road – Single family home with an illegal extension on the house. Steven Simicich, Esq. (steven@slig.law), Managing Partner, SL Law Group – for the applicant Jesus Rivera. Special Hillside Preservation District – Horizontal enlargement to a single-family home. Interior work. Enlargement of the garage and the room above the garage. Deck is not part of this proposal, but it is falling apart.

Motion: To approve enlargement structurally sound and to include the deck made structurally sound/rebuilt entirely. Land Use Vote: 9 Yes, 0 No, 0 Ab

Full Board Vote - Passes Unanimously, 30-0-0.

Waterfront, Joe Ahlstrom – Minutes are in the packet. I'm happy with the comments about the waterfront. The waterfront is coming back with the Esplanade, they'll be a lot going on. It will be a lot of opportunity for a lot of people. Thank you for the letter for the Ferry to Brooklyn. Hopefully that will get done.

**Public Services, Sunny Jain** - Leaves picked up on Sunday, November 26<sup>th</sup> and December 10<sup>th</sup>. It should be put in paper lawn bags or clear plastic or a labeled bin with a secured lid. I'm sure there will be further dates. For snow, we mentioned last year to have the plows come down on both sides of the street. As far as the homeless shelter, they will be assigning security chiefs. As soon as we get the names we will have a meeting with them and meet regularly. There were sidewalk issues but they are cleaning it up.

Youth Services, Kathleen Coen & Mohan Radhakrishna – Minutes are in the packet. Our next meeting is on November 29th. We are having the Staten Island Parks Department Youth Coordinator speak about a Robotics Program after school in park facilities. There are other programs for after school also. There will be another speaker about lowering the voting age.

**Transportation, Nicholas Zvegintzov** – No meeting. Nick is under the weather. Chairman Siclari said the fast ferry schedule has changed from three boats to two boats. As long as they keep running for Staten Island.

#### Labor, Robert Holst -

Rules & Legislative Affairs, Anthony Cosentino & Timothy Forsyth – The NYS Liquor Authority has a new rule for all committee chairs. If you are applying for a new liquor license, you must serve food and until the time of closing, otherwise you're in violation. On the renewals, they are grandfathered in.

**Budget & Finance, Anthony Cosentino** – Anthony Cosentino said he had a meeting with the office staff for about 3 hours. We have the Expense Budget for up to \$30,000 and the Capital Budget for beyond that amount. We had a great meeting with a lot of input. It was supposed to be presented tonight but there was an administrative snag with the city so instead it will be presented to next months full board meeting.

Parks Committee, Anthony Cosentino – The Parks Department wants to do a presentation. They are reconstructing the vestibule at Stone House on Clove Road. I suggested they come before the West Brighton Area Committee. We can have a joint meeting with Parks at that location. (Parks is presenting at our next Full Board meeting on Tuesday, December 12<sup>th</sup>).

Health & Human Services, Fran Reali - Fran Reali is excused.

West New Brighton/St. George Committee, Claudette Duff & Anthony Cosentino – Report in the packet. Parks Committee asked for a letter of support for Tot Playground construction in Mahoney Park. Letter is in the packet. The park serves 2-5 year olds. Project is .23 acres. \$1.93 million dollars. ADA Accessibility, shaded areas with trees, swings, seating, etc. Reverse roll call. It passes unanimously.

**Silver Lake/Sunnyside/Westerleigh – Timothy Forsyth** – No meeting, no minutes. We will meet tomorrow night at Safari Realty, 6:30 PM.

Rosebank/Fort Wadsworh/Shore Acres – John Guzzo – No meeting, no minutes. We spoke in the past about having Ad-Hoc meetings regarding these battery operated sites from Con Edison. Corrected, the Wrigley's building closed down in 1949, not 1919.

Mariner's Harbor/Port Richmond/Elm Park/Arlington, Selina Grey & Dora Berksteiner – We had our first meeting. No minutes. The next meeting will be on 11/27/23. It is virtual. We are actively looking for a place.

## Motion for the Board

## Comment by SI CB1 on the North Shore BRT Draft Environmental Statement

Staten Island Community Board 1 had already commented on the Final Scoping Document on June 11, 2019, and finds that its objections have not been met in the October 2023 Staten Island North Shore BRT DEIS, and re-states and extends them here.

CB1 supports the North Shore BRT to enhance community development and reduce existing commute times.

CB1 urges the MTA to collaborate with City, State, and US Government to complete the design for terminating the BRT in the existing SIRT station at St. George. This design was improperly ignored in the DEIS.

The proposed routing into the bus terminal via Richmond Terrace is absolutely unacceptable for multiple reasons: Increasing instead of decreasing transit times, eliminating parking, bus stops, and bike lane, adding to traffic obstruction, and retarding circulation instead of easing it.

The DEIS seeks to support the on-street routing by releasing Appendix B: St. George Terminal Access Evaluation. Its entire analysis is: 'Based on the initial review conducted as part of this screening effort and in consultation with New York City Department of Transportation, it was determined that an alignment that travelled beneath the Ferry Terminal and its associated retail corridor was not considered feasible primarily due to

security restrictions and to a lesser extent the inability to relocate critical equipment.' (p. 33)

The EIS is required to examine all the impacts of the design decisions by objective criteria. The unsupported opinion of a Department at any level of government is inadequate to establish security impacts. Marine Security implications of the BRT terminal station options should have been examined according to the Marine Security standards set up by the US Department of Homeland Security and with the support of USDHS staff.




Figure 6 - Option 2

In particular the impacts of each individual option 2, 3, and 4 should have been examined individually since they are not equivalent in their impacts. For example, Option 2 has its station approaches and its platforms and staging areas outside the existing MarSec perimeter with a less than 20' corridor between them to be assessed for Marine Security (Fig 6, p. 14.)

Options 2, 3, and 4 must be assessed to complete the EIS, and selection including them needs to be considered in order to avoid adverse environmental impacts and costs of the alternative onstreet routes.

In Option 2, we recommend making the terminal loop in the anticlockwise direction. This will avoid conflicts with driving on the right.

The on-street segment from Nicholas St. to the entrance to the Ferry Terminal, comprising six lanes of traffic (seven at several turning lanes), presents multiple problems:

- Increasing instead of decreasing transit times.
- Eliminating parking, bus stops, and bike lane.
- Eliminating 250 parking spaces from Nicholas Street to the Ferry Terminal will create parking hardships for individuals (especially the handicapped) and burdens to businesses that depend on Richmond Terrace's street parking for patrons.
- Decreasing amenity by presenting a traffic wall between the waterfront esplanade / Ferry Terminal and Staten Island's civic center / 'downtown'.
- Blocking entrance to Borough Hall, the County Building, the 120 Precinct, Family Court, the Ballpark, and the Empire Outlets.
- Blocking automobile entrance to both commercial parking garages.
- Presenting a traffic wall to passengers moving from Staten Island's civic center to and from the Ferry Terminal.

The cost analysis of 'preferred' alternative does not impute the going-forward costs of the degraded transportation environment, especially street access to SI's most-traveled transportation node, thus under-costing this alternative.

The DEIS dismisses these costs: 'Significant adverse impacts are anticipated to traffic movements at 19 different intersections during one or more analyzed time periods. Significant adverse impacts are anticipated at two sidewalk locations. Approximately 250 on-street parking spaces along Richmond Terrace between Bay Street and Nicholas Street would be eliminated to accommodate the proposed busway (except for the 90-degree parking on Richmond Terrace associated the NYPD 120th Precinct); however, off-street parking would have capacity to accommodate the on-street shortfall.' (p. E-16)
