Chairman Vincent Accornero called the meeting to order at 7:05 P.M.

Mr. Ron Risotti presented Board of Standards and Appeals Application No. 2019-266-BZ – enlargement of an ambulatory diagnostic or treatment care facility which exceeds 1,500 square of floor area, contrary to ZR 22-14 located at 1498 Clove Road.

This is Dr. Giovanazzo's Gynecologist Office, there will be 2 apartments upstairs. There are no parking requirements at the site - they have included 15 parking spaces – 2 spaces reserved for apartments and 1 handicap. The site will be fully landscaped.

Mr. Krebushevski presented Department of City Planning Application No. N 200194 ZAR - Request authorization for the development of a single-family residence within the steep slope in the Special Hillsides Preservation District at 260 Brighton Avenue.

11 trees to be removed and new trees planted clustered closer together – Hans Arborist inspected all trees. Perk tests have been done. There drywells in rear and in front to collect water. The homes are being built closer to the front as to maintain as much of the steep slope as possible. There are similar homes on both sides of the lot. By building the homes with the drywells will absorb a lot of the water that currently is ponding on Brighton Avenue.

Mr. Arvanites mentioned there is a huge ponding condition on that corner. Many former and current Elected Officials that he was a staff member of said that they bought surrounding property in that area to make and expand Jones' Woods and Goodhue Park. Tier I sites should not be built on.

The neighbor of the proposed homes was in attendance, Maha Haddad and Eyh Amos who were happy the homes were going to be constructed. There was concern of the construction equipment that was going to be used to dig in the steep slope.

The homes are to be built closer to the front of the property and excavation will be performed from the front.

Department of City Planning No N 180008 ZAR – Request for Authorization for site alteration on a steep slope and authorization for lot coverage controls for installation of new permeable pavement to replace existing walkway and create a new patio area to an existing single-family two-story home at 95 Louis Street in the Special Hillsides Preservation District at 95 Louis Street.

The Architect Mr. Peter Calvanico did not appear nor the owner of the property. There was a brief discussion about tabling the motion until next month and ask for representation to appear. There was insufficient time to table the motion.

Mr. Accornero mentioned that the Hillsides Preservation District came in 1987. The reason was for oversight not to stop landowners from developing their property. The authorizations and approvals needed insures that building is done in a way to maintain as much as the steep slope as possible. A lot of the applications help with drainage due to the drywells that are built on the property.
