There will be 85 studio apartments, 163 1-bedroom apartments, 103 2-bedroom apartments and 15 3-bedroom apartments.

The housing will be 100% affordability:

HPD Ella Program

80% LIHTC Eligible

20% of units at 90% AMI.

There will be 360,000 square feet of residential space

8,600 square feet of non-residential space.

Pedestrian safeguards: protected laws, one-way traffic loop, and limited curb cuts.

Spatial certainty: streetlights, oversized windows, "four" facades and continuous residential corridor.

Concerns were raised about the non-existing seawall which will undermine the buildings, safety concerns for the residents, need for increased parking and additional disabled parking, need for supportive mental health wellness offered to the homeless individuals and how they will be integrated into the building. Unsafe working conditions on projects in NYC and the protection of fair wages to the workers. Isolation of the facility and lack of public transportation.


Conclusions

Important items to be recommended in current projects:

- Waterfront access where the North Shore BRT is near the shore.
- Direct links from the NE Shore, including the BRT, to proposed express buses to Newark Airport and the Hudson-Bergen Light Rail.
- 4. Based on this hearing, the Transportation Committee will formulate funding requests and go-forwards to be addressed to the Governor of NYS, the Mayor of NYC, State and City elected, and others.

Verrazzano Bridge Emergency (Shared-Use) Lanes



2016 Long Range Plan showed added north and south lanes on VB for emergency vehicles and pedestrian / cycle traffic.

MTA:

Out of date. Redecking the lower deck still in the future. Ramp enhancements are the current priority.

CB1: Ask new plan briefing.

North Shore Bus Rapid Transit (BRT)



Establish limited stop electricpowered bus network fanning into the grade-separated right-of-way of the former North Shore Branch of the SI Railway.

CB1: Ask new plan briefing.
Request NYS budgeting.

West Shore Alternatives





St. George Station Access




Create space at St. George

Staten Island Gateway




Create a civic gateway and reduce surface traffic confusion in front of St. George Station at Staten Island's civic center.

Closed to public since 2013.

NYC EDC:

Spokesperson knew nothing about this area.

CB1:

Pier One at Lighthouse Plaza



Restore the docking / fishing pier created in 2009. Closed to the public since 2017.

NYC EDC: Spokesperson knew little about this area.

CB1:

Will probe whether NYC EDC is in violation over these completed capital projects, now unusable.
