An application has been submitted to the Department of City Planning Application No. N210111ZAR, N210112ZAR to request authorizations for the development of 1-two family home on a steep slope at 285 Stanley Avenue within a Special Hillsides Preservation District The proposed development consists of the construction of a two-family residence with accessory off-street parking for a total of three cars on an existing vacant lot. The lot has frontage along Stanley Avenue and Fairmount Avenue. Stanley Avenue is a mapped street improved with pavement and sanitary sewer, watermain and other utilities. All storm water will be retained on the properties with drywells.

Motion made and seconded to approve both applications as submitted for 279 and 285 Stanley Avenue 9-2-0.
