### **OFFICE STAFF**

Joseph Carroll, District Manager Lisa Crosby, Community Associate Chairwoman Leticia Remauro called the meeting to order at 8:10 P.M. immediately following the Land Use Public Hearing.

Pledge of Allegiance.

Roll call attendance taken.

Quorum was present.

Chairwoman Leticia Remauro read the list of Elected Official representatives in attendance.

Motion made and seconded by Ms. Linda Eskenas to accept June 2009 Board Minutes.

### **PUBLIC SESSION**

Mr. Rajiv Gowda spoke of the upcoming Democratic Primary Election and asked for support in the election.

Chairwoman Leticia Remauro informed Mr. Gowda that the Community Board is not a political forum and his speaking was inappropriate.

Mr. Ronald Meisels spoke of the National Lighthouse Museum. Mr. Meisels was mugged 3 weeks ago and beaten with a metal bat on Hannah Street. There were papers scattered outside 30 Bay Street and Mr. Meisels went to retrieve a shopping cart to retrieve the papers. The National Lighthouse Museum should be opened to the public and not have locks on the doors. The Nantucket should be brought back to Staten Island. Ms. Pamela Silvistri did stories of many storefronts on Bay Street that are closed. "We do not need anymore restaurants; we need to have the National Lighthouse Museum open to the public."

Mr. Saleen Shah from Citizens Committee for New York City spoke of "New Yorkers for Better Neighborhoods Grant Application." Citizens Committee for New York City offers small grants for volunteer-led projects that improve and strengthens communities, and that involve neighbors in a meaningful way. Our grants are for grassroots community groups in economically under-resourced neighborhoods. Through New Yorkers for Better Neighborhoods, Citizens Committee for New York City awards grants of \$500 to \$3,000. There is a grant workshop this Saturday. For more information see below.

Luis Caridad from Neighborhood Economic Development Advocacy Project is a resource center that deals with economic justice. If anyone is facing foreclosure or knows anyone that is facing foreclosure 311 should be called and they will be given information on reputable foreclosure crisis centers or foreclosure specialists.

Many people refinanced their mortgage and are unable to make the payments. There is a stimulus package from President Obama if you qualify which helps lower your mortgage payments.

New York State Law prohibits upfront fees when refinancing your mortgage. Mr. Caridad urged anyone who was facing foreclosure or who were thinking about refinancing their mortgage to seek professional help before signing or paying anything. Flyers were available. <u>DISTRICT MANAGER</u>, <u>JOSEPH CARROLL</u> – Mr. Carroll reviewed the stimulus funded projects for our Board area and noted that these are important numbers for the north shore.

<u>CHAIRWOMAN, LETICIA REMAURO</u> – Ms. Remauro sent e-mails out over the summer to the Board Members.
