Pledge of Allegiance. Roll call attendance taken, quorum was present. Motion made, seconded and approved to accept June 2014 Full Board Minutes.

PUBLIC SESSION

Ms. Fran Reali spoke of the 6th Annual Memorial Dinner in memory of Frank J. Reali, III which is to protect one young heart at a time by helping to provide supportive funds for echocardiograms or other heart baseline testing for 8th graders, prior to entering high school sports.

Beth Malone, Hope Wright, Barbara Sanchez, Jack Bolembach, Phyllis Zito and Carinda Longueira all spoke regarding items relating to Mount Manresa. Issues spoken about were the asbestos in the buildings, the demolition of the buildings and zoning.

Ms. Elise Vetere spoke of accidents and speeding on Royal Oak Road and the need for traffic controls.

Ms. Katherine Romanelli spoke of quality of life in Mariners Harbor, residents playing loud music all day, night.

Joseph Parker, Michel Polmieri, Matthew DeLuccio, Richard Pagan and Rose DeLuccio all spoke opposing the variance request for 200 Cambridge Avenue, Rabbi Jacob Joseph School for girls. Residents state that there is already disregard for the neighborhood with overgrown trees onto adjoining properties, grading problems that are affecting adjoining homeowners, disregard from parents, children littering when dropping children off, traffic issues, etc.

Mr. Eric Petillo from Sundog Theatre spoke he has a 40-minute touring show about the dangers of tobacco smoking and advertising.

FUNCTIONAL COMMITTEE REPORTS

LAND USE, VINCENT ACCORNERO -

The following motions were read, discussed and voted on as follows:

1. Department of City Planning Application No. C 110122 ZMR – 1816 Forest Avenue – Proposal to map a C1-2 commercial overlay within an existing R3-2 District on the south side of Forest Avenue to facilitate a proposed use Group 6, local retail commercial development and change the portion of the existing C1-1 commercial overlay to a C1-2.

Motion made and seconded to approve as submitted.

Roll call vote taken. Vote passed 27-0-1.

 Board of Standards & Appeals Application Cal. No. 126-14-A – 3153 Richmond Terrace – Proposal to permit construction of a warehouse building partially located within the bed of a mapped but unbuilt street. Motion made and seconded to approve with the condition that the applicant sign a restrictive covenant, attached to the land in perpetuity to agree to accept all costs of demolition and reconstruction of the building if DOT plans to widen Richmond Terrace.

Roll call vote taken, vote passed 25-2-0 (1 ineligible)

3. Board of Standards & Appeals Cal. No. 153-14-A – 200 Cambridge Avenue – Proposal to build a one-story school building located partially within the bed of a mapped but unbuilt street.

Motion made and seconded to deny the application: Based on the owner's demonstrated disregard for the community with the existing conditions and use of the property, the increased traffic and disruption of the quality of life that would result from approval of the application, and the reports of unlicensed plumbing and electrical work being performed at the property, we cannot approve the application. Roll call vote taken. Vote passed 28-0-1.

4. Board of Standards & Appeals Cal. No. 526-76-BZ – 1492 Victory Blvd. – Proposal to reopen, amend and extend the term of a variance.

An amendment to the motion was made to amend the term of variance to waive the term limitation.

Motion made and seconded to approve as submitted. Roll call vote taken. Vote passed 27-1-1.

5. Board of Standards and Appeals Cal. No. 171-14-A – 172-14-A - 235 Dixon Avenue – Proposal to construct a single-family home located partially within the bed of a mapped street.

Motion made and seconded to approve with the condition that visually permeable fencing and/or low growing shrubbery be used around the perimeter of the property for daylighting on the corners of Dixon and Granite Avenue. Roll call vote taken. Vote passed 24-2-3.

Proposed contextual rezoning study of the Rosebank, Ft. Wadswoth, Shore Acres and Clifton Neighborhoods.

Motion made and seconded to assist and join the application as co-applicant.

Community Board #1, as a New York City Agency, request that the Department of City Planning provide all necessary support, including an in-house environmental review, a negative declaration is expected since the majority of the action reflects the exiting build out of these areas and the contextual action would reflect that and protect against large scale change in densities.

Reverse roll call vote taken. Vote passed unanimously.
