#### **OLD BUSINESS:**

- 1. We still have not received an update from Terry Troia, Project Hospitality regarding the temporary shelter at 32 Browell Street. Committee will try to contact Ms. Troia.
- 2. The Hill Street Police Precinct site has not been cleaned. We are trying to contact Wildcat Service Corporation to get a status for them acquiring permission to clean the site.
- 3. The US Post Office on Tompkins Avenue, property adjacent to Thelma Court Harold Wagner will get the proper name and telephone number of the carting company and contact them.
- 4. The loitering condition in front of the Gerard Carter Center on Broad Street has stopped.
- 5. We have been informed that parking on Front Street will not be a problem for the members of the Ocean Yacht Club at 370 Front Street.
- 6. Dorothy Brown reports that we must write a letter to the new Captain, Labaniel Urbina in order to have him attend a future meeting to update us on the Kroc Center.
- 7. Peter Lisi inquired about the construction at the intersection of Bay Street and Vanderbilt Avenue. Most likely it is part of the "Siphon Project," an underwater tunnel that will link Staten Island and Brooklyn creating a new source of drinking water for north shore residents, and includes a chlorination station on Front Street.

#### **NEW BUSINESS:**

- 1. City Planning application N110393ZCR and N110394ZAR, Woodside Avenue and Ramsey Place, Block 617 Lot 1, Special Hillsides Preservation District.

  Applicant was not in attendance. A discussion was held and the chief concern was the steep grade of the slope affecting the Special Hillside Preservation District. After a lengthy deliberation, it was decided that due to lack of information and knowledge the area committee could not make a recommendation, and thereby defers the decision to the Land Use Committee.

#### **NEW BUSINESS**

2241 Victory Boulevard – Beyer's Market An application was discussed on their request to "extinguish" their variance which allows operation within a residentially-zoned area. It was the understanding of the committee that after getting the variance extended, in 2001, they now seek to remove the variance. After much discussion the committee agreed that extending the variance was acceptable but does NOT recommend the variance be removed from the site.

Demo permits were presented: 86 Keiber Ct., 25 Manor Rd (garage), and 56 O'Connor

Liquor License at 1710 Victory came in (Azarel INC), with no survey, or any other information, the committee declined to approve or disapprove without proper information.

Various community event flyers were presented.

A letter from the Borough President regarding Ada Place being "officially named" on the Topographic Bureau maps was read.

An email from Chairperson Remauro restating CB #1's commitment to de-mapping the wooded portion of Waldron Avenue was read.

Amerika Grewel, a Gyrmes Hill neighbor, appealed to the committee to take action to help prevent the string of accidents on lower Howard Avenue. She mentioned several recent accidents (one that very morning), including the recent hit and run bicyclist fatality. Physical changes to Howard Avenue were discussed. Rumple strips, medians to narrow the roads, flashing lights, etc. The committee felt that the main issue was with the lax enforcement of the existing rules but unanimously agreed that an immediate traffic study should be requested.

With no further business the meeting was adjourned.
