- iv*The Port Richmond area has a high amount of social service agencies many of which focus on assisting people with recovery and addiction problems (i.e. Camelot, Project Hospitality).
- v.* There is a history of alcohol related offenses in the area (i.e. DUI and vehicular accidents related to DUI).
- vi.*The Port Richmond area has multiple legal/illegal Single Room Occupancy units and Section 8 dwellings and this establishment has the potential to attract transient customers.
- 5. Reviewed Volunteers of America letter of support for a survey of the area for four new residences, and discussed the letter of support for the Redemption Center on Forest Avenue.

Agenda Items:

The applications of Kyoto Sushi, Inc. and A&S Pizzeria for renewal of their beer and wine licenses were approved without objection.

Indiglo Restaurant Isharaka Gunanghe, Shaniku Fernando and Neal Visoky, Esq. appeared to support the application for a new liquor license for, which will occupy one-half the premises formerly occupied by the Wild Goose, minus the courtyard, and offer a varied menu including dishes from Sri Lanka, where the owners were born. The application was approved with the recommendation that the restaurant close at 1 AM during the week and 2 AM on the weekends, subject to future review and depending on performance.

<u>FI Torito Restaurant</u> Nery Mendez and her husband appeared to support the application for a new beer and wine license for, at 1007 Castleton Avenue. Because the location is on the first floor of a building with two floors of apartments above it, the application was approved subject to the limitation that the restaurant close at midnight during the week and at 1 AM on the weekend.

<u>Legends Hospitality LLC</u> An application was submitted for a new liquor license for SI Yankee Stadium, to serve liquor, beer and wine in the concession stands and the suites during ball games. No one appeared in support of the application, but it was approved.

<u>Cinderella Restaurant</u> An application was submitted for a new liquor license for a restaurant at 108 Victory Boulevard. No one appeared in support of the application, and because the location is on the first floor of a building with two floors of apartments above it, the application was approved subject to the limitation that the restaurant close at 11 PM during the week and at midnight on the weekend.

Note: A day or two after the meeting, a representative of Cinderella's Restaurant called and offered to appear at the next meeting. Consequently, a meeting of the Area Committee will be held on June 19, 2012 to consider that application and complaints concerning a different establishment.

LIQUOR LICENCES:

- 1. Liquor License Renewal Application, Macumba Café Inc., 68-74 Canal Street. Second review, Applicant did not attend again. Committee has the same concerns. The CB1 survey completed by the applicant, the committee has concerns regarding the applicant's response to "Will you have live entertainment in your establishment? If so, will you have sound baffling installed? D.J. once a month" and that the SLA Renewal Community Board Notice Form No.5 response is that there will be Paton Dancing (small scale). The committee believes that this type of entertainment does not conform to the current SLA License on file. With a vote of 7-0-0 the committee denied approval of the application.
- 2. Liquor License Renewal Application, Bay Street Saloon Inc., 523 Bay Street, aka 15 Sand Street. Alexander Levin appeared for the application. Renewal application stated there would be a disc jockey and jute box, however his original application did not. He has agreed to amend the renewal to reflect no live entertainment or performances. With the stipulation for no live entertainment or performances the committee voted and approved the application with a vote of 7-0-0.
