Kelly Vilar welcomed all and last month's minutes were distributed and no corrections were made.

The first order of business was a presentation/overview from the NYC Parks Department regarding Cromwell Recreation Center. The overview was given by Bill LaCurtis, NYC Parks Recreation Manager SI. It also happens that Mr. LaCurtis was the Cromwell Recreation Center Manager prior to its total destruction during the Sandy storm. Mr. LaCurtis shared with the group that the Parks Depart has identified 3 potential although not dedicated sites for the rebuilding of Cromwell. This facility was of enormous use to the community. It had 6 full size basketball courts, several multi-purpose rooms and more... It was a very well used facility and provided much need services filling gaps in recreational programming that exists on north shore.

Mr. LaCurtis shared with us a survey that the Parks Department is conducting and asked that we get as many people from our community or former Cromwell users to fill out the survey with as much detail and suggestions as we can. Everyone obtained copies and made a commitment to get surveys back to Mr. LaCurtis prior to our next meeting March 3rd. After some discussion with a question and answer period, by consensus the youth committee decided to create a coalition inviting former Cromwell users and other stakeholders to come together to keep the conversation with Parks Dept, local officials and the community at large going with a goal to rebuild Cromwell in the caliber of which it existed.

Tammy Greer Brown of NAACP and First Central Baptist Church gave a presentation on the upcoming Historically Black Colleges & Universities (HBCU) Fair coming on March 14 at McKee High School. The HBCU Fair is the only fair of its kind on Staten Island and only one of two that are conducted in New York City. More than 60 Historically Black Colleges and Universities have been invited. There will also be financial aid and scholarship workshops, other college resources such as Princeton Review and HBCU Tour Guides and Reservationists. In the past more than 500 youth and their parents have come through the fair. The NAACP who sponsors this event is looking for volunteers to help with set up, coordinating traffic,

food service, and breakdown. Celeste Holmes who is a north shore parent is also an alum of an HBCU as well as Ms. Greer Brown and both spoke passionately about the quality of education, long term friendships and networking that exists deeply at HBCUs. Anyone wishing to volunteer or help in any way could contact Ms. Greer Brown.

Rebecca Samuels let us know that the Staten Island Council of Churches does keep a calendar of Vacation Bible Schools. We will obtain to share with all.

The committee discussed the youth resource directory project. It was decided that a website might be more useful and easier to update. It would include not only a listing of resources, but a possible interactive blog with opinion posts by youth and parents, links to key community resources and perhaps news article/column on hot youth topics of the day. More discussion to be conducted on the matter. There is a desire from the committee to have completed by May/June so that we may kick off enrollment for summer programs.

Congratulations was given to three North Shore Youth Programs that were recently awarded new grants for afterschool programming. They include: African Refuge Inc. in Clifton which serves predominantly Liberian families living in North Shore. Also the Miraj Islamic School on Victory Blvd in Tompkinsville serving one of the largest Albanian Islamic communities in the city. Finally, the Faber Park Field House serving youth in Port Richmond. The new programs should begin on or about March 1st.

Meeting wrapped up with Announcements including the upcoming Chess and Checkers Tournament sponsored by the 121 Precinct on Feb 16; 9th Annual Youth Empowerment Summit at Wagner College on Feb 28; Deadline for All Star Code: Connecting Young Men of Color to the Tech Industry Summer Institute is Feb 9; Girls Who Code Summer Immersion Program is taking applications for Summer Science Program; Interfaith Youth Fellowship Program Religious Diversity youth discussions taking applications for stipend positions for youth till March 15.
