## **Minutes of the CB #1 Youth Committee meeting**

held Friday, June 10, 2016 at Brighton Heights Reformed Church 320 St. Marks Place at 7pm

- Kelly Vilar opened the meeting welcoming the attendees. She set a celebratory tone as we highlight our successes, set future goals, and showcase our youth. Community Board 1's First Vice-Chair Anthony Cosentino was present. Additionally, representatives from Councilmember Debi Rose and Public Advocate Letitia James' office were in attendance.
- Kelly renewed her optimism that the Rebuild Cromwell effort is resonating with local legislators and the public, despite the setback of Cromwell not making it on this year's capital gains budget. The committee plans to continue raising awareness while setting our sights on next year's budget season.
- Kelly discussed the Staten Island Community Board 1 Youth Committee website, as the actual website was navigated and projected in real-time for the benefit of the attendees. The website is for all ages, but targets youth with the purpose of disseminating information. It also serves as a clearinghouse for photos of youth engaged in positive and healthy activities. "The Wheel, Waterfront and Youth" is a prominent feature of the website designed to promote youth involvement in the waterfront development effort. The website encourages our youth to participate in a survey regarding the wheel. Lastly the website contains links to elected officials.
- Kelly shared her vision for next year to include establishing a youth conference led by young people with adults in supportive roles. She then introduced Ms. Donna Mazzella and Ms. Susan M. Donna gave a synopsis of the work she has completed this past year on behalf of the Youth Committee. Donna has raised awareness about issues facing our youth, most notably at a recent Federation of Protestant Welfare Agencies' meeting. She advocated for more childcare and increasing school seats on the North Shore. Susan encouraged the attendees to testify on behalf of our youth at a public hearing regarding the Bay Street Corridor being held on Wednesday, June 15, 2016, 6pm at Trinity Lutheran Church, 309 St. Paul's Avenue.
- Representative from P.S. 59 discussed how the April 2016 tour of the Harbor School on Governors Island has sparked increased efforts to bring a Maritime themed school to Staten Island. Kristen and Megan spoke of an effort to bring such a middle school to Fort Wadsworth. They announced that Mr. Murray Fisher, founder of the Harbor School is scheduled to visit P.S. 59 on Wednesday, June 15, 2016.

- Ms. Carole Reiss, founder of the Staten Island Green Charter School, shared her 5 year journey to get approval to open the school. After recently receiving a verbal commitment, the school plans to open in September of 2017. Carole anticipates formal approval by December and is seeking highly qualified candidates for the position of school leader. A centerpiece of instruction will be a dual language program with a focus on multiculturalism.
- Ms. Tammy Greer Brown recapped this year's efforts to support youth taking specialized high school examinations. She also praised a delegation of New York's federally elected officials for their support of Historically Black Colleges and Universities (HBCU). During a recent college fair at McKee High School, over 400 youth participated and over 50 HBCUs were represented.
- Ms. Laura Martocci followed up with a recap of how a chance meeting with Ann Tisch led to a renewed effort to bring a Young Women's Leadership Academy to Staten Island. She renewed her earlier praise of BP Oddo's support and reminded those in attendance that every borough in NYC has a Young Women's Leadership Academy except Staten Island.
- Ms. Mayela Calderon, Community Outreach Coordinator with Big Brother Big Sisters of New York City (BBBS), recapped their successes this year in the North Shore of Staten Island. The organization identified mentors during a "Meet & Greet" in January, National Mentor Month. BBBS also opened a Staten Island satellite office at 60 Bay Street. BBBS holds monthly orientations to train volunteers. The next orientations are scheduled for July 13 and August 6, 2016. They are also encouraging Staten Islanders to apply for a position as an associate program manager in the Staten Island satellite office.
- Tackling Youth Substance Abuse (TYSA), working with Teens4Change, highlighted their work this year in tackling teenage substance abuse. Two teen representatives of Teens4Change showed their YouTube presentation, then spoke about their efforts to limit tobacco and alcohol advertisements, provide beverage training for retailers and create positive activities for youth. Teens4Change spoke about their "Sticker Shock" program. With permission from local retailers, they affix stickers to alcohol products highlighting the legal consequences of giving alcohol to individual under the age of 21. Teens4Change meet every Wednesday at the JCC. They provide training in LGBTQ issues, public speaking and leadership summits. They look forward to a closer alliance with CB1's Youth Committee in the future.
- Members of the Brighton Heights Reform Church Youth Orchestra performed a musical selection as a living testimony of the hard work and dedication of our local youth and their director, Ms. Yvette.
- Meeting was adjourned. A celebration featuring food and fellowship commenced.
