Whereas the proposed (3) private roads would not be built to the same DOT standards as roads placed on the official map of NYC, and;

Whereas, the proposed 163 units not fronting on a mapped street would substantially alter and affect the surrounding community by nature of the impacts on traffic, storm waters, sanitary sewer, and, school seats;

Be it hereby resolved: Community Board #1 categorically opposes this application and recommends any development on this site which requires apportioning of the existing tax lot or the creation of internal roads be submitted as a ULURP application, so the proposed roads have a complete multi agency review and EAS, to be placed on the official map of NYC, and;

Be it further resolved: Community Board #1 rejects the applicant's claim for a procedural hardship waiver for the complete application since such a claim results in avoiding the process required to properly plan for the appropriate legal roadway design, as we are sure a purchaser with the development history of this applicant would be aware of the complexities of appropriate development of this environmentally sensitive site.

Residents voiced concerns on the steep slope and the effect it will have on homes and the hills below and major concern of disrupting the Serpentine Rock.

Mr. St. Jacques responded that this project will help drainage and disturbance below as retaining walls and dry wells.

In addition to the homes there're will be 2 sets of multifamily dwellings that do not require authorizations.

Assemblyman Charles Fall spoke against the proposal wanted the land purchased for Parkland.

Assemblywoman Nicole Malliotakis also opposed to the proposal has reached out to Savo Brothers as did Borough President Oddo, other elected officials and community residents. Savo Brothers are unresponsive, do not return phone calls and are unwilling to meet. The offer still stands to meet with the applicant the Assemblywoman informed the Applicants representative.

Many community residents spoke of the false asbestos report that was filed the inspector which was prosecuted for the false report. Improper removal of trees and buildings prior to permits issued. Rats running rampant from the property onto adjoining streets and properties.

In addition, residents spoke against the amount of homes being built due to traffic, unsuitable sewers on Fingerboard to handle the many new homes as well as the Port Richmond Sewer Treatment plant not being able to handle new buildings.

Concerns were also raised regarding the HOA how the streets will fall into disrepair, no oversight of the HOA will have to have private Sanitation and snow removal. (Sanitation will pick up on private streets if the HOA signs a waiver allowing them to remove without any liability to damage).

There are no school seats, schools are already overcrowded, no city hospital.


1. Transportation Committee meetings

2. Meeting re Goethals Bridge pedestrian / bike path

The Committee met on September 17, 2019 in conjunction with Mariner's Harbor / Port Richmond Local Area Committee, to hear how the NYC DOT plan to link the (completed) Goethals Bridge pedestrian / bike path to the city streets at Forest Ave.

The completed bridge path exits on the southwest side of Goethals Road N., which is often jammed two-lanes wide with tractor-trailers waiting to enter the New York Container Terminal.

The plan will be to build a sidewalk path north-westward on State property, make a U turn on Western Avenue, and built a path south-eastward on the northeast side of Narrows Road S. (which does not get backed up).

The new path will cross only one exit and one entrance of I-278 to join Forest Avenue at the I-278 underpass.

2. North Shore Bus Rapid Transit (BRT) - vote and action

The North Shore BRT is project by the MTA for a bus with frequent service from the ferry terminal along the (more or less) dedicated right of way of the North Shore Line to South Ave., then south on street to the West Shore Plaza.

Claiming engineering difficulties the MTA's proposed route sends the buses off the dedicated right-of-way and onto Richmond Terrace at Nicholas St. to the ferry terminal, making seven lanes of traffic, eliminating access to Borough Hall, the Mall, the ballpark, Family Court, the 120 Precinct, and the parking garages, and blocking parking, bike lanes, and bus stops.

At the June meeting, CB1 voted to send a letter of comment to the MTA, with copies to City and State elected:

'CB1 supports the North Shore Transit to enhance community development and reduce existing commute times. Except that ... CB1 urges continued planning and engineering to route buses and/or light rail completely off Richmond Terrace to the Ferry Terminal.'

Members of the Transportation Committee have been visiting electeds to seek agreement on this.

Please testify at the public Scoping meeting for the Environmental Impact Statement (EIS) on Thursday, October 17, 2019 from 6:00 pm to 8:30 pm at the Snug Harbor, Lower Great Hall, 1000 Richmond Terrace, Staten Island, NY 10301.
