Chairman Vincent Accornero called the meeting to order at 7:10 P.M. The following applications were presented:

Two applications have been submitted to the Board of Standards & Appeals, Application Nos. 2019-185-A and 2019-186-A requesting a waiver to allow construction of 2 two-family homes located partially within the bed of a mapped street at 47 Fletcher Street.

Mr. Tim Boyland showed plans and presented 47 Fletcher Street for 2-two family homes that is located partially within the bed of a mapped street which is a one-way street. The homes are in compliance with the low density rules, staying in line with other homes already there. There will be a shared curb cut with a 1 car garage for each property. Two parking spots plus 1 garage. Builders paving plan have already been submitted and waiting approval.

Drainage rain gardens, etc. are being prepared for submission to DEP and other city agencies. Plan to build Green. Owner owns part of Amity Street and the other lots around the property. There is no plan to widen Fletcher Street and house numbers have been issued. Three sons, two of them to live in the homes.

John Guzzo, Rosebank Chair said the street is not wide enough. Mr. Guzzo claimed there are plans for street widening. Parking complaints in the community already exist. Snow plows cannot plow at that location, cannot turn around. Would like to have Amity opened to Fletcher Street. Trouble turning from Virginia Avenue to Fletcher Street. Difficulty backing out of driveways. Only a partial curb.

Nicholas Zvegintzov – Getting complaints for traffic and foolish to be piece meal where there are possibilities to widen and to allow streets to be mapped.

Vincent Accornero – Transportation issue suggestions were made to build one house behind the other or a one-family house.

An application has been submitted to the Board of Standards & Appeals, Application No. 120-13-BZ for an extension of a previously granted variance at 1815 Forest Avenue, McDonalds. Drive thru has to go through BSA. Came 5 years ago and application was approved. Request for another 5 years.

John Guzzo - Brought up ponding in the rear of the property.

The operator of the McDonalds stated he had problems with the construction company and has not been able to have them alleviate any of the problems he has. The operator has a monthly service to suck out all drainage, road debris. Have to mulch, sand and mud buildup.

Condition of BSA for 5 years, special permit.

An application has been submitted to the Board of Standards & Appeals, Application No. 2019-198-A requesting a waiver to facilitation the change of use and enlargement of an existing three-story building to a three-story school which lies in the bed of mapped at 1390 Richmond Terrace. This application was not heard due to presentation not complete. Will be heard in the November Land Use Meeting.

Report of September 10, 2019

1. Transportation Committee meetings

No meetings during the summer.

Next meeting: Tuesday, September 17, 2019, 7 p.m., 250 Park Ave. Joint meeting with Mariner's Harbor / Port Richmond Local Area Committee.



The NYC DOT will 'discuss a proposal to enhance connectivity to the new Goethals Bridge bike path'. The NYC DOT will not connect to the (completed by the State) pedestrian / bike path on the Goethals Bridge without figuring out sidewalks and crossings.

2. Staten Island North Shore Bus Rapid Transit (BRT)

The North Shore BRT is now appearing as a project of the so-called 'MTA System Modernization'

(https://new.mta.info/system_modernization/northshorebrt).

'We are developing a Bus Rapid Transit (BRT) system between West Shore Plaza and the St. George Terminal. BRT will provide faster, more reliable travel along Staten Island's North and West Shores. BRT was the recommended option as part of our Alternative Analysis process. We are beginning the environmental review process...'

It is a bus with frequent service from the ferry terminal along the (more or less) dedicated right of way of the North Shore Line to South Ave., then south on street to the West Shore Plaza.

Claiming engineering difficulties the proposed route sends the buses off the dedicated right-of-way and onto Richmond Terrace at Nicholas St. to the ferry terminal, eliminating parking, bike lanes, and bus stops.

At the June meeting, CB1 voted to send a letter of comment to the MTA, with copies to City and State elected:

The MTA will hold a public open house to present the alternatives to be studied, 5:30p.m. - 8p.m. on September 25, at the Elks Lodge, 3250 Richmond Ave.

4. Other announcements

- Residential loading zones being piloted for a year on Richmond Terr. between Westervelt Ave. and Jersey St., and on St Marks Pl. between Fort Pl. and Wall St.
- Fall bus changes: Very slight improvements of service on the S53 (weekdays) and the S46 (Saturday), and cut-back service on the S74 and S78 on Sunday.
- Speed cameras (as of July 11 2019): Up to 750 allowed at any one time in NYC, 1/4 mile radius around schools, operating year-round weekdays 6a.m. to 10p.m.
