A Land Use Public Hearing was held prior to the Board Meeting. Land Use Chairman Vincent Accornero called the Public Hearing to order at 7:06 P.M.

1. Department of City Planning Application No. N 130084 ZAR - Forest Avenue Shoppers Town Retail Expansion -1565 Forest Avenue — in connection with a 1-story, approximately 8,000 square-foot enlargement of an existing retail development — reduction of the parking requirements, modification of the landscaping provisions.

Mr. Ethan Goodman showed plans of the proposal. There are plans to demolish the building where Wholesale Liquidators was and the 3 stores directly beside and build a brand new Stop and Shop. There are currently 764 existing spaces, the applicant is proposing 770 spaces. There is ample parking for the Stop and Shop and other stores in the plaza. A comprehensive reconfiguration and upgrading for the existing parking lot is proposed. In addition, there are proposed changes to add perimeter landscaping and interior planted islands complying with the landscaping requirements. There are also plans to modify the two easternmost existing curb cuts on Forest Avenue by eliminating one curb cut and landscaping that area, and reducing the width of the other curb cut. Another existing curb cut on Barrett Avenue will be reduced in width to 20 feet. Lastly, the application requests to legalize the existing 13,360 square-foot building housing the CVS drugstore.

The loading dock will be fully enclosed.

There were some concerns of the trucks coming in the back of the store.

Full plans are on file at the Board Office.

Motion made and seconded to approve as submitted.

Roll call vote taken. Vote passed unanimously.

2. Board of Standards & Appeals Application Cal. NO. 58-13-A – Appeal to the Board of Standards & Appeals to permit construction of a twelve-unit residential building located within the bed of a mapped but unbuilt street on Wiman Place, Rosebank.

Mr. Todd Dale, representing the applicant explained that at the present time, Wiman Place is partially and irregularly paved and improved at the subject location, providing access between Sylvaton Terrace to the north and Church Lane to the south. Plans for the proposed development call for widening this paved and improved portion of Wiman Place to a width of 38 feet, maintaining and substantially improving the existing access between Sylvaton Terrace and Church Lane. It is proposed to develop a cellar and three-story, twelve-unit residential building with 10,244 square feet of floor area. As per the zoning regulations, proposed building will include 8 accessory off-street parking spaces, 7 will be located in the cellar of the proposed building.

Rosebank Chairman, John Guzzo had concerns regarding the amount of parking spaces that are being provided and, what the apartments were going to be, studios, one bedroom.

Mr. Accornero said that what the apartments are going to be is not part of the application, and the parking that is proposed is what is required by the zoning.

Motion made and seconded to approve the application with the condition that the building footprint be reduced and parking be increased to a 1 spot to 1 unit ratio.

Roll call vote taken, vote passes.

3. Board of Standards & Appeals Application No. 2-13-BZ — Application to legalize extension for retail use in a residential district at 438 Targee Street.

Mr. Durate, representing the applicant stated that the variance application is to legalize an enlargement that was made to the existing one-story building on the site prior to 2001. It is proposed to allow the owner of the Use Group 6 food store that occupies the legal part of the building to create a new retail use in the now vacant enlargement. The site is in a R3A District. The enlargement was made prior to 2001 when the current owner bought the building. The enlarged portion contains approximately 563 square feet of floor area.

Mr. Larry Beslow said his committee reviewed the application but left it up to the decision to the Land Use Committee.

Questions were raised as to what the enlargement would be used for?

The owner was unsure what the enlarged portion would be used for since it is not legal right now.

Mr. Accornero reminded everyone that the use is not a factor of the application and, whatever would be put there would have to follow the same rules as a Use Group 6.

Mr. Ogbewele asked that the application be tabled until the next Stapleton/Clifton/Concord Area Committee Meeting for more information.

Roll call vote taken, vote passed to table to the next Stapleton/Clifton/Concord Area Committee Meeting.

<u>FIRST VICE-CHAIRMAN, ANTHONY COSENTINO</u> —Mr. Cosentino read the following letter regarding our responses to the proposed FY 2014 Budget which was included in everyone's packet: Dear Mayor Bloomberg:

Staten Island Community Board 1 would like to present you with our comments regarding your proposed FY 2014 Budget.

Recognizing That New York City is under fiscal constraints, we are limiting our comments to six significant matters.

- 1. Relocation of Sanitation's District 1 garage to Fresh Kills while the response indicates the Agency's willingness to accomplish the move, there has been no funding provided to make the move happen. Considering that the garage was to have been relocated a decade ago and considering that the FY14 budget contained funds for garages to be built both in Manhattan and Brooklyn for more than \$120 million dollars each, it is unfair to continue to burden the economically depressed Jersey Street community with this facility; moreover, it is environmentally unjust to make this community endure the garage's continued presence when the City has ample room to relocate it to free City-owned property at Fresh Kills a move that would provide a new machine shop and combined Sanitation District 1/3 facility. Realizing that it would cost DOS approximately \$76 million dollars (as stated by DOS by email to Councilmember Rose) for Staten Island to receive a combined facility that would benefit two service distribution areas and a machine shop that would benefit the whole of a borough while also removing a potential health hazard; economic deterrent and traffic obstacle from an area that DCP considers pivotal for economic development in its recently released North Shore Study should compel you to fund this site of the SI District 1 Garage immediately.
- 2. Implementation of Drainage Plans the response indicated the Agency needs further study of the issue but considering that SICB1 has met with, discussed and proposed this for 20 years, the Agency's response is incomprehensible. The impact of inaction over these years can be seen along Forest Avenue where businesses have been severely damaged by rain water, especially Afternoon's; the Coffee and Tea Market; Café Milano; Yogurberry; Kyoto Sushi; Randall Manor Pharmacy; Andrea S. Morse, Esq.; Always There Respiratory Care; Pretty Woman; JJ Nail Salon; The Country Mouse (which had to close for one month; and, SI Bank and Trust (which closed for one week). These selected examples do not speak to the residential damage or the damage to the streets and sidewalks that the lack of storm sewers cause, nor did the damaged endured by areas such as Victory Boulevard. In order to provide economic viability along this retail corridor, we request that you direct your agency to fund this project in full.
- 3. Purchase the old hospital campus at 101 Castleton Avenue for mixed use development incredibly, this also evinced a response of "further study by the agency." The Agency has been managing this property for two decades during which time the property has slipped into dissolution and revered Staten Island landmark was destroyed. Much like the relocation of the Sanitation garage, the inattention to this property continues to depress the economy and social structure of the nearby Jersey Street community, therefore we request that you direct your agency to fund this request in full and

begin legal action to acquire this property so that It can be developed in an historically sensitive and sustainable manner.

- 4. Increased funding for Parks every one of our requests to fund park projects have been answered by the agency recommending we seek Borough Presidential or City Council funding. Considering that Staten Island contains 7,523.172 acres of parks and is expecting to add another 2200 acres with the creation of the Fresh Kills Park and that the Bronx contains 7,085.176 acres, Brooklyn contains 4,562.263, Manhattan contains 2,732.408 acres and Queens contains 7,272.669 acres, it is unconscionable your agency would be directing us to our local elected officials to seek funding for upkeep when we are the borough with the most acreage and the smallest budget. We therefore request that you direct your agency to fully fund all of the parks items requested by CB1 including the North Shore Greenway Trail and Luis Lopez Park.
- 5. Now that all the Rosebank parochial schools are closed and the pressures on the already overcrowded P.S. 13 have been ramped- up, the children of this large and growing community need to have access to a public library to ensure that they have equal educational opportunities commensurate with all our other CB1 communities.
- 6. Install Smart Lights along bus routes on Forest Avenue, Victory Boulevard, Castleton Avenue, Clove Road, Bradley Avenue, Jewett Avenue, Bay Street, and Hylan Boulevard to facilitate the movement of traffic.

Staten Island has consistently received the smallest piece of the budget pie even though we are the fastest growing borough of the five and our per capita income is the highest in New York City. We respectfully request that you reevaluate your responses to the above items and direct your agencies to fund them fully.

Thank you for your attention to this matter.

The scope of work includes site utility upgrades, radiant heated floor slab, and exterior modifications including decorative entrance doors, brick paving, metal fencing, trees and a bike rack. The existing cellar space will also be renovated.


