Board of Standards & Appeals Application No. 340-04-BZ – 1579 Forest Avenue, Amendment to a variance previously granted permitting construction of a new drug store (Walgreen's) without required parking to allow change in u se to a food store (Top Tomato) with different parking requirement.

Mr. Todd Dale presented the application – concerns were raised that other Top Tomato stores parking is inadequate and not enough handicap spots, garbage –placement and deliveries.

Board of Standards And Appeals Application Nos. 2016-325 thru 2016-328 BZ - 61, 67, 69 and 71 Elvin Street - Variances requested to allow for the construction of four two-family attached homes (8 units) contrary to use regulations ZR 22-12 and to allow for a portion of the required parking to be located within the prolongation of the front building wall line contrary to ZR 21-622-61.

Mr. Steven Simicich presented the application – there were major concerns raised about traffic and housing style.

Motion to deny development due to lack of non-arterial access and housing style and density contrary to existing neighboring development and projects of the LDGM, recognizing that the as-of-right development would provide a reasonable return to existing ratio.

Roll call vote taken, vote passed Land Use Committee to deny application unanimously.

Borough Commander Kenneth Corey the new Commander addressed the Board. Commander Corey looks forward to working with everyone and reminded everyone if you see something say something. In attendance was also Deputy Inspector Matthew Harrington who Commander Corey mentioned he is excited to see the new NCO expanded to the 121. The program is already active in the 120 Pct.

Chairman Siclari introduced the new Commander of the 120 Pct. Deputy Inspector Isa Abassi. Deputy Inspector Abassi concurred with the previous comments by the Borough Commander.

One item in particular was brought to the attention of Deputy Inspector Abassi was the parking in front of the 120 Pct.

The Deputy Inspector mentioned he is aware of the problem – he understands that this was occurring before the Wheel and Outlets were being constructed – he will curtail the situation and try to find a solution to the parking in front of the Pct.

A Certificate of Recognition was given from Borough President James Oddo, Councilmembers Debi Rose and Steven Matteo and Assemblyman Titone to Samantha Salvatore for saving the life of a 9-year-old girl was able to go home to her family thanks to the instincts of Samantha Salvatore, a physical education teacher at PS 78 in Stapleton who save the student who was choking on a hamburger.

Ms. Sue Ling Lee, NYC Health and Hospital Corporation spoke of the Gotham Health primary care facility at Tompkins and Vanderbilt Avenues. This will be the first full service primary care practice established by NYC HHC in Staten Island. The building, which is a modular building is almost completed. HHC will be hiring staff for the facility very soon and the facility would open.

Question was raised regarding the buses from the Hungerford School that line up along Tompkins and Vanderbilt Avenues to drop off and pick up students. Ms. Lee stated that HHC plans to work closely with the school regarding the school bus situation and, are well aware of it.
