Report of March 13, 2018

1. No meeting in February or March

2. Transit

CB1 motion approved...

To urge the MTA to install the Express bus changes, start the indepth Staten Island bus study, and improve cross-bridge transit.

Approved unanimously by Full Board on February 15 2018 (see minutes).

The Express Buses are coming

This MTA project cuts Express Bus time wandering Manhattan and Staten Island, to make more / quicker service on the express part.

Actual routes have now been proposed (after public input). No schedules yet.

MTA will hold an Open House 6p.m. Thursday, March 22nd, at the All Saints' Church. The Chair will attend, plus other Transportation Committee members, but no formal meeting.

Implementation possible by August 2018.

Savings in traffic time will be ploughed back into more service.

Bus Turnaround Coalition

... is a coalition of transportation groups pushing for fast and reliable bus service to all Boroughs (http://busturnaround.nyc/#15).

Its Bus Report Cards show that, while bus riding in Staten island is rising (unlike in other Boroughs), three of the City's worst routes for unreliability are in Staten Island:

- -The S44 (serving Richmond Ave and the Mall)
- -The S46 (serving four schools, and the Teleport offices and hotels)
- -The S52 (a rare cross-island bus that links the North Shore and the South Shore and serves Staten Island University Hospital).

Ferries back in service

Rush hour service on the Staten Island Ferry was cut back while two of the large ferries were out of service.

The 53-year-old F.B. John F. Kennedy returned to service on March 8 2018, after the Ferry shop machined some no-longer-available parts.

'Regional Connectivity to New Jersey / A New View'

The Staten Island Economic Development Council (SIEDC) floated a new Policy Paper.

One of three goals:

'3. Develop additional local and regional partnerships to increase public outreach and education on the benefits of critical projects including the West Shore Light Rail, SI Gondola and other multimodal options for bi-state travel.'

Car share

'In line with recent City Council legislation, the NYC Department of Transportation is launching a two-year citywide pilot to designate about 300 parking spaces in municipal parking facilities and 300 parking spaces on-street in select neighborhoods exclusively for the use of carshare companies.' (http://nycdotcarshare.info/)

The CB1 sharing areas are the Municipal Courthouse Carpark on Central Ave and the St. George Ferry Terminal South Municipal Parking Field.

'The New York City Housing Authority has partnered up with Zipcar to bring you discounted weekday driving. Plus the application fee is waived, so you get a discounted annual membership.'

A survey by City Harvest shows that many CB1 residents do their 'big' grocery shopping by bus and car services.

3. Streets

Traffic light coming at Targee Street and Laurel Avenue

Installation will be performed by contract and the work is tentatively scheduled to be completed by June 30th.

Speed bumps coming to Park Hill

Park Hill between Osgood and Roff, and on Park Hill between Roff and Sobel and than 2 more between Park Hill and Palma Drive.

Staten Island Ferry Terminal Bicycle and Pedestrian Improvements

The SI Advance managed to make two attacks in February on this complex plan for the Richmond Terrace / Bay St / Ferry Terminal intersection (not yet complete):

- A front page 'news story' 'Bike lane reconfiguration near St. George ferry terminal: A recipe for chaos?', (http://www.silive.com/expo/ERRY-2018/02/b70dd91aad/bike lane reconfiguration near.html), February 10, 2018.

- An editorial 'Most dangerous bike lane ever? It might be this daredevil one', SI Advance, February 24, 2018.

Both complained about bicyclists crossing traffic, ignoring the fact that this intersection has 10 traffic flows (11 when Lighthouse Point opens). The question is not that traffic flows will cross each other, but how to channel them.

The new proposal was endorsed by CB1 on June 17 2017.

LED street lights coming throughout Staten Island this year This will hopefully light up some under lit stretches, e.g., Jersey St, where there are presently 5 temporary NYPD lights.
