- Required Fair-Share standards are met in the siting of any projects operated or funded by the City, or directly under the auspices of any City, State or Federal Agency;
- An accurate and current census of Federal, State, or local programs in the proposed siting district(s) is provided;
- Clear and readily accessible publication of the algorithms, metrics and all other information used to determine the location of proposed sites in real time is supplied to the local community as provided for in the Fair Share Criteria and/or at least 90 days prior to the construction, purchase or leasing of any structure that is proposed to be used for such purposes; and
- Adequate community notification and involvement is performed, at the very least compliance with the New York General City Law Section 66 (Open Meeting Rule)

At the West Brighton/St. George Area Committee Meeting, letters of objection were submitted by Mr. Joe Dicks asking the State Liquor Authority to deny the liquor license for the Corner House, 427 Forest Avenue if the application has not been approved as of yet. Almost all of the letters submitted, (which was a form letter with room at the bottom of the page to insert comments) was to deny due to no parking and the other establishments in the immediate area. The item was tabled at the meeting. Mr. Dicks also noted there was not a quorum at the November Area Committee Meeting when the application was heard and approved.

It was noted that Mr. Dick's bartends at Jody's Bar located up the block at 327 Forest Avenue.

It was determined that the Corner House on Forest Avenue, 427 Forest Avenue did submit their application to the Liquor Authority, it has not been put into their system. The Steering Committee agreed that in November the motion to approve the liquor license was reviewed by the Executive Committee since there was no quorum. The Executive Committee determined that that the approval by the area committee was valid. The Steering Committee determined that the original approval stands as is.

This initiative seeks to mitigate the impact of the transport of goods – primarily by truck, through, and within, our city. Staten Island, with our maritime resources (Howland Hook) and nascent rail line connecting the container-port, and recent and continuing development of large-scale distribution centers, must play a role in this effort.

Mayor DiBlasio forecasts 5,000 jobs will be created, "many in Sunset Park [Brooklyn]" – Staten Island maritime stakeholders should take the "Maritime Support Services Survey" to ensure an accurate picture of our interests. See https://www.surveymonkey.com/r/maritime-support-services-survey.

Comments for EDC consideration:

- *the new connections for trucks coming off the Goethals Bridge are good, but there remains no plan or method to keep over-sized trucks off local streets;
- *lack of enforcement of "last mile" requirements
- *no provision of rest areas for truckers; trucks parked on local streets overnight
- *Staten Island bulkheads in a sorry state of disrepair
- *very few potential ports for commercial use too shallow
- * maritime study program is currently in development (EDC is aware of this); could be combined with apprenticeship training programs; large vacant commercial space along the waterfront should be considered [as well as Snug Harbor].
- *the Bay Street Corridor rezoning should be re-conceptualized to preserve maritime applications and employment, rather than focusing exclusively on residential with a limited number of building maintenance and retail positions.

The Labor Committee will met with EDC again, following the release of the quantitative and qualitative summary of survey responses, reflecting jobs, services, and industry sentiments.

FILE COMPLAINTS - use 311 AND NCOs. Our civics hear about problems at every one of our meetings... but when asked for complaint numbers, we discover no one has called it in, details are vague: this is not the way to resolve problems.

Accountability, via precinct Community Council meetings and the NCO Build the Block meetings was discussed... try to get an official delegate from your Association to attend and report back to your group. The 120th Community Council meetings are held the 4th Wednesday of the month, 7pm; the 121st meets on the 2d Wednesday at 7pm.

The need for changes to, and additional, regulation/legislation was discussed- here's what's pending in the City Council. Consider a letter of support to your Council member!

INT 1130-2018: prohibit commercial establishments from parking vehicles on city streets as part of their business. This would include auto body shops, mechanics, car rental businesses, and gas stations, who use street parking for the purpose of dropping-off, picking-up, inspecting, storing, repairing, servicing or displaying a vehicle for sale, lease or rent.

INT 708--2018: require that used car dealers and operator of garages and parking lots obey parking rules that prohibit parking on sidewalks and crosswalks. In the event of repeat violations, DCA would have discretion to suspend or revoke the entity's license to operate in the City.

INT 1141-2018: prohibit any city agency from agreeing to reduce fines for parking violations in exchange for a waiver of the right to contest parking violations. It would also require that any

dismissal of a parking violation or reduction of a fine, other than for certain technical reasons, would require a hearing on the merits of each charge and a written determination by an administrative law judge.

Other actions for consideration:

***311 calls/slow response time - impact on effective enforcement is significant. We will ask Borough Command to consider flagging "hot spots" for non-complaint driven enforcement.

***Trucks on non-truck routes; the influence of WAYZ - "social navigation tool for private cars. Because of that, we don't currently support navigating in lanes dedicated to public transportation, bicycles or trucks." Tell them that truck routes need to be considered at https://waze.uservoice.com/forums/59223-waze-suggestion-box

***Anti-idling enforcement: NYC fines for 1 minute+ in school zones, 3+ minutes elsewhere. NYC has, essentially, a "bounty" program for citizen-complaints – see http://www.nyc.gov/html/dep/pdf/air/citizens-air-complaint-form.pdf. Enforcement is difficult – however, document complaints via. 311 to show a pattern; Agencies prefer to expend their limited resources when they have a good chance of actually taking action. Again: urge your members to call 311; save up the reports. Your Council member's constituent services staff can help arrange action by DEP.

NOTE: refrigeration trucks are exempted from the idling laws – however, commercial vehicles are only allowed two hours on a City street, and "reefers" and trailers without a cab are not allowed at all.

Many issues are attributable to failures in planning and infrastructure design. The development and support of businesses requiring heavy trucking is contrary to our neighborhood realities of narrow streets and existing residential uses juxtaposed with intensive commercial operations. These developments rely heavily on State incentive programs; State Comptroller DiNapoli and newly elected Assemblyman Fall may provide assistance. Truck access, particularly difficult for oversized 53 ft. trucks, brings traffic to a standstill, despite reconfigured parking/standing regulations. Further, truck maneuvers over sidewalks leave homeowners liable for repairs.

We have requested a presentation from the Department of Transportation on how the Agency makes planning decisions. We have also asked for a report on the control of street-use permits for oversized vehicles.

Health/Human Services - Update, February 2019

Amy Poirier, Chairwoman

Met with Sue Ling at Gotham. We have connected her with 6 community based programs that are interested in using Gotham for Health Care. Made a formal introduction. Now it is up to them to follow up.

By the end of March, they will have 2 interns, 2 pediatricians, 2 OBGYN's, as well as agreements with both Staten Island Hospitals and RUMC, which is important because as of now, they have ability to see a patient through a pregnancy and delivery.

The Breast Cancer Center is up and operating with Dr. Wilson who will be able to do reconstructive surgery also. Their Mammogram Department is still seeking workers for the new center on Clove and Victory.

They have an additional out-patient facility which is located on Forest Avenue within the Western Beef Plaza.

Family Practitioners are being interviewed so they can have two of them. There is one with an offer on the table, however this physician has another offer on the table from an additional practice.

They have a Diabetic RN who has an intense program up and running. It focuses on High Blood Pressure and Diet. These visits take place between doctor appointments so that the patient has ongoing contact with the team.

The goal for Gotham is to become a Primary Care Center.

Once the patient numbers build up, they will adjust the hours to meet the goal that is anticipated next year.

CB1 is hosting a Plant-Based/Vegan/Vegetarian Pot Luck Educational evening on Thursday, April 25^{th} at 7pm at Christ Church, 76 Franklin Avenue.

CB1 is hosting a drug awareness evening on Tuesday, April 30th at Christ Church, 76 Franklin Avenue. This is in partnership with CCRB who will do a presentation with a focus on teen drug and misdiagnoses. Our DA's office will be there to do a NARCAN training and to provide supplies. Gotham Medical will be present for the program and walk in options they offer.
