P.O. Quoins Rios introduced herself as the new Community Affairs Officer from the 120 Pct. who is working with P.O. Salvatore Gianino. Officer Rios left her business cards and announced she will be here for the remainder of the meeting if anyone had any questions or issues in their community.

Mr. John Guzzo, Chairman of the Rosebank Area Committee stated the residents are still having trouble with Locale at 1221 Bay Street. Patrons of the club are coming out causing disturbances, especially Friday and Saturday nights. During the evening mostly after between 1:00 A.M. – 2:00 A.M. patrons are coming out of the club, sitting on steps of homeowners, urinating on public property and a car is pulling up with a full bar in the trunk of their car serving alcohol to underage and patrons of the bar. It is total chaos around 3:30 A.M. -4:00 A.M. when the patrons are leaving.

Ms. Cynthia Lane, Barker Street Block Association spoke of a home on Barker Street that is selling drugs.

EXECUTIVE COMMITTEE REPORTS

<u>FIRST VICE-CHAIRMAN, ANTHONY COSETINO</u> – Mr. Cosentino welcomed everyone back from the summer break.

<u>SECOND VICE-CHAIRMAN, CHRISTOPHER ROONEY</u> – Mr. Rooney welcomed everyone back and looks forward to working with the functional committee chairs to have another productive year.

<u>THIRD VICE-CHAIRMAN, FRIDAY OGEWELE</u> – Mr. Ogbewele welcomed everyone back and looks forward to working with the area committee chairs and thanked them for their cooperation last year.

TREASURER, LARRY BESLOW – The Treasurer's report is in the packet.

SECRETARY, NICHOLAS SICLARI – Wishes we were still on summer break.

CHAIRWOMAN, LETICIA REMAURO – Chairwoman Remauro gave an update of all of the work that was done over the summer break. Anthony Cosentino, Anjail Ameen-Rice and Vincent Accornero had attended meetings regarding Port Richmond Avenue, working with the community, merchants and Police Department. Councilmember Debi Rose and SI Elected Officials, Ajmal Chaudhry, Sean Sweeney and Joseph Carroll were able to have the sanitation maintenance facility portion moved from Jersey Street to trailers at the Fresh Kill site. This will free up space in the garage to have all the truck inside of the garage. Linda Eskenas and the Greenway Committee worked diligently to have the Greenway trail recognized and incorporated by many City Agencies into the Waterfront Plan.

Chairwoman Remauro thanked the Staten Island Downtown Council, Ken Tirado, Resident of Bay Street Landing, and everyone who helped, visited and enjoyed the former Coast Guard site over the summer. Permits were secured hold many events every weekend. We are working on extending the permits and to use the building for events in the cooler weather.

Chairwoman Remauro urged everyone to attend the MTA Public Hearing on Fare Hikes on September 16, 2010 at the St. George Theatre.

The Borough President has developed a proposal that could spare SI not only higher tools and fares but also restore much needed service reductions.

By charging \$1 to all cash payers and not increasing E-Z Pass rates to all MTA facilities. This board has supported our commercial retailers here on Staten Island that does not get discounts.

Due to other obligations Mr. Sean Sweeney has stepped down as Transportation Chairman. Ms. Jeanne Hogan will be taking over the Chairmanship.

Lastly, Chairwoman congratulated Joseph Carroll on the recent marriage of his step daughter and our own Youth Chairwoman Marilyn Brown.

PARLIMENTAIRAN, JEANNE HOGAN – No report.

<u>DISTRICT MANAGER, JOSEPH CARROLL</u> – Mr. Carroll announced Ms. Camille Zarrelli did the flower arrangements and they were beautiful.

Chairwoman Remauro asked everyone to research their request as far as what agency it should go to and get a recent estimate of cost of a recently funded similar request and have it available for the Budget Public Hearing. It is important for us to submit our request with as much detail as possible.

FUNCTIONAL COMMITTEE REPORTS

<u>LAND USE, VINCENT ACCORNERO</u> – The following resolutions were presented on behalf of the Land Use Committee, seconded, discussed and voted on as follows:

1. 15 Irving Place – Board of Standards & Appeals Application No. 855-87-BZ – request to permanently remove the term of a variance.

Community Board #1 recommends an extension for a term of 20 years from the date the current variance expires in November 2013.

Roll call vote taken - Motion passed 23-4-0.

2. 252 Victory Blvd. – City Planning Authorization No. N 100324 ZAR - to develop a multi-family building with 15 units and 23 parking spaces within the Special Hillsides Preservation District.

Community Board #1 approves authorization with the condition that there are planted green roofs.

Roll call vote taken- Motion passed 15-14-0.

3. Victory Blvd. residential Development e/s north of Cebra Avenue – City Planning Authorization No. 020670 ZAR – to facilitate the development of a 3-story, 2 family detached residential buildings (two side-by-side one family dwellings).

Community Board #1 approves authorization with the condition that there are planted garage roofs (which is the terrace and entrance to the home).

Roll call vote taken, Motion passed 16-13-0.

4. 25 Sunrise Terrace – City Planning Authorization No. N 090398 ZAR – to authorize development in steep slope and modification of lot coverage controls in order to construct a new detached single-family home within the Special Hillsides Preservation District.

Community Board #1 **denies** authorization because the existing structure substantially exceeds lot coverage.

Roll call vote taken. Vote passed to deny authorization 28-1-0.

Mr. Accornero explained the Hillsides Preservation District was put in place not to stop all building in the district but to put restrictions such as lot coverage, height, and tree replacement and trigger reviews by the community board and city planning.

<u>BUDGET & FINANCE, ANTHONY COSENTINO</u> – Mr. Cosentino announced the Budget Public Hearing which District Manger, Joseph Carroll previously spoke about is on October 7, 2010 – 8:00 P.M. at the Board Office.

<u>WATERFRONT, CURT WARD</u> – There was no meeting. The next is on September 28, 2010 at 7:00 P.M. at the Board Office. Mr. Ward thanked Linda Eskenas and the Greenway Committee for their hard work on the resolution passed in June on the Greenway Trail.
