Pledge of AllegianceSecretary Camille Zarrelli took roll call attendance.A quorum was present.Motion made and seconded to accept February 2008 Board Minutes. Motion passed unanimously.

The Elected Officials representatives present introduced themselves.

## **OFFICERS' REPORTS**

**FIRST VICE-CHAIRWOMAN, SHEILA McGINN** – The minutes of the meeting are in the packet. Two letters will be sent out on behalf of the Silver Lake/Sunnyside/Westerleigh Area Committee not supporting renewal of a beer license for MBQ Superette at 956 Richmond Avenue and a liquor license for Danny Boy's Tavern located at 1815 Victory Blvd. The letter which is sent to all applicants for new and renewal licenses inviting the applicant to the respective area committee meeting will be tweaked to make it more friendly and to the applicants benefit to attend the area meetings.

Since there was not a quorum at the Mariners Harbor/Port Richmond area committee meeting all motions made at the meeting will be sent via letter.

- 1. Invite the Department of Health to the next area committee meeting.
- 2. Letter to the Department of Investigation asking them to examine the process by which the health code violations are reviewed by the DOH in order to determine whether or not there are unfair practices taking place.
- 3. A request will be made to the Department of Health asking for a Department of Health Building on S.I. or at the very least have the Department of Health hear health code violations on Staten Island at least once a week. Health Code violations have to be heard at 66 John Street.
- 4. On a separate topic, a letter is to be sent to local representatives: Assemblymen Matthew Titone and Michael Cusick, and Senators Diane Savino and Andrew Lanza to request the NYS Parks Department take over and maintain the Graniteville Quarry because the land is not maintained properly by the NYC Parks Department. The letter should include a request for a better fence and lighting.

Page three of the Mariners Harbor/Port Richmond Area Committee Minutes were not included in the packet.

The school that is mentioned under the Clifton/Concord/Stapleton Area Committee of the Steering minutes in reference to the 500ft. law is Immaculate Conception not Emmanuel Lutheran School.

# THIRD VICE-CHAIRMAN, GEORGE WONICA, JR. – No report.

**SECRETARY, CAMILLE ZARRELLI** – There was an Executive Committee Meeting prior to the Board Meeting tonight. The minutes will be included in the packet next

month. Ms. Zarrelli reminded the members, if they are unable to attend a meeting area, functional or board meeting please e-mail the office and the chairperson of the committee. It is important to know if there will be a quorum at the meetings.

<u>CHAIRMAN, SEAN SWEENEY</u> – At this time, Community Board #1 does not have a Treasurer. Daniel McOlvin resigned last month.

Next month a Call for Candidate Form will be mailed with the April Meeting notice. If anyone does not receive a form, please call the Board Office. Nominations will take place at the May Meeting. Anyone who has been a member for one year and a member in good standing can apply for a position on the Executive Committee. Chairman Sweeney urged anyone who wants to run for any of the Executive Committee positions to submit their name.

Community Board #1 and its members have accomplished many things over the last year. Chairman Sweeney announced:

The first K-8 school is being built on Regis Drive and will be named the Charles A. Langere School.

Mr. Beslow and the Clifton/Concord Stapleton area committee can boast about an early childhood learning center in Stapleton.

The Public Services and Land Use committees are proud of a new building and location for the 120<sup>th</sup> Pct. on Hill Street.

A new 121<sup>th</sup> Pct. is going to be in the Mariners Harbor Area.

Mr. Beslow single-handedly worked on a temporary but working fix for the flooding in Park Hill on Osgood Avenue. We are working on a permanent repair.

With the help of Ken Tirado and Chief Marra, we have gotten approval to have traffic control agents along Clove Road for the endurance of the Clove Road sewer project.

Dominick Lambert, Linda Eskenas and Daniel McOlvin got the train rolling for us that is now known as the north shore freight line.

With the help of Curt Ward and Terry Player we have approved new cranes for Howland Hook.

Vincent Accornero, Chris Rooney and Curt Ward have been instrumental in the development deal that saves the Lighthouse Museum.

With the help of Land Use led by Vincent Accornero, Chris Rooney and Leticia Remauro we have attached LEED requirements to all land use projects.

Debi Rose and Lisa Lattanzio have worked together and have been helpful in bringing to fruition two Federally Qualified Health Care centers, one in Port Richmond and one in Mariners Harbor.

Curt Ward and the Mariners Harbor Area Committee are pressing for an agreement to have the new mega cement importer improve Richmond Terrace and Morningstar Road.

John Guzzo the Chair of the Rosebank Area Committee and the advocate who never says no to his community has represented this board at one brownfield clean up and one natural disaster this past year.

Anthony Cosentino stepped to the plate with the Jersey Street Sanitation Garage. Now, if we could get our City's finances in order he will be there to free that neighborhood of its decades old burden.

West Brighton Area Chair Megan Delmar has met with the anger of commuters who rely on the MTA with a positive response and continued efforts on their behalf.

Chairman Sweeney thanked all the Area and Functional Chairs for their silent but great work.

To the new members who are no longer rookies and are slowly finding their voices, thank you and don't give up.

"Tonight I am pleased to say that I have a major announcement. We have heard much talk about a website for Community Board #1 and now we are about a week or two away from its launch. We have asked DOITT for their help and they have responded. I have asked a few members to be the core WEB committee and they are: Marilyn Averett, Ken Tirado and Camille Zarrelli. Combined they are a force. They will assist Leticia Remauro with decisions about content and design. The website will assist the office staff by having a 24-hour presence for our community. We will post minutes and the CB1 by-laws to further our transparency on the north shore. The site will have links to all City and State Agencies. I will be asking the Youth Committee to host a photo contest for children of the north shore. Winners will have their photographs posted on Community Board 1's new Website."

Mr. James Powell, Vice-President of Patient Services, Staten Island University Hospital was asked to speak last month in honor of Black History Month but, due to the weather last month, we have asked Mr. Powell to speak tonight. Chairman Sweeney introduced Mr. Powell.

Mr. Powell thanked the Board for having him. Mr. Powell told a story of a man named Sam.

"Sam was raised by his mother and grandmother. To this day Sam has never seen his father, nor has anyone ever communicated to him about his father. In the early years, Sam never saw the inside of a school; he was the man of the house because he was the oldest of three brothers. At 12 years old Sam worked in the field as a sharecropper along-side men twice his age from sun up to sun down. Sam did not want to work in the field; he wanted to go to school. Sam's mother sent him to live with his aunt in New York City. Sam went to school on a regular basis and reached out to the other students for help because he lacked the knowledge needed to excel.

Sam got a part-time job in a drug store. He delivered medicine to the town's people. When he was not working at the drug store, he was unable to go into the store and buy a fountain soda because of the racism that existed. The owner of the drug store cared alot about Sam and constantly said if people are nice to you than there is something in it for them. He said "go forth young man and get as much education as you can. There is only one person standing in the way of what you want and that is you." Sam graduated from High School and landed a job at Chock full of Nuts. While working at Chock Full of Nuts he met Jackie Robinson. He developed a relationship with the famous Jackie Robinson. Sam's license plate will forever have Jackie Robinson's number of 42. Jackie Robinson urged Sam to enroll in college. Sam took that advice and after a few years he received an associate degree in hotel technology.

While Sam was getting his shoes shined one day in the Terrace hotel lobby at 125th Street and 7<sup>th</sup> Avenue, Malcolm X sat beside him. Sam spoke with Malcolm X. Sam did not believe many of the beliefs of Malcolm X and did not join his Temple, but, Malcolm X told him you can not love others before you love yourself.

Sam landed a job as a Supervisor in a New York Hospital, while attending College for his Masters Degree.

Sam currently works as Vice-President of Patient Services in a very well known Staten Island Hospital."

"I am Sam."

Chairman Sweeney introduced the Susan Wagner High School Dispute Resolution Team.

Mr. Anthony George a teacher explained the program is a peer conflict resolution program and one of the first things the students are taught when they enter the program is find your voice, use your words, you have choices in life. The students are in the program for three years, from their sophomore year until they graduate. The team has performed at Day Against Hate at Petrides, and at the U.N. The team will be performing again tomorrow at the U.N.

The students attending tonight are: John Doyle, (George Doyle's grandson), Deanna Norbiga, (Sean Sweeney's niece), Jessica Livan and Eric Held.

The students expressed gratitude to the program and the things they have learned and accomplished such as being able to communicate with their family, their peers. The program has taught them to be tolerable to stand up for themselves and not to sit idly by amongst other things.

#### FUNCTIONAL COMMITTEE REPORTS

**SANITATION GARAGE SITING COMMITTEE, ANTHONY COSENTINO** – Mr. Cosentino reported the board office is going to send an e-mail to Mr. Dan Klein, Director of Real Estate, Department of Sanitation for a complete update of the new Sanitation District 1 garage in light of the recent article in the S.I. Advance that the money has been cut for the new garage.

<u>YOUTH SERVICES, LARRY BESLOW</u> – Ms. JoAnne Pentangelo chaired the Youth meeting last month Youth Services Meeting. The Board Office has been having a problem with the e-mail and the minutes were not included in the packet. Well wishes were sent to Mr. Beslow who will be having surgery and will be out for about two months.

<u>PUBLIC SERVICES, LLOYD BACCHUS</u> – The minutes of the meeting are in the packet. There is a flyer in everyone's packet. The New York City Department of City Planning and the Economic Development Corporation are sponsoring a "West Shore Open House" which will be held on March 13, 2008 starting at 6:30 with a presentation at 7:00 P.M.

WATERFRONT, CURT WARD – The minutes of the meeting are in the packet.

BUDGET & FINANCE, TERRY PLAYER - No report.

**LAND USE, CHRISTOPHER ROONEY** – The minutes of the Land Use Committee are in the packet.

Mr. Bill Taitt, representing Councilman McMahon, said the Councilman has not taken a position on the development at the Stapleton Municipal Parking Lot.

"The plan must be very closely scrutinized, to ensure that there is adequate parking not only for the prospective residents but also for the public.

The Councilman is deeply concerned with the way the City conducts business in regard to the development of affordable housing projects under the Department of Housing Preservation and Development. Private developers are normally granted tax-breaks by the City in exchange for developing affordable housing units; however, these developers do not have an official contract with the City of New York and therefore not obligated to pay prevailing wage during construction. The Councilman believes this is a bad precedent that needs to be addressed, which is why he has requested legislation in the City Council that would require developers who receive any kind of city subsidy to pay prevailing wage to all workers."

The Stapleton SIRT Station needs to be analyzed by an engineer to any potential impacts on the operations of the railroad. More importantly, the Stapleton train station desperately needs an upgrade, and currently it is not a priority of the MTA for renovation. The Councilman has made several requests to the MTA for renovation of the Stapleton train station, and will continue to advocate for priority renovation.

The following motions were read and voted on:

#### **MOTION**

Community Board #1 approves the proposed dormitory for Wagner College on Campus Road on the Baseball diamond as presented.

Roll call vote taken. Vote passed 33-6-2.

## **MOTION**

Community Board #1 approves the proposed revisions for Stapleton Court at the Stapleton Municipal Parking Lot as presented.

Roll call vote taken. Vote passed 40-0-0 (1 ineligible).

Mr. Rooney asked the board members opinion on a Board of Standards & Appeals Land Use Application, which was voted on and approved for 130 Montgomery Avenue. The applicant had to submit plans for a 30-day authorization to City Planning because it is in the Special Hillside Preservation District. Mr. Rooney asked the members if they wanted to re-hear the application. It was decided that the application would be heard and voted on again.

**<u>HUMAN RESOURCES, LISA LATTANZIO</u>** – The minutes will be included in the packet next month.

## AREA COMMITTEE REPORTS

## ROSEBANK/FORT WADSWORTH/SHORE ACRES, JOHN GUZZO - The

Mr. Guzzo made a motion that any new flag poles/cellular antennas that are planned for the north shore must first notify Community Board #1.

Detective Tierney responded the success was due to 100% cooperation from the residents in the area, the sponsors of the parade, the local businesses and the patrons of the businesses.

The Manor Road Post Office will be hosting a meeting on March 19, 2008 at 5:00 P.M. to address what they have done and what they will be doing in the future to address the concerns of the residents on Raymond Avenue. If you are going to attend please contact the Board Office.

Mr. Wonica asked the area chairs to discuss at their next meeting holding an area clean up. It could be in a park, corners in the community that are need of being cleaned, wherever the community feels it is needed. Spring is around the corner; it would be nice if every area committee pitched in to beautify their neighborhood.

Jacob Massaquoi, III runs the African Refuge program in Park Hill. The program benefits the African Community. It was burglarized last month, eight laptop computers were stolen.
